Absentee Ballots

Senator KANY of Kennebec was granted unanimous consent to address the Senate on the Record.

Senator KANY: Mr. President and members of the Senate. Perhaps I had better give an explanation. This bill is actually going through all readings in both Houses today and we are asking you to finally enact it now as an emergency measure so that clerks whose names are listed on a ballot in uncontested elections can handle those ballots without committing a class D crime.

As you will recall, we extensively amended our absentee ballot laws last year by providing balloting and actual elections at nursing homes and removing candidates who are on a ballot or candidates for an election from the absentee balloting process. In so doing, those clerks who must run for election on a ballot were really prevented from handling ballots and since so many of the clerks throughout the state often run without opposition, it seemed appropriate for us to amend the law so that those clerks could then handle ballots and that is precisely what this does and in fact with the municipal elections coming up in many communities there are ballots literally waiting to be picked up and that is why we are passing this as an emergency measure. In those towns where there is a contested election for clerks a deputy must be appointed to handle the ballots.

This being an Emergency Measure and having received the affirmative vote of 24 Members of the Senate, with No Senators having voted in the negative, and 24 being two-thirds of the entire elected Membership of the Senate, was PASSED TO BE ENACTED and having been signed by the President Pro Tem, was presented by the Secretary to the Governor

for his approval.

Dennett, the Last Orator.

Senator ESTES of York was granted unanimous consent to address the Senate on the Record.

Senator ESTES: Ladies and Gentlemen of the Senate. I do not wish to take up much of your time. As were you, I was also saddened by the loss of Representative Dana Stevenson this week. I also wanted to make note of an historical loss to the Maine Legislature that took place on Tuesday and that was William Ellsworth Dennett, former Representative from Kittery and State Senator who served in the Legislature until 1970. Mr. Dennett had been praised upon his retirement as a giant in the Maine Legislature and there was an editorial in today's Portland Press Herald that I think captures the essence of Mr. Dennett. He is a man that I will long remember. He was an inspiration to me as a high school student and is a legend in his time, not only in the southern part of the state, but also throughout the state. I would like to read this into the record if you will bear with me. It is entitled

The death of William Ellsworth Dennett the other day attracted little attention around the state. No reason that it should. It has almost been two decades since Dennett retired after a distinguished career in the Maine Legislature. Yet his passing at age 80 marks the end of an era, for Dennett was the last great orator of the Maine House. There are no orators in the Maine Legislature today nor have their been for years. They speak but that is the best to be said of it. There are no men or women capable of rising to their feet and with the power of words alone, figuratively causing their colleagues to see with their ears — Dennett could. When he or his colleague, the late Sumner Pike of Lubec spoke, the House hushed and heads turned as members gave their attention to a master. Always delivered

extemporaneously, a Dennett speech had an unerring sense of rhythm, of cadence, of clarity, of humor. And so compelling were his words, so marvelously resilient and so eloquently reasonable that someone once remarked that if the gentlemen from Kittery ever proposed abolishing the Office of Governor, at least 30 fellow members would rise immediately to second the motion. Dennett was a self-taught man, though he had dropped out of school at age 15 to go to sea and seek his fortune. His search for knowledge became a life-long avocation. He could also summon up the appropriate quotation from the barred english and american history world and so catholic were his interests that he could discourse knowledgably on the history of the Passamaquoddy Indians, or the current balance in the State's Treasury. For all his gifts and talents he was, however, a courtly, honest and gentle man. He never harbored a grudge nor made a single enemy. He served his state with love and devotion and all Mainers whether they knew Bill Dennett or not, are all in his debt. Thank you.

Senator PERKINS of Hancock was granted unanimous consent to address the Senate on the Record.

Senator PERKINS: Mr. President and ladies and gentlemen of the Senate. I would ask today when we adjourn that we adjourn in memory of Dana Stevenson our friend, associate and colleague, our Uncle Sam. He died the way he lived, serving the people who elected him and his friends. Thank you.

The Joint Order having been returned from the House READ and PASSED in concurrence, on motion by Senator PERKINS of Hancock, ADJOURNED in memory of Representative Dana Stevenson until Tuesday, February 16, 1988, at 10:00 in the morning.
