JOINT RESOLUTION MEMORIALIZING THE UNITED STATES COAST GUARD AND THE UNITED STATES DEPARTMENT OF TRANSPORTATION TO CEASE AND DESIST ALL EFFORTS TO CLOSE TWO COAST GUARD STATIONS IN MAINE

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the Second Regular Session of the One Hundred and Thirteenth Legislature, now assembled, most respectfully present and petition the United States Coast Guard and the United States Department of Transportation to cease and desist all efforts to close 2 Coast Guard stations in Maine, as follows:

WHEREAS, the United States Coast Guard has summarily and publicly announced the intention of permanently closing 2 stations in Maine; and

WHEREAS, the Maine stations designated for closing are the search and rescue station at Eastport and the marine safety detachment at Bangor, involving a total cutback of 12 people and \$473,000; and

WHEREAS, these facilities are 2 of 6 along the New England coast scheduled to be shut down next month to cover a shortfall in the operating budget; and

WHEREAS, this decision comes at a time when Maine's 3,500 miles of coastline are already thinly protected from the increased intrusion of drug traffic; and

WHEREAS, the sea provides the State with a vast and priceless resource which has long been vital to our economy, and our commercial fishermen rely on the services of the United States Coast Guard as their only protection; now, therefore be it

RESOLVED: That We. your Memorialists, do hereby respectfully protest said closure and request the United States Department of Transportation and the

United States Coast Guard to cease and desist in their efforts to close these facilities; and be it further

RESOLVED: That the Members of the United States Congress for the State of Maine are hereby urgently requested to use every possible means to cause the decision to close these facilities to be reversed; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to Admiral Paul A. Yost, Jr., Commandant of the United States Coast Guard; James H. Burnley IV, Secretary of the United States Department of Transportation; and to each member of the Maine Congressional Delegation.

At this time, the Chair would like to express his appreciation to the Senator from York, Senator Dutremble, for the fine job he did Friday in his duties as Presiding Officer.

Senator MATTHEWS of Kennebec was granted unanimous consent to address the Senate on the Record.

Senator MATTHEWS: Thank you Mr. President, men and women of the Senate. I am not going to take a long time this morning, but I feel very, very strongly that something has to be said on the Record on this floor. We all know that over the weekend seven more workers, replacement workers, at the IP mill were exposed to chlorine gas. I don't know how many times this has happened at the International Paper Company mill in Jay, but it has been a number of times. It seems to me that the people that work in that mill, replacement workers and the people that live around that town, do deserve the kind of protection that this Legislature and our Governor can offer. I wonder how many people have to die before something is done in correcting what is going on at Jay. I am looking today at an article written by International Paper Company, an advertisement, which talks about the wonderful job that they are doing at International Paper Company in Jay and I won't read the whole gist of it, but it says, "Facts Not Fiction. A misinformation campaign has been rolling through Maine for several weeks. International Paper Company's Androscoggin mill believes that the people of Maine are entitled to the facts, not fiction." The Company says, "the facts are after making the tough decision to hire permanent replacements the mill has quickly been able to achieve normal production."

God save us if this is normal production at their Paper Company. People have been exposed to danger, chemicals, chlorine leaks, my God the Paper Company calls this normal production. I have two paper companies in my Senate District, both Scott Paper Company and never in my life have I heard of such outbreaks of chlorine leaks and poor management practices causing the communities to be jeopardized for their health and safety. My God, they ought to talk about the facts and put it out there to the public what the hell is going on, excuse me Mr. President. I think it is time enough and I would call upon the Governor to take strong action in Jay to preserve the health and safety of those replacement workers and the people who live in that area. Those workers that will someday get their jobs back. I think it is long overdue so I would make this message loud and clear. The good Senator from Oxford, Senator Erwin, has been telling us what has been going on in that mill for months now and it is time that the Legislature and the Governor took action. It is long overdue. God, let's not have some more people die.
