Senator WEBSTER: Thank you Mr. President, ladies and gentlemen of the Senate. Several days ago, the good Senator from Kennebec, Senator Matthews, brought to our attention his concerns regarding the recent chlorine leak in Jay, Maine. It is a concern that we all have and I want to bring to the attention of this Body today several things that have happened in the last few days. Yesterday, on page three of the Kennebec Journal, there was an article of concern to me and to many of us of a chlorine leak at Statler Paper in Augusta. I would like to read on the Record a quote by a DEP official. "If it hadn't been for the public exposure of the incident in Jay, Maine, they probably wouldn't have reported it." That ought to be of some concern to us. Yesterday, in Rumford at Boise Cascade, there was a chlorine leak and an evacuation of twenty people on the front page of the That ought to be of concern to us. I Lewiston Sun. would like to bring these matters to the attention of the Senate and to anyone who is listening that we are concerned about these incidences that are happening throughout Maine. I heard over the weekend of a chlorine leak in northern Maine, in that paper company and I would suggest that somebody in State Government, and I am not in any way implying the Governor because I believe we all realize he is doing all that can be done, but I would hope that particularly DEP would take notice that this is not the kind of thing that should be going on, jeopardizing the health of the people of Maine. Thank you.
