JOINT RESOLUTION REQUESTING IMMEDIATE ACTION TO RESTORE THE PUBLIC PEACE, HEALTH AND SAFETY OF MAINE CITIZENS IN FRANKLIN AND ANDROSCOGGIN COUNTIES

WHEREAS, widespread fear haunts the peaceful towns of Jay, Livermore Falls and Chisolm in the wake of a series of gas and chemical leaks at the International Paper Company's Androscoggin Mill; and

WHEREAS, tensions mount throughout the area over threats to health and safety and the frightened townspeople have been shaken by the presence of clouds of deadly gas, hospitalization and mass

evacuation; and

WHEREAS, this continuing and unnecessary threat to the public health and safety of citizens of this State behooves the reasonable person to cease all operations pending a full determination of policies and practices that will lead to the causes and prevention of such conditions; and

WHEREAS, emergency powers are vested by enabling certain officials in time of crisis to take actions to prevent violence or disaster for the preservation of the public peace, health and safety; and

WHEREAS, the selectmen of the Town of Jay voted unanimously to request that the Governor shut down the International Paper Company mill in Jay until such time as the mill can be thoroughly inspected and proven safe; now, therefore, be it

RESOLVED: That We, the members of the 113th Legislature now assembled in Second Regular Session, being mindful of events leading to the crisis which has angered and frightened the citizens of Androscoggin and Franklin Counties and the official position the Town of Jay has taken on closing the mill, respectfully urge and request the Governor of this State, the Honorable John R. McKernan, Jr., to exercise the emergency powers of his office

immediately suspend the operation International Paper Company's Androscoggin Mill pending a full investigation of policies and practices by which the mill is operated to determine the extent to which safety is observed, to which there is provision for emergency response and to which the public is protected; and be it further

RESOLVED: That the Governor mobilize appropriate members of his cabinet on environmental protection, labor, human services and public safety to restore public peace, health and safety, to determine if the law is being upheld in all respects and what, if any, changes in structures, procedures or operations should be made to better serve this industry and the public at large; and be it further

RESOLVED: That the Governor gives the appropriate federal, municipal and county officials and individuals with expertise in the various occupations and skills necessary in operating a papermaking facility an opportunity to participate in

these deliberations; and be it further

RESOLVED: That suitable copies of this
resolution, duly authenticated by the Secretary of State, be transmitted forthwith to Governor John R. McKernan, Jr., and appropriate cabinet members.

THE PRESIDENT: The Chair recognizes the Senator

from Kennebec, Senator Matthews.
Senator MATTHEWS: Thank you Mr. President, men and women of the Senate. I stand before you today as the sponsor of this Resolution. I sponsored this Resolution because I believe, as I think all of us in this Chamber do, that health and safety issues and the health and safety of the citizens of this state are the most important things that the Legislature can attempt to guarantee. I stand before you this morning moved by the concerns and the emotions of the people in Jay that have gone through the roughest six months probably of any citizens of any community across our state.

I want to just mention the kinds of concerns that have been mentioned before throughout our history and the statements, I guess, that echoed through my mind today are the words of Franklin D. Roosevelt: "That we have a right to be free from fear. The citizens have a right to be free from fear." The people of Jay have that same right. The children of Jay have that same right. I understand this morning that a motion to Table this Resolution will be made. concur with that motion. I have never and I will never stand against any attempt by the Governor or anyone to offer their services and attempt to redress situations like this. I thank the Governor for his interest. I would ask that the Governor's Commission attempt to seriously deal with this issue because it is a serious issue not a political issue, not a labor issue. It is a health and safety issue and in an effort to give the Governor due course and time, we will Table this Resolution today. Thank you Mr. President.
