Gentlemen:

The Maine High Risk Insurance Organization submits the attached budget for its first year of operation. We need legislative approval for our budget so that we may begin offering insurance to a maximum of 300 Maine citizens who are unable to get health insurance because of medical reasons. Following is a brief explanation of the major elements of the budget: Revenues

- Hospital Assessment is based on the amount allowed in the law. This has been discussed at the Hospital Advisory Committee of the Maine Health Care Finance Commission and the Board has decided to ask hospitals to make quarterly payments to help ease any cash flow burdens. The requires that the MHCFC recognizes the financial impact of this assessment in setting hospital revenue limits.
- Premium income represents the payments individuals will make for insurance coverage. This is based on our estimate of timing and the 150% maximum of standard rates allowed in the law.
- 3. General fund assessment is the amount included in the law for the subsidy for those who cannot afford to pay the full premium.

Expenses

Claims are estimated by the use of actuarial computations using data from other states. This is a highly volatile area and may

vary significantly due to the nature of a high insurance group. If experience significantly better than projected, we may be able to reduce future assessments to hospitals.

Staff support will be provided via contract with the Bureau of Insurance.
