As chairman, I am pleased to submit a copy of the findings of the Commission engaged by the 113th Legislature to study the resolve entitled "Resolve to Establish a Commission to Study the Feasibility of Constructing a 4-lane Highway from Interstate 95 to the St. John Valley".

The report, while indicating that a new controlled access highway facility cannot be justified at this time under traditional analysis processes, clearly states the importance of Routes 1 and 11 and indicates the strong need to continue and accelerate the upgrading of these corridors.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Collins.

Senator COLLINS: Thank you Mr. President. Mr. President, men and women of the Senate. I hope you will defeat the motion of Recede and Concur so that we, in fact, may Insist. We have discussed the Bill before us the other day and I think this Body overwhelmingly supported the basic premise of the retraining program and the funding mechanism. Today, as we look at this Bill, we find that there has been a change in the funding mechanism from the other Body where there is an Amendment that proposes that funding come from the General Fund and if you are serious about this Bill, as I think you are, you have to recognize that that type of funding will not occur. If we are to support this legislation we must do it by the method that is in the original Bill. which uses money through the Unemployment Fund. For those of you are concerned about that mechanism  ${\rm I}$  would like to suggest two things that may influence your decision. You all know that I am very zealous of that fund, I have lived through the days when it has gotten to such levels that employers had to increase their contributions and I have seen the time when we have borrowed Federal Funds in order to put that Fund in proper perspective. I am pleased first to report to you that the Fund is in the best condition that it has ever been in and secondly, I want you to remember that there is a built in circuit breaker that does eliminate all Star contributions when unemployment conditions are not favorable. Keep in mind that Star contributions are separate from the Unemployment Compensation Program and not one single penny would come out of the trust funds reserves. So, I hope you will join me in defeating the pending motion and then vote to Insist, which is our previous position. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Sewall.

Senator SEWALL: Thank you Mr. President. Mr. President, men and women of the Senate. It is a very strange occasion when I rise to oppose the good Senator from Aroostook on a motion dealing with a labor issue, but I must oppose him and the Governor on this point. I served a good deal of time of the Labor Committee, not the most enjoyable time of my life, but I did learn a few things. One of them is the Unemployment Compensation Fund which was set up for one singular purpose and none other. It was set up to give some income to those people who are unemployed, it was not set up for another purpose. The only contributors to this Fund are employers. The employers before, when they started adding more expensive propositions to the Fund, had to pay a penalty. They said that the time, don't worry, we will put these benefits in, everything is fine and if we get into trouble we will borrow the money from the Federal Government and as they have done with so many other states, they will never make us pay it back. Surprise, surprise, there has been a surtax to employers in the State of Maine for years and years and years to pay back that loan from the Federal Government which we supposedly where never going to pay back. If you look back in the law and you see where there was a series of amendments put in by a fellow name Bernard Estes, who I believe was a Senator at the time, to clear up that Fund and to finally make it viable. It is viable, our economy is better than it has been in years and as much as I would like to see the economy stay that way, I am sure there will be changes in it. If we are going to start using money that was set aside and is taken from employers for one specific purpose and distributed into any other purpose, I feel that is wrong and I feel that is detrimental to the Fund. Т also think that it sets a precedent which is worse than this Bill which may be a small movement in that direction and maybe eventually they will want to say, well in order to get this you must take training or maybe they will say eventually that employees should pay in something. Maybe employees should pay one percent into the Fund. Maybe they will try to make it better that way, but right now they don't and who is really going to pay for this? Remember in Maine that small business is the backbone of business here and those small employers, who pay into this Fund and generally they are people who have small stores, mom and pop outfits, gasoline stations and the like,

those people are going to be paying in this retraining program which chances are they are not going to retrain anyone to be a clerk in their store or to pump gas and that sort of thing. I think it is detrimental, I think that the idea of retraining is a good one, I have supported a lot of legislation in that direction, but I think that we now have an option before us of funding a social program, along with other social programs in this state and I think if we Recede and Concur, we will be doing a better thing, not something that opens the door wide for social programs to be financed by the Unemployment Fund.

#### Off Record Remarks

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President. Mr. President, men and women of the Senate. I heard referred in debate this morning from the good Senator from Aroostook about those tough times when businesses throughout the state had to pay in on a surcharge to the Unemployment Insurance Fund, because this state has unemployment laws that caused it to be in deficit to the Federal Government. The small businesses had to pay a surcharge so that the state of Maine would not be in the red. That was paid over years, it was paid in good times as well as bad times, by all the businesses in the state.

Now we have record low unemployment, we have businesses that are paying far above the minimum wage offering health benefits to attract employees and some summer establishments are willing to put up the people in room and board plus a set fee each week, which is totally unheard of. Now we come up with a program that is going to tax the surplus from the Unemployment Fund, which we fought when other entities wanted to tap that Unemployment Fund in different parts of the state because of certain labor unrest. Now we are going to tap that for unemployed people that are chronic unemployed people to help train them. They are going to get employment theoretically, but none of the money that is gained through that reemployment is going back into the State's General Fund. There is no obligation for any of that reemployment theoretically to be paid back to the state either to the Unemployment Fund or back to the State General Fund. There is no commitment on the other side of the equation. I strongly oppose the use of those businesses that paid in to get the state out of red ink, now when we have record low employment in the Insurance Fund, instead of giving that back to those employers, we are now setting up a program that says that once the money runs out, then we will disband the program. All of us here must know by now that that never happens here any ways. That program will have a life of all of its own. I think the important thing here is to start it off on the right foot. If it deserves attention, it will get the attention of the General Fund Appropriation Table. If it deserves to come out of the Unemployment Fund, then there ought to be some commitment on those people theoretically when they get hired again, to recommit some funds back to it. don't think it is fair to always tap those employers who have paid in. So, I will be supporting the motion to Recede and Concur and I hope that you folks would also. Thank you. THE PRESIDENT: The Chair recognizes the Senator

from York, Senator Dutremble.

Senator DUTREMBLE: Thank you Mr. President. Mr. President, men and women of the Senate. I would just like to correct a few comments that were made to make sure that everyone is clear about exactly where the money comes from. The money does not come from any existing funds in the Unemployment Trust Fund, nor will it increase an employers rate or will employers have to pay more because of this program. The money is coming from the fact that the schedule was about to go down by .1 point I believe and the money that was going to go down instead of returning it to the employers is going to be used to fund the program. So, when the Governor proposed this idea the question was do you like the idea that they are taking this money or would you rather see it in the General Fund. I guess I looked at it as far as what kind of program it was and saw it was a program that maybe I would generally support and then where would the funding come from. I also realized that going to the General Fund right now would probably mean that the Bill would not pass and the Bill would die. So, the Governor did propose this and it is someway a tax, a minor tax. but I guess it is something I can support because of the program. I hope that you would go with the motion to Insist and reject the current motion to Recede and Concur.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Collins.

Senator COLLINS: Thank you Mr. President. Mr President, men and women of the Senate. I think the distinguished Chairman of the Labor Committee has made the point rather well that we are not tapping a fund. I guess that we repeated this message several times, but I think it is important because the arguments from the other side seems to suggest that we are doing this and we are not. Second, I would like to call to your attention that this Bill is supported by business. It is a business tax and business people support it. Star program is supported by the Maine Merchants Association, the Maine Chamber of Commerce and Industry, the Maine Grocers Association, the fifteen County Private Industry Council, the Cumberland County Private Industry Council and many others. I would like to suggest to you that at least eighty percent of those people who participate in the Star program, will be placed in small business in Maine. As a small businessman in Maine, I am very pleased that we are taking this type of action. whereby we can train people for the jobs that are available in the places where we need them badly. It seems to me that business people are going to benefit from this legislation as are the people who are taking off the roles of unemployment as they learn new skills and enter into a new job market. I hope that you will defeat the pending motion and then endorse the motion to Insist.

to Insist. Thank you. THE PRESIDENT: The Chair recognizes the Senator from Penobscot. Senator Baldacci.

Senator BALDACCI: Thank you Mr. President. Mr. President, men and women of the Senate. The good Senator from Aroostook, Senator Collins, has talked about what is good for small business people and that this act is going to help them in finding employment. And that this is something that they should be paying for because they are the ones that need these people who are well trained. The fact of the matter is that eighty-five percent of the businesses in the State of Maine are small businesses and the fact of the matter is that those small businesses are not contributing to the unemployment problems of the State of Maine, but are contributing to the employment of the State of Maine by and large. They take people that are not trained and train them in small businesses where you have few employees, where you take somebody that is willing to start at a lower rate, show them the way of doing things and having them learn and going from a small operation to a large operation. That is the training that goes on in small businesses. Some program with classrooms isn't going to be a program that is going to help the small businesses. The program that is going to help the small businesses is a program that you already have on the books. It helps pay a salary of a person that is receiving state aid. So you have state contributing along with the business the contributing to pay somebody to work with the small business. That is an existing program. You have the Women Education and Training Program that takes women that are drop outs of high school to get back into the education framework, pays their tuition and transportation and helps out with those programs and makes them available for the work force.

I don't sit on the Labor Committee, but when I go around my district and talk to people that are effected and work with these programs, they are out there, why start a new program when you already have an existing program? Just because you take something existing and call it Star, it has a bright flashly thing to it and it is going to make everybody feel good? You know I think it is a big waste of money and it could be well served going back to those businesses.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Collins.

Senator COLLINS: Thank you Mr. President. President, men and women of the Senate. I am rather suspect that the name of this ought to be Star Wars as opposed to Star. I think that we ought to recognize that this program is not going to create a new bureaucracy. One of the strengths of the programs is that it is going to be built on existing systems, including our Vocational Technical Institutes. It is going to include job training, it is going to utilize adult education. It is not going to offer just one thing, it is not going to be entirely focused on classrooms. It is going to offer a multitude of existing programs that can be utilized in this. So, we ought not to fear that we are going to have a new bureaucracy. Second, I would like to remind you once more that the program self destructs in two years time. Third, I would like to remind you that this is not a program when times are bad. It is a program for when times are good and when times are bad and there are additional calls on unemployment funds, this program goes out of business. So, you don't have to fear that.

Senator COLLINS of Aroostook requested a Roll Call.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Sewall.

Senator SEWALL: Thank you Mr. President. Mr. President, men and women of the Senate. I just wanted to respond to a few remarks that have been made, one from my colleague Senator Collins, when he said that business supported this Bill and it is true in a split vote the Chamber of Commerce board finally did decide to go along with this and I presume the Maine Merchants did too. But, let's talk about who represents most of small business in Maine and that is the National Federation of Independent Businesses and when they were asked the question, "Should a scheduled unemployment reduction be reallocated to the training and education program for unemployed workers?" The results were eleven percent yes, eighty-three percent no and six percent undecided. That looks like a pretty clear decision from small business to me. Then just let me mention from

AFL-CIO memorandum which was a statement given in Washington on Monday, December fourteenth, where the AFL-CIO said, "in both cases we are opposed to the use of Unemployment Trust Funds to carry out demonstration projects beyond the purposes that are specified. It is our firm conviction that the nations unemployment insurance system should provide temporary income support to jobless workers. Other programs targeted at displaced or dislocated workers are needed but they should be funded separately. We are opposed to the diversion of trust fund money."

So, I am not alone in this and I hope you will consider what you are doing and what a precedent you may be setting today in using these funds. THE PRESIDENT: The Chair recognizes the Senator

from York, Senator Kerry.

Senator KERRY: Thank you Mr. President. Mr. President, men and women of the Senate. I think what we are really doing today is sending a message to the people of Maine and to the working people as well as small businesses that we are attempting to address a fundamental and systemic problem with people who are chronically unemployed. In the past, many members of my party have supported job training programs, educational programs to put people back to work, and vocational education programs that would provide new opportunities for people to address fundamental long-term concerns with employment. I think this particular program, although it has a good intent and many of us support in concept, may be sending a wrong message not only to the small businesses of Maine, but to the working people of Maine. Probably more importantly, to those who are having a difficult time finding jobs and employment. There may be many of us here who find that the funding mechanism for this program is central to the debate. If we really want to address the problem we must address the problem with sufficient resources to address is over time. It is my understanding from those who have been working on this Bill that this is the first time that they have sought to receive funding for this mechanism through the Unemployment Trust Fund. I, like many of you here in this Body, was either serving in the Senate or the House and we do recall the times when that Fund was in dire straits. But, I don't think that the selection of the Unemployment Trust Fund windfall is the key question either. I think the key question is what is the perception and what is the reality. The reality is for a person that we are trying to address in terms of providing them with better employment opportunities and on-the-job training in a small business in the state of Maine, they will think that they now have a great deal of hope that will last more than twenty-four months. That in fact it will hopefully last for twenty-four to thirty years that they will be able to work and gain skills that are necessary to go forward to feed their families, to develop skills, etc. I honestly believe looking at the Bill as it stands now and looking at the funding mechanism that we are really not addressing the fundamental chronic problem that a person in this situation has. I also believe that the message that we are sending out to the small business community is that we are trying to fund a program in an expeditious fashion. It may seem politically astute for those of us in Augusta, saying that we are going to try to address this problem in a superficial fashion and it may play well out there in the community. The reality is those businesses who are small businesses in Maine, for many of them there never is great times. They are usually struggling to make it every day of their lives. They are usually struggling to meet a payroll, they are usually struggling to pay their taxes, they are usually

struggling to maintain the viability of their businesses. And as many Senators, especially the good Senator from Penobscot, Senator Baldacci, mentioned that the small businesses are in fact the backbone of the Maine economy. My point of view here today is if we are going to be honest in addressing this issue, and I find that the arguments are persuasive, that if we really want to address this issue we must fund it through a proper mechanism and the proper mechanism is the General Fund.

I do in fact believe the concept is good, I think the program itself is questionable, I think the funding mechanism is inappropriate and it is very seldom that I agree with the good Senator from Lincoln, Senator Sewall, but in this particular occasion I do and I would support the Motion to Recede and Concur.

On motion by Senator COLLINS of Aroostook. supported by a Division of at least one-fifth of the Members present and voting, a Roll Call was ordered.

THE PRESIDENT: The pending question before the Senate is the motion of Senator SEWALL of Lincoln to RECEDE and CONCUR.

A vote of Yes will be in favor of the motion to RECEDE and CONCUR.

A vote of No will be opposed.

Is the Senate ready for the question?
