THE PRESIDENT: The Chair recognizes the Senator from Waldo. Senator Gould.

Senator GOULD: Thank you Mr. President. President, men and women of the Senate. I hope that we will defeat the motion to Recede and Concur. committee we decided that legislators should not be included as employees of the state and

if they were to be included, in my opinion, it should be included under the benefit package or the bill that includes the salary increases and not as a side benefit. Thank you Mr. President.

Senator GOULĎ of Waldo requested a Division.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President. President, men and women of the Senate. The reason that it should not be included under that is the fact that the health insurance and other coverages that normally attributed to state employees, legislators are also covered for that. The fact of the matter is that we should not be discouraging anybody from running for the Legislature that may have children, but because of having to take care of children they would be unable to serve. I think it would be kind of discriminatory against those people not to at least have the ability and to ban that type of coverage for them. I would hope that we would go along with the pending motion.

On motion by Senator GOULD of Waldo, supported by a Division of at least one-fifth of the Members present and voting, a Roll Call was ordered. THE PRESIDENT: The Chair recognizes the Senator

from Penobscot, Senator Webster.

Senator WEBSTER: Thank you Mr. President. Mr. President, men and women of the Senate. I would like to pose a question through the Chair to a member of the committee. I would like to know whether a public hearing was held on this issue, specifically on the issue of giving legislators the right to have day care services provided. It seems to me that there would not be tremendous public support for that position. I would like to know when this issue was discussed, if the context of the issue dealt with state employees or the context of the issue dealt with allowing benefits for members of the Legislature dealing with day care.

THĔ PRESIDENT: The Senator from Franklin, Senator Webster, has posed a question through the Chair to any Senator who may care to respond.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President, members of the Senate. It is pretty popular to bash legislators or the Legislature and it seems that may play well back home to some people and some constituencies. The fact of the matter is that the bill dealt with state employees and having a day care facility for state employees. Members of Legislature are state employees, their health benefit package that is for state employees is also for Members of the Legislature and the fact of the matter is that it is not a legislators day care center bill, it is a state employees day care center bill. The committee in its first report rather than try to jeopardize that, it passed it without that. It is a simple bill of a state employee having day care

facilities and not excluding any state employee just because they happen to sit in the Legislature and frankly I think it is kind of discriminatory because of people who do have children who may want to serve in the Legislature and not being able to do that. I don't think in the State of Maine as far as we have progressed, as far as our membership in the Senate and the Legislature as a whole, that we want to go backwards. I think that we would be going backwards if we eliminated that provision from the bill. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you Mr. President. President, men and women of the Senate. I can't believe what I am hearing here today. It seems as though the Legislature, the Senate and others are becoming a welfare program. We have all the benefits that seem to be coming out. We have a dental program, we have a retirement program, we have a health program, we have a major medical program and now we are going to have day care program. I don't believe my constituents would be very much in favor of the Legislature having a day care program.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Thank you Mr. President. President, men and women of the Senate. I don't see any difference between a legislator having day care slots available to them, than a state employee having slots available to them. We have state retirement, state employees have state retirement. That is not a welfare program. We have state dental because it is the same as state employees having a dental program. We have medical insurance through the state just as state employees do. That is not a welfare program. To characterize those things as a welfare program, I think, is an extreme form of exaggeration. It is the same thing that everybody else has. We are not asking for any more. We are not asking for any less. Legislators aren't any more and they certainly aren't any less. If the amount of reimbursement for miles that you drive on the road as a state employee goes up, ours goes up. It doesn't go up any more, it doesn't go up any less and it shouldn't. Obviously, I have no children and as a matter of fact, I know of nobody in the Senate who is interested in availing themselves of the senate who is th is not the point. The point is what is fair is fair. It is not a welfare program.

THE PRESIDENT: The Chair recognizes the Senator

from Franklin, Senator Webster.
Senator WEBSTER: Thank you Mr. President. President, men and women of the Senate. I believe the good Senator from Kennebec, Senator Matthews, and I are the only members of this Senate who have children young enough to be in day care. I am one of the few who have a five year old and I know as well as anybody else does how difficult it is to find day care. Last night we had the opportunity to honor one of our colleagues, the good Senator from Lincoln, Senator Sewall, at a reception and unfortunately my wife was unable to attend because we were not able to find someone to watch our child. So I know all about the problems associated with that. This is interesting issue because this is the kind of issue that upsets the people of Maine, particularly the constituents that we represent. It is my opinion that it is a back door approach to passing a law. There was no public hearing held. If we had a bill before the Legislature, an act to allow day care for state legislators, it wouldn't have even gotten out of committee. I don't think there is any support

among the constituents in our districts to give legislators an additional benefit in this area. I would like to pose a question to members of the If we are to continue to keep this provision in this bill before us, how many state employees are going to be displaced? I would also like to know whether legislators are going to have preferential treatment. Anyone who says that we aren't, I am going to have a hard time believing that knowing the political process and how it works. we are going to allow legislators and I guess when I ran for the legislature I knew what the advantages and disadvantages were of becoming a legislator and I guess I would know whether I was willing to make the sacrifices that were needed. I would like to know how many state employees are going to be displaced if we have legislators who obviously are going to get preferential treatment. Most of us are not living and dying on what we make here in the Maine Legislature. It seems to me that most of the people who are state employees, what I consider state employees, are actually here to make a living. would hope that none of these people would have their children displaced so that some legislator who decided to use the system was taking up space that could be occupied by truly state employees.

THE PRESIDENT: The Chair recognizes the Senator

from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President. Mr. President, men and women of the Senate. There is so much area to cover with this Bill that I will try to hegin very quickly. First of all there was a public hearing on the legislation. I would appreciate it if members of this Body that criticize legislative committees would at least check the facts to make sure first. There was a public hearing on this legislation. The second point is that it refers to a socialistic state. I am amazed from the good Senator from Cumberland, Senator Dillenback, who quickly forgets this aspire program that is supposed to cover day care costs and health insurance costs and where the proposal is coming from. I am also surprised in a tight labor market that we talk about child care and having businesses get together in providing it and getting tax exemption or tax breaks from the government to provide those services because we need those people in the workplace. This is not something that is going to create a socialistic state. It is something that is going to meet a present demand that we have in the marketplace. Not defending Senator Kerry from York, or Senator Randall who is from Washington, but I assume they have children who would also be available for child care services, not just the good Senator from Franklin, Senator Webster, or the Senator from Kennebec, Senator Matthews. I would hope that we would be realistic in giving state employees, all state employees a day care facility availability. That is all it is.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Dillenback.

Senator DILLENBACK: Thank you Mr. President. Mr. President, men and women of the Senate. I didn't mention socialism, but I see that you are getting very close to the point. I will say this. I am all in favor of helping the state employees. I am in favor of helping everybody that needs day care. is one of the most essential things we need in this state for the working people. But I draw a line when it comes to the legislators. Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Kennebec, Senator Matthews.

Senator MATTHEWS: Thank you Mr. President. President, men and women of the Senate. Since my name has come up as one of the two that has been

using day care for my two children, I feel compelled to get up and especially after the statements by the good Senator from Franklin, Senator Webster, and the Senator from Cumberland, Senator Dillenback. This Legislature is called a citizen legislature and as I look up in the balcony at some young children watching the Maine Senate in action, I apologize to those young children for the statements that have been made on this floor. Because this is a citizen legislature and day care has been an issue articulated by the Governor, John R. McKernan, as a major issue for the people of Maine, a major issue not a partisan one. But I hear as the good Senator from Hancock, Senator Perkins, said the rights of spring. Sounds like the rights of spring part two today on the floor of the Senate and a snow job and a snow storm of massive proportion is being waged on the floor. I will vote for this Bill today and stand proudly. My two children go to a day care center and they will probably go to that same day care with or without this Bill. But ladies and gentlemen this is a citizen Legislature and no one should be denied the right to run for the Maine Senate or the Maine House of Representatives. I am appalled by the statements that have been made on this floor — absolutely appalled. I don't think they serve to better the debate at all. Pure partisan rhetoric.

THE PRESIDENT: The Chair recognizes the Senator

from Franklin, Senator Webster.
Senator WEBSTER: Thank you Mr. President. President, men and women of the Senate. First of all I would like to indicate my sincere apologies to the good Senator from Washington, Senator Randall, and the other members of this Body who could partake of this benefit. I find this an interesting issue. The Good Senator from Penobscot, Senator Baldacci, has indicated that there was a public hearing. Let me read you what the bill says, "An Act to Establish On Site Day Care at the Capitol Complex." I am sure the public is not aware of this back door attempt to help legislators. Over the years I have seen bills before the Legislature to allow free use of state parks to members of the Legislature, to allow free use of the turnpike to state legislators and to see other issues debated before the Maine House and the Maine Senate to benefit legislators. On every occasion I might add those bills were defeated. There was no public hearing held specifically on the issue of giving legislators benefits. If the Legislature needs this kind of benefit, it ought to be reviewed by the Compensation Commission and it ought to be debated on its merit and not attached to another bill as we are doing here today. I feel that this is not a partisan issue.

It is a common sense issue. I applaud the good Senator from Kennebec, Senator Matthews, apologizing for me and for apologizing to the Senate and I hope he continues to do so in the weeks ahead.

THE PRESIDENT: The Chair recognizes the Senator

from Kennebec, Senator Bustin.

Senator BUSTIN: Thank you Mr. President. Mr. President, men and women of the Senate. I wasn't going to get up and speak on this Bill because I was amused by the fact that we had only had the male section of the Senate speaking on the Bill and I thought that was very, very good indeed. Then I began opening my mail and I had a packet from a Barbara Collier who is with the Department of Human Services in child care and this whole packet is on child care. It is very interesting, because I have been an advocate for child care throughout my tenure in this Legislature. I would like to read to you a couple of little epistles that she sent me and they are just an outline of what is being done. "One Hundred and Thirteenth Legislative Child Care Initiative enacted in June of 1987." What the legislation will provide "two hundred and fifty thousand dollars per year for 1987-1988 and 1988-1989, to develop such regional child care resource development centers that will determine regional child care needs, recruit and maintain providers and make referrals, work with public and private employers on the development of more child facilities, encourage cooperation municipalities, schools, community organizations, health services and employers." I can go on and on, but there is a whole list here and I am sure we can copy it and send it to you. Then she sent me another list which is a gubernatorial program on child care initiatives "expanded resources for child care. Item number one. New child care slots - one hundred and seventy nine additional contracted state subsidized slots, six hundred and fifty-one thousand dollars. Three hundred and ninety-four child care voucher slots for state subsidized care, one million, forty-one thousand five hundred and five dollars. Improving existing child care system. Additional training for all child care providers, seventy five thousand dollars. Ten percent salary increases for contracted providers, five hundred thousand dollars. New child care program development" and carefully, "additional staff for resource development centers located in job opportunity zones, thirty thousand dollars. On site child care for state employees in Bangor and Augusta, two hundred and seventy eight thousand dollars."

I think that is is well intended, it is a good direction for us to go in this state. Obviously, the Legislature previously and the Legislature now wants to provide that care. All we are talking about incredibly so is whether you afford child care facilities to legislators who we know get some of the lowest pay for the number of hours that we put in of If I tried to figure my hourly wage it would not come to minimum of what I devote to the State of Maine through my legislative duties. It would not come to minimum wage. Yet you are saying to me that I can't avail myself if I were younger of a child care slot for my child. That is incredible. The other incredible thing to me is that the catchment area, if you will excuse the word, for the legislators who would avail themselves of the opportunity to use one of those child care slots is

very minimal, very minimal indeed. I suspect that of the legislators sitting in this Body and the other Body, there would be very, very few who could avail themselves of those slots because they live in other areas. They have their child care in other areas. They don't have it here in the State House Complex. The incredible thing is that we are The incredible thing is that we are taking this much legislative time to discuss an issue that doesn't make any sense to discuss because legislators should be included in the bill. I was happy to exclude them because I voted that way in the Senate, but the other Body obviously feels differently. I think we ought to go along with them. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Estes.

Senator ESTES: Thank you Mr. President. Mr. President. men and women of the Senate. I would just like to comment to ladies and gentlemen of the Senate this morning to perhaps clear up some irrational presumptions as to this Bill. In looking at the original bill and the committee amendment, the bill establishes a program in Augusta that would serve perhaps as a model program. There are eligibility requirements. They are talking about a program that will initially enroll sixty children and would be open during normal work hours from 6:45 until 5:30 p.m. There would be eligibility requirements that individuals would have to meet as state employees who would qualify under this program. There would be a sliding scale of fees for the program based on gross family income. It is not a state hand out, they are expecting to raise fees and to cover costs and they are to be reporting out any deficits. This is to be analyzed on a yearly basis. There is also going to be a preference system for lower income employees. As you look through the committee amendment to the bill, there is also a feasibility study that takes a look into the potential of other child care into the potential of other child care facilities and programs not only in Augusta, but for state employees in other portions of the state. I think it is a very clear-cut and very well-designed program to get child care off the ground even more than it has to date. The only reference legislators as state employees was the amendment that we passed exempting them. The presumption in the is that any state employee who meets eligibility requirements would be allowed to participate in such a program. I hope that answers some of the confusion that has been going on this morning. Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Penobscot, Senator Baldacci.

Senator BALDACCI: Thank you Mr. President. Mr. President, men and women of the Senate. Just a point of clarification. The bill also would allow not legislators, but also the Governor if he has children that would like to be included in child care, the Attorney General, the Secretary of State, the State Treasurer. It is not just legislators, it is all state employees.

Joint Resolution

The Following Joint Resolution: JOINT RESOLUTION MEMORIALIZING CONGRESS TO RELEASE FEDERAL HIGHWAY TRUST FUNDS

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the Second Regular Session of the One Hundred and Thirteenth Legislature, now assembled, most respectfully present and petition the members of the 101st Congress of the United States, as follows:

WHEREAS, the Federal Government imposes a tax of 9 cents per gallon on motor fuel which is deposited in the Federal Highway Trust Fund; and

WHEREAS, that trust fund by law may only be used for specified purposes, primarily the construction and maintenance of federal-aid highways and urban mass transit; and

WHEREAS, the states, including Maine, rely upon funds from that trust fund to pay a fair share of the cost of maintenance and necessary improvements to federal-aid highways, highways that are an essential part of the infrastructure on which the people and businesses of the State depend; and

WHEREAS, the Federal-Aid Highway Act covering fiscal years 1988-1992 cut back authorizations from that fund, and Maine's share dropped significantly \$142,000,000 for fiscal year \$119,000,000 for fiscal year 1988; and

WHEREAS, Maine had planned a highway budget of \$167,000,000 for state fiscal year 1988-89, including the \$119,000,000 of federal funds, matched by State

and local funds; and

WHEREAS, later federal action in the Continuing Appropriation Act of 1988 held back \$10,000,000 even from this reduced funding for fiscal year 1988, and the President's budget proposal suggests that even more than \$10,000,000 will be held back the next year as part of the federal budget balancing package; and WHEREAS, the failure of the Federal Government to

release the full amount from the Federal Highway Trust Fund will unfairly require the State to make up for the shortfall, despite the fact that the Federal Highway Trust Fund is entirely paid for by user fees, not general tax revenues, thus requiring the people of Maine to pay twice for the same purpose; now, therefore, be it

RESOLVED: That your We, Memorialists, respectfully urge and request that the 101st United States Congress release the funds which have been held back from the Federal Highway Trust Fund and distribute it to the states, including Maine's share of approximately \$20,000,000 for fiscal years 1988 and 1989; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable Ronald Reagan, President of the United States, the President of the Senate and Speaker of the House of the Congress of the United States and to each member of the Senate and House of Representatives in the Congress of the United States from this State.
