State of Maine PROCLAMATION

WHEREAS, there exists in the State of Maine an extraordinary occasion arising out of a record-high excess of revenues over projections at the end of the just concluded fiscal year; and WHEREAS, these additional revenues have resulted,

WHEREAS, these additional revenues have resulted, in large measure, from higher than anticipated yields from Maine's personal and corporate income taxes; and

WHEREAS, it is deemed to be in the State's best interest and to be the fair and proper thing to do for the Legislature to authorize the return of these revenues to the taxpayers in an equitable, efficient and expeditious manner;

and expeditious manner; NOW, THEREFORE, I, JOHN R. MCKERNAN, JR., Governor of the State of Maine, by virtue of constitutional power vested in me as Governor, do hereby convene the Legislature of this State, hereby requesting the Senators and Representatives to assemble in their respective chambers at the Capitol in Augusta on Thursday, the fifteenth (15th) day of September, 1988 at ten (10) o'clock in the morning in order to receive communications, enact legislation to return excess revenues, appropriate additional funds to address critical and urgent needs within the State's mental health delivery system and to appropriate additional monies to continue present anti-drug activities, which are currently threatened by cut backs in Federal monies and conduct such other legislative business as may be appropriate. During the first quarter of 1988 the Commission received an estimated 2,444 petitions and disposed of 2,125 by decision or dismissal. Commissioners Cote, Cox, and Pelletier assumed their posts during the first quarter of 1988. We anticipate Commissioner Bruce Livingston will be sworn in during June. With the new Commissioners on board, we are hopeful that the time it takes to litigate a disputed case can be significantly reduced. We plan to focus this year on delays in appeal decisions. Due to the volume of litigation and informal conferences, appellate decisions have been taking longer and a backlog has developed. The Appellate Division will be bearing down more aggressively on Commissioners. There have been no complaints or filings in connection with the 30 day decision rule of M.R.S.A. in §99-B as implemented by Commission Rule 22.11. Dear President Pray: This letter and statistical attachments are the quarterly report of Commissioner caseload and progress mandated by 39 M.R.S.A. §92(3). During the second quarter of 1988 the Commission received an estimated 2,646 petitions and disposed of 2.915 by decision or dismissal. Commissioner Bruce Livingston was sworn in July 1, 1988. Commissioner Nicholas Scaccia has resigned effective September 2, 1988. We understand attorney Dawn Lieb has been nominated to the Commission and, if confirmed, will be able to start hearings as early as October.

Economic growth in Southern Maine seems to be increasing the Commission's caseload for that region without a corresponding reduction elsewhere in the state. Accordingly, we urgently need to apply more resources to our Augusta and Portland regional offices to accommodate the shift in caseload. There have been no complaints or filings in connection with the 30 day decision rule of M.R.S.A. §99-B as implemented by Commission Rule 22.11. A summary of caseload and dispositions is presented in the attached tables. I would be happy to discuss this report further if you wish.

Senator KANY: Thank you Mr. President. Mr. President, men and women of the Senate. I have some questions about this nomination. I am completely open on voting on the nomination, but I just read a press report, of course we all know that you don't necessarily get the complete picture by reading the press report. Therefore, I would like to ask the members of the Public Utilities Committee who are

present more about this particular nominee and his

views and his open mindedness. I was concerned when I read about his perhaps market ideology as opposed to philosophy and although we in Maine particularly have seen the market really run what might occur in energy development especially. In fact we have more of a market economy in energy and electricity than probably any other state in this country, since we have had quite a few of our natural resources available for use in developing electricity. Also, the Public Utility Regulatory Policy Act has encouraged kind of a market economy.

Sometimes market economy may not work to the best interests of the state of Maine in the long run and I guess that I can't help to think in terms of what has happened to the railroad. If indeed it is the market that has really run what has happened in the railroad industry in the state of Maine, then obviously it is not serving us properly. We need rails. We need to transport our hazardous rails materials particularly instead of having them constantly going in smaller trucks on the roads along all of our residents in automobiles. I am very concerned if this person is an ideologue and I hope not. Interested in purely a market economy as opposed to assuring the citizens of this state that in the long run they will have an appropriate energy future. Ŧ would just ask some members of the Committee to speak to this particular point.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Kerry.

Senator KERRY: Thank you Mr. President. Mr. President, men and women of the Senate. In response to the good Senator from Kennebec, Senator Kany, I will address that specific issue. Mr. Gordon presented himself to the Committee, he did a fine job. He was very forthright and direct about his free market emphasis. He is in fact a Milton Freidman apologist in a friendly sense of the word and I think the key is that he said he is not married to any particular philosophy, that he was not an ideologue as a matter of economy philosophy. I think that Mr. Gordon is so to speak a professorial type, he spent most of his career in the academic environment. He has been at the Communications area in terms of the Federal Government and has spent most of his time. I would say, in the telecommunications field rather than in energy. He was also very forthright in saying that he had to do a considerable amount of work in the energy field and that he in fact would be very sensitive and very open to the least cost mode of developing an energy policy and a regulatory framework for the state of Maine. I think that all of us had some concerns regarding the unbridled free market approach to the utility industry here in the state. Unfortunately, in this case Mr. Gordon had not published as extensively as the previous nominee had and there might not have been as much information available to us to be able to ascertain exactly what his views were on specific issues. I think he acquitted himself well before the Committee, he seemed open. I think that it was the opinion of most of the members of the Committee that he was not an ideologue and that based on a couple hours of questioning and querying, but it is my opinion that he will be open, that he will not be fossilized into a specific position and that the current two other members on the P.U.C. would be a balancing force with regards to his perspective. I also think that he himself manifested an openness to listen to what was the best policy for the state and that he himself would not be an ideologue. I hope that answers your questions.

THE PRESIDENT: The Joint Standing Committee on UTILITIES has recommended the nomination of Kenneth
