Off Record Remarks

Senator BRANNIGAN of Cumberland was granted unanimous consent to address the Senate on the Record. Senator BRANNIGAN: Thank you Mr. President. President, men and women of the Senate. Regarding Supplement #1, I have had questions as to why the Governor has withdrawn the name of Brian Tarbox for appointment to the Marine Resources Advisory Council. In case anyone were to feel that it was anything unacceptable about Mr. Tarbox, I would like to lay that to rest. That is not the reason that the Governor has withdrawn the nomination. The Joint Standing Committee on Marine Resources would have been delighted and will be delighted to reappoint this fine young man to the Council. The problem is that there was no place for him. The Governor appointed two people when there was only one vacancy and fortunately the House Chair, Representative Mitchell, remembered that this Legislature and that Committee last year made the decision that when the next vacancy would be filled by the President of the Maine Lobsters Association. That vacancy happened in November, immediately upon two vacancies appearing, one of them was immediately filled, by law, by the head of the Lobsterman's Association. So, we had to choose between the two appointee's. We chose the one who had the longest term of service. We have proposed an interim law which will allow Mr. Tarbox's name to be reappointed and I believe that will be done. It is necessary that he be reappointed because he represents aquaculturists and he represents a part of the State that is not as well represented as it must be. He also represents an occupation that is not well represented as it must be. I am sure that is more explanation that anyone wanted to hear, but it does fill some time while we are waiting for supplement #5 and it also clears the name of Mr. Tarbox.

The Joint Standing Committee on Taxation is pleased to report to the Legislature regarding its statutory reviews conducted during the interim.

Title 36 MRSA, Section 198 required the Committee to review certain tax expenditure items relating to income tax modifications. No changes, additions or deletions to these items are recommended at this time.

Title 36 MRSA, Section 1760, subsection 9-D, required the Committee to review the annual report on the phase-in of a sales tax exemption for fuel and electricity purchased for use at manufacturing facilities. This exemption is progressing smoothly and should be fully effective for the fiscal year beginning July 1, 1991. By phasing-in this exemption, the State will not be hit with a large

loss of revenue in a single year.

Title 36 MRSA, Section 6217 required the Committee to study the Household Tax and Rent Refund Program and recommend retention, repeal or revision. The Committee met this requirement during its review and deliberation of L.D. 2574, "AN ACT to Expand the Property Tax Circuit Breaker Program". Public Law 1987, c. 839 implemented our revisions to the program and retained it indefinitely by removing the Sunset Clause. However, we hope to continue our review and analysis of this program during this session because we view it as the best method of providing property tax relief for the citizens of the State of Maine.

We welcome your input in these or any of our future studies.

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the First Regular Session of the One Hundred and Fourteenth Legislature, now assembled, most respectfully present and petition the Congress of the United States, as follows:

WHEREAS, many Vietnam veterans have developed conditions which are more prevalent among this group than among the general populace, such as chloracne, porphyria cutanea tarda, non-Hodgkin's lymphoma and lung cancer; and

WHEREAS, these conditions require medical care and may make the veteran partially or totally disabled; and

WHEREAS, the failure of the Veterans Administration to consider these conditions as service-related has caused additional suffering and distress to these veterans; now, therefore, be it

That We, your Memorialists, RESOLVED: respectfully recommend and urge the Congress of the United States to grant presumptive compensation to Vietnam veterans with these conditions and to allow such compensation for additional conditions as the evidence accumulates; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable George Bush, President of the United States; the President of the Senate; and the Speaker of the House of Representatives of the Congress of the United States and to each member of the Maine Congressional Delegation and governor of the 50 states and United States

territories.

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the First

Regular Session of the One Hundred and Fourteenth Legislature, now assembled, most respectfully present and petition the Congress of the United States, as

WHEREAS, there is continually increasing evidence that many medical conditions are associated with exposure to dioxin; and

WHEREAS, many veterans have elevated dioxin levels in their bodies; and

WHEREAS, the failure of the United States Veterans Administration to consider these conditions as service-related, until further studies conducted, will cause additional suffering distress to these veterans; now, therefore, be it

RESOLVED: That We, your Memorialists. respectfully recommend and urge the Congress of the United States to direct the United States Veterans Administration to make available to any Vietnam-era veteran who was potentially exposed to dioxin-contaminated herbicides while in military service, a test which measures the level of dioxin (2, 3, 7, 8 -- TCDD) in the veteran's body; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable George Bush, President of the United States, the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States, each member of the Maine Congressional Delegation and each governor of the 50 states and the United States territories.

WHEREAS. the class action settlement initiated to benefit Vietnam veterans and not to restrict access to federal assistance programs nor to save the federal government money; now, therefore, be

RESOLVED: That We, your Memorialists. respectfully recommend and urge the Congress of the United States to amend the Social Security Act of the United States to provide an exemption for funds awarded to Vietnam veterans pursuant to the class action suit for the purpose of determining eligibility for federally funded public assistance programs; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable George Bush, President of the United States, the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States and to each member of the Maine Congressional Delegation.

Since then, she has had various positions within state government and is now working for the House Republican office. I know that many of you know her from her previous service to the state.

I feel sad about the fact that Ralph has passed away and I know many of you do here as well. He was a kind, loving gentleman that I became very, very fond of. I feel very fortunate to have known such a person.

As the Resolution points out, he was a great supporter of farms, dairy cattle, the sort of thing being from the southern part of the state I don't get too involved with but it was clear that he had a passion for that industry in the State of Maine.

In addition to that, he had a great passion for the fairs in the State of Maine. He worked very, very diligently at Windsor Fair and at other fairs throughout the state. In fact, this last weekend was the annual fair meeting that they have. Ralph had been sick for quite some time but was fortunate enough to be able to go to that fair meeting this last weekend. There is a saying "that when you get a chance to do something you really, really like to do, it is a lot like you died and went to heaven." I think from Ralph's standpoint, being able to have gone to that meeting this last weekend and to have come home and passed away in his sleep, he actually did die and go to heaven. I just want to bring that to the attention of the House because he was the kind of a guy that makes Maine a special, special place to live. I feel fortunate to have known him and I know our prayers and condolences go out to Rosa and all the members of his family. I thank you Mr. Speaker and Members of the House.
