I am pleased to enclose a copy of our report on the first eight months of operation of the Strategic Training and Accelerated Reemployment (STAR) Program. This report has been submitted to the Joint Standing Committee on Labor, in accordance Public Law chapter 577.

As I think you will agree after reviewing the ort, the STAR Program has surpassed our report, the STAR Program has surpassed our expectations for providing an essential training program for recently unemployed Maine citizens. During the first eight months, we have achieved over ninety percent of our goal for the first year, which was to provide education and training to 600 Maine people. I think you will also be pleased to find that the average wage at placement to date is \$6.33 per hour, which exceeds our goal of \$6.00 per hour. You may also be interested in knowing that the

STAR Program has been of significant assistance in aiding many of Maine's dislocated workers during the 1988/89 program year, in particular those previously employed by Health-tex, Emple Knitting Mills and Penobscot Poultry. Many of these workers left 20 or more years of hard work and loyal employment, to find themselves jobless with skills that are no longer marketable.

For your information, we will be submitting shortly a proposal to continue, and make a few changes to, the STAR Program. If you have any questions concerning this report, please do hesitate to contact me.
