Representative JOSEPH: Mr. Speaker, Ladies and Gentlemen of the House: I urge you to vote in favor of this particular measure. The questions that have been raised in this particular body have been questions that the unanimous committee report of the 13 members of the State and Local Government Committee have asked.

We have tried very hard to find solutions and answers to a long standing question. The questions that you heard raised on the floor have addressed and I urge you to vote in favor of this bill.

SPEAKER: The Chair recognizes from Presque Isle, Representative Representative MacBride.

Representative MACBRIDE: Mr. Speaker, I would like to pose a question through the Chair.

Is the passage of this bill going to impose any additional cost on municipalities?

The SPEAKER: The Representative from Presque Isle, Representative MacBride, has posed a question through the Chair to anyone who may respond if they so desire.

The Chair recognizes the Representative

Waterville, Representative Joseph.

Representative JOSEPH: Mr. Speaker, Men and Women of the House: In answer to the good Representative's question, this bill is mandatory. This is an option for any town or municipality if, in case, they would like to maintain, plow, and sand any private road in their area. This decision would be made by a vote of the body of that town, a legislative body or the people of that town, depending upon the way in which that vote would be taken.

The SPEAKER: The Chair recognizes Representative from Belfast, Representative Marsano.

Representative MARSANO: Men and Women of the House: I have attempted to ferret out what has happened with respect to this bill in committee.

understood that at one point that this matter had been considered as a piece of legislation which could conceivably go to the Supreme Court sitting on a solemn occasion for some kind of determination with respect to the constitutionality of the bill. don't know whether that is something being considered or not. What bothers me is what is inside of the bill with respect to litigation. It is my view that there is a good possibility that this bill will open up a substantial amount of litigation because I see it as incorporating the Maine Tort Claims Act and I think it incorporates it in a fashion which means that there is an exception for the way in which roads are maintained. Accordingly, I think there could be litigation about these roads.
One of the things that is in this bill that

strikes me as strange is the fact that the private road in order to be maintained has to be one which is not noticed as a private road. That creates the possibility that, on some kind of rainy or icy evening, you would go down one of these private roads (the signs indicating that it is a private road which would indicate to you that it wasn't well-maintained) would thereby mean that you were involved in a trap of some sort -- you get down there, the sanding hadn't taken place or whatever, the roads are narrow, they are icy or whatever and you get into an accident and then the question is whether or not there is municipal liability. It seems to me that there is a good chance there is that.

I live in an area which is famous for its hills and because of that, there are any number of these long winding roads that go down to streams, ponds, into camps and things of this nature, and I think that it is a difficult situation. I haven't been able to find out from the committee how the committee. considered this. I apologize to the members of the committee -- some of them I have spoken with but I haven't had a chance to talk to the Chair of the Committee yet and I may not get that before the vote but that is not critical because I hope when the vote is taken, you will vote against it.

SPEAKER: The Chair recognizes Representative from Standish, Representative Greenlaw. Representative GREENLAW: Mr. Speaker, Members of the House: I urge you to vote for this bill. I think the committee did a good job studying it. The bill has been around for years and I think as legislators we should have the courage to face up to this bill. In the meantime, I would ask you to think — did you ever see an attorney try to drive business away before?

SPEAKER: The The Chair recognizes Representative from Corinth, Representative Strout.

Representative STROUT: Mr. Speaker, Ladies and Gentlemen of the House: I would have to disagree with the previous speaker. I am today joining with my good friend from Belfast, Representative Marsano.

To answer the good lady from Presque Isle,

Representative MacBride, I don't think she got a clear answer -- there is no question in my mind that, if you pass a bill that says that municipalities are going to maintain private roads, of course it is going to cost them more money. I don't care if this goes to a solemn occasion or not, the issue here is public funds going to private roads. It is as simple as that. If that is what you want to do, then vote yes for this. If you don't want this to happen, you want to vote no.

These sixth grade students that are mentioned in the Legislative Sentiment before you today along with their classmates strong support and contribution selected the name "Endeavour", named after a Captain James Cook's ship that he piloted on three separate occasions. Accompanying submission of the name "Endeavour" was a board game, an educational board game pertaining to space travel and the travels of the space shuttle.

When I was about 10 years old, President John Kennedy spoke about putting a person on the moon before the decade of the '60's was out -- today we talk about the hope of spring and the kind of hope that this time of the year brings. I think these students speak well to that because I think they speak to the hope of the future because they will go on to their national competition in Washington, D.C. and sometime next month, NASA will select from all of the entries across the country, the overseas schools and the Department of Defense Schools, one name for the next space shuttle.

I hope that you will join me in wishing good luck those students from Martel School in their endeavor to have their name selected as that of next space shuttle.
