Came from the Senate Failing of passage to be engrossed in non-concurrence.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Jacques.

Representative JACQUES: Mr. Speaker, Men and Women of the House: I move that the House adhere.

Some of you may ask why I am making a motion that could in effect kill the bill. It seems that some of the people that are working for the Department of Fisheries and Wildlife right now, (wardens and biologists) have been calling certain legislators with concerns and reservations about the data-seeking methods and the census of moose in the State of Maine. As you can probably determine, it is awfully hard for us to argue the merits and demerits of these numbers based on those occurrences.

The problem I have is, I firmly believe that the House was right in the action that we took, thereby I am making the motion to adhere so that this House can reaffirm the position that we believe that Fisheries and Wildlife should manage its resources based on scientific data and research and not on emotions. Unfortunately, there are some people employed by the department that have problems with that very scientific data and research.

I would urge that the House support the motion to adhere.

The SPEAKER: The Chair recognizes the Representative from Cherryfield, Representative Farren.

Representative FARREN: Mr. Speaker, Ladies and Gentlemen of the House: I move that the House recede and concur.

Many will tell you harvesting more moose is a social or a personal issue. While I will not deny that the social aspect or ones personal preference enters into it, my decision goes further than that. How many moose do we really have? I am not comfortable with what they are telling us. Many people have told me that the current method of assessing the population is less than adequate, an estimate at best. There has been much more research done on the black bear, but even so, what we thought was a healthy resource, we are now told that major changes will have to be instituted if we experience another harvest as occurred last year. We harvested approximately 2,800. Only a few years ago, they were saying the population could stand a harvest of 2,000 plus. If the population was in such good condition only two or three years ago, why is it that, after only one year of such a harvest, all of a sudden it is more than the population can stand? I for one am not willing to take that chance with the moose.

We all know that clear cutting provides ideal habitat for moose. The discussion we hear in the halls and on some of the L.D.'s that we have seen, if put into law, will change the amount and the size of those clear cuts dramatically. I am not necessarily saying that changes should not be made but I am asking what impact that will have on the moose population? The estimated population, if accurate, has held its own under nearly ideal conditions. Are we willing to take a chance? That will be the case in the change of cutting practices if instituted. Why not wait until we have a better way of assessing the population and find out what impact changes in the timber harvest practices will have if any?

With respect to the cited safety problems on Route 201, I submit the moose population is only one of the reasons, speed at which the automobiles are traveling on that road are another factor. Regardless of that factor, I will concede that the moose population is high in that region. If so, and it is such a safety hazard, why hasn't the commissioner of Inland Fisheries and Wildlife proposed an increase in the number of permits in that area, even if it is at the expense of another area? He does have that authority, if my source of information is correct, and I believe it is.

Finally, ladies and gentlemen of the House, the so-called social or personal aspect, at least as far as I am concerned, might be reflected in my questionnaire. I included it on my questionnaire two years ago and again this year. The response was a greater percentage opposed this year than two years ago. 75 percent opposed and 25 percent in favor. I took particular notice of the respondents in an attempt to see what the hunters were saying. The result was many hunters, some of which participated in previous moose hunts, were suggesting that the number of permits issued not be increased.

Ladies and gentlemen of the House, I hope you will join me and concur with the other body.

Mr. Speaker, when the vote is taken, I request a roll call.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The pending question before the House is the motion of Representative Farren of Cherryfield that the House recede and concur. Those in favor will vote yes; those opposed will vote no.

In 1980, the Congress of the United States made a national commitment to institutionalize an official remembrance of the darkest chapter in human history, the Holocaust.

It is with great pride that I present this Resolution on the 44th anniversary of the Holocaust of those who suffered as victims of Nazism

commemorating Yom Hashoah, the "Days of Remembrance." It is hard for me to believe as a second generation that there are people who say the Holocaust never really happened. They stand on street corners or in front of colleges and universities preaching while passing hand-outs saying, it is not true, the stories about the Holocaust never existed, all fabricated. Just ask the people who are here today, the men and women at the Blaine House tea, who survived the concentration camps and watched their families and friends shot to death or burned to death in a furnace or used as surgical experiments, who have been tortured or starved to death. Just ask them if it is true or not.

Millions of people died, Christians and Jews alike, by the hands of the Neo-Nazis. Racism, batred bigotry are still alive today hatred. bigotry are still alive today, unfortunately. With the skin heads and the Ku Klux Klan, yes this is 1989 and Germany is unsettled again. The ultra right wing Nazis are back, they are again. The ultra right wing Nazis are back, they are doing what they call foreigner bashing. They want all foreigners out. The good German people are frightened, they want the Nazis out and they are fighting back. I am frightened too. We must protect and educate our children so they will never forget the Holocaust because it really happened. Hatred has never made our children or anyone happier but the one thing that we can give them is our blessing for world peace and hope that they do not ever forget but fight back.
