It's not only an excessive expenditure of state funds but it contributes to the solid waste problem. I think we should call this to the attention of the department involved and I can think of no better way to do this (and if you will join with me) than by returning your envelopes to me and I will see to it that they are returned to the appropriate department and we shall inform them that these are problems that should be dealt with and it should start in their own backyard.
