L.D. 1300):

Resolve to Request that the Board of Trustees of

the University of Maine System Determine the Cost of Establishing a Training Program for Nurse Practitioners in Northern Maine.
Board of Trustees of the University of Maine System authorized to study establishment of training program. Resolved: That the Board of Trustees of the University of Maine System is directed to conduct a study to determine the costs of establishing an advanced nursing degree program for nurse practitioners in northern

Reporting date established. Resolved: That the Board of Trustees shall report its findings, including proposed location of the program, to the Legislature by February 1, 1990.

The Chancellor's Office, working with the Nursing faculty in the University of Maine System, has carried out the study called for in the resolution and is herewith submitting to the Legislature the resultant report, "A Study to Determine the Costs of Establishing a Training Program for Nurse Practitioners in Northern Maine."

The University of Maine is interested in initiating this program. Locating the program at the University of Maine, should it be initiated, is supported by the nursing faculty and the administration at the University of Southern Maine and the University of Maine at Fort Kent, the Chancellor, and the Board of Trustees. It must be noted, however, that the University of Maine will not be able to offer the master's level nurse practitioner program unless it can be totally funded with federal funds.

Training grant funds for support of such programs are available from the U.S. Department of Health and Human Services. The closing date for the next round of applications for these training grants is March

30, 1990. The School of Nursing at the University of Maine is developing an application for a training grant to provide total funding for this program for submission by March 30, 1990.

Should the application for a training grant be funded by the U.S. Department of Health and Human Services, acceptance of the grant by the University of Maine would be contingent upon Board of Trustees of the University of Maine System approval of a formal academic program proposal from the University of Maine in accord with Board Policy.

We would be happy to respond to any questions about the costs study or the University of Maine System's planning efforts for a possible Master of Science in Nursing Program with a major in Rural Health Family Nurse Practitioner at the University of Maine.

JOINT RESOLUTION MEMORIALIZING THE

GOVERNMENTS OF EASTERN EUROPEAN COUNTRIES TO CONTINUE TO SUPPORT EFFORTS FOR FREEDOM

WE, your Memorialists, the Members of the One Hundred and Fourteenth Legislature of the State of Maine, now assembled in the Second Regular Session, most respectfully present and petition the governments of the nations of Albania, Bulgaria, Czechoslovakia, the German Democratic Republic, Hungary, Poland, Romania, the Union of Soviet Socialist Republics and its member republics and

Yugoslavia, as follows:
WHEREAS, the people of Maine have watched with admiration during the past 6 months as the people of your nations have courageously stood for the cause of freedom and the rights to which they and their

neighbors are entitled; and

WHEREAS, the people of Maine are preparing to attend our local town meetings, a cherished Maine tradition and the purest expression of democratic government; and

WHEREAS, individual expressions of conscience humanity have touched responsive chords in millions of fellow European citizens who have been inspired to add their voices to the collective demand for freedom of assembly, freedom of the press, freedom of religion, representative self-government market-based economies; and

WHEREAS, on our own behalf, and on behalf of the people of the State of Maine, we wish to express our support for this evolving process, which is bringing new vitality, and the adoption of democratic values, governance and decentralized self-representation to your countries; and

WHEREAS, we express our admiration for the efforts of your people and wish to encourage you to support these efforts and to continue to move forward toward a world of reduced tension in which all governments recognize individual liberties promote human dignity; now therefore, be it

RESOLVED: That we hope and pray that the peoples of your nations will have the opportunity to have their voices heard and their votes counted; and be it

further

RESOLVED: your That We, Memorialists. respectfully recommend and urge the Ambassadors of the above nations to communicate our support and admiration to the highest levels of your governments; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable George H.W. Bush, President of the United States, to the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States and to each Member of the Maine Congressional Delegation.

SPEAKER: The Chair The recognizes Representative from Waldo, Representative Whitcomb. Representative WHITCOMB: Mr. Speaker, Ladies and Gentlemen of the House: I am sure every person in this chamber, every person in America who cares about events around the world, has been following, very closely, the drama that has been taking place in eastern Europe and Russia over the last few weeks and months.

It seemed appropriate as we ended this season of our own democratic institutions, our town meetings, our political party caucuses, that we send this expression of Legislative Sentiment to the consulates of these people as appropriate recognition of the hope and prayers of all of us and our concern for the sheer courage and determination of these people.

This is just a simple message, but one I think that comes from each one of us with our own heartfelt

conscience and I urge its adoption.
The SPEAKER: The Chair recognizes Representative from Old Town, Representative Paradis.

Representative PARADIS: Mr. Speaker, Ladies and Gentlemen of the House: It is with a great deal of pride that I stand before you today to cosponsor this Resolution which is addressed to our President and to

the Congressional Delegation.

The Resolution calls attention to our complete support and encouragement of the actions of the people of eastern Europe in their efforts to remove Those of the Communist rule from their daily lives. us who grew up in my generation have been particularly aware of the brutality of this Totalitarian form of government and what it has done to its own people and how it has maintained itself in power by extreme brutality, mass extinctions, and any other form of oppression against its own people that can be imaginable.

I grew up in the Catholic Church and during the time I that was growing up as a boy, we prayed at each Mass for the conversion of Russia and bringing back the forms of Christianity that we knew and grew up under. We asked for this many, many times and our pleas, it appears, have been finally addressed and answered. We give thanks for this and we recognize the joy that these people must be experiencing and we join and request that our form of government here lend any means of encouragement that it possibly can.
