Bill "An Act Concerning Legislative Review of Nominations for Chief Executive Officer of the Finance Authority of Maine" (EMERGENCY) (H.P. 18) (L.D. 13) (Presented by Representative GWADOSKY of Fairfield) (Cosponsored by Senator CLARK of Cumberland, Senator PERKINS of Hancock and Speaker MARTIN of Eagle Lake) (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 27.)

By unanimous consent, without reference to any committee, the Bill was read twice.

Representative Gwadowsky of Fairfield offered House Amendment "A" (H-2) and moved its adoption.

House Amendment (H-2) was read by the Clerk and adopted.

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed. This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken. 124 voted in favor of the same and none against and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

Alcohol and Drug Abuse Planning Committee

In accordance with PL 1983, Chapter 464, the Alcohol and Drug Abuse Planning Committee (ADPC) is to conduct a statewide needs assessment every four (4) years. Although the next required assessment is not due until 1991, the ADPC felt that it was timely to conduct a needs assessment two (2) years following the major increase in the Premium Fund. This allows us to assess not only the current needs for substance abuse prevention, education and treatment programs/services, but also the change in needs resulting from the increase in the Premium Fund. The enclosed needs assessment document presents the substance abuse needs in the areas of dual diagnosis, education, law enforcement, corrections, and treatment as identified by individuals attending regional meetings. Comparing these results with those of the 1984 needs assessment, it is clear that the 1988 participants were better able to provide the specifics as they related to both need and methods for addressing the needs. Please note that in addition to the recommendations, a listing of the participants making the recommendations are included. I have enclosed a sufficient number of copies of this report so that each legislator will have their own copy. A copy of the transmittal letter has been inserted.
