Senator PEARSON of Penobscot was unanimous consent to address the Senate on the Record. Senator PEARSON: Thank you Mr. President. Mr. President, men and women of the Senate. In Enfield, where I live, some time ago there was a very tragic murder of a little girl. She was in the third grade and there has been an ongoing investigation. As you have probably read in the paper, they have arrested somebody who allegedly perpetrated the crime. Of course, that particular case is of considerable interest in the town. Last night I was was watching the news coverage of the case on television. They went to arraign the alleged perpetrator in court in the town of Lincoln, and when they came out the television crew, it seems to me, shoved a microphone into the face of a little eight year old girl and proceeded to interview her about the case. This was just something that bothered me a great deal. If you

can imagine what it would be like to have a child in little rural town like that and have to go through all the explanations to the children that were in the grade with the victim and then to have a television station just for "news sake" stick a microphone in front of her and ask her about the case. It was just something that screwed up my stomach a little bit, because it didn't need to be done. The child put her hand up because the light was coming in her face and she was very shy. You can imagine all of the things that her parents have had to explain. They had to, apparently, take the child into the court in order to arraign this person for some reason or another, but I don't think there was any need of what the television crew did. Thank you.
