(Off Record Remarks)

Representative Melendy of Rockland was granted unanimous consent to address the House.

Representative MELENDY: Mr. Speaker, Men and Women of the House: It is with a great deal of pleasure that I rise to share with you a few paragraphs of updated history about the "Bowdoin", the official State of Maine Vessel.

As many of you who were members of the 113th Legislature will recall, the approval of naming the Bowdoin our official state vessel was granted by the Legislature in 1988. I am sure some of you will also remember that, at the time, there were legislators concerned that the state not absorb any cost by the designation of this historic vessel, which was planked by Maine men, using Maine white oak, and skippered by a Bowdoin College graduate in Arctic explorations.

The Bowdoin had been refurbished by the Schooner Bowdoin Association at a cost of \$750,000. Due to prior fundraising efforts by the association, the purchase of the vessel was possible at a cost of only \$180,000. You will be pleased to hear that the purchase of the Bowdoin by the Maine Maritime Academy was made possible as a result of the sale of another vessel acquired through a drug bust and no state funds needed to be appropriated for this purchase.

As the sponsor of the legislation that gave the Bowdoin its new title, I was invited by Dr. Edward Morse, President of the Schooner Bowdoin Association, and Maine Maritime Academy President Kenneth Curtis to attend the signing of the documents on Thursday, April 27, that made the Bowdoin the property of the State of Maine.

The Bowdoin is now owned by Maine Maritime Academy, which will use the vessel to train academy students to sail, as a recruitment tool, and for public visitation and fundraising for the school during port stays. The restoration of the Bowdoin and the future use of the schooner stands as a tribute to Admiral Donald MacMillan, who captained the boat on many Arctic voyages, and keeps alive an important chapter of Maine History.

On motion of Representative McGowan of Canaan, Adjourned until Wednesday, May 3, 1989, at twelve o'clock noon.

JOINT RESOLUTION MEMORIALIZING CONGRESS
OPPOSING A FEDERAL MOTOR FUEL TAX
FOR DEFICIT REDUCTION

WE, your Memorialists, the Members of the One Hundred and Fourteenth Legislature of the State of Maine, now assembled in the First Regular Session, most respectfully present and petition the Congress of the United States as follows:

WHEREAS, some Members of Congress have proposed that the federal tax on motor fuels be substantially increased to raise funds for the purpose of reducing

the federal deficit; and

WHEREAS, a federal motor fuel tax increase large enough to provide more than a token decrease in the deficit would shrink the tax base for the states by reducing gasoline use; and

WHEREAS, the states rely heavily on motor fuel taxes for highway and bridge construction and maintenance and for other highway needs; and

WHEREAS, such a reduction in the states' tax base would add pressure for further increases in state motor fuel taxes to compensate for the reduced tax base: and

WHEREAS, such increased taxes at both the federal and state levels would seriously affect travel and tourism within and among the states further eroding state and local government revenues; and

WHEREAS, motor fuel tax increases disproportionally affect the poor and consumers in larger states where travel distances are greater; and

WHEREAS, the diversion of federal motor fuel tax revenues for deficit reduction would place an unfair burden on vehicle users for solving a national problem; and

WHEREAS, such a diversion strikes at the heart of the federal highway user fee concept that has served the nation so well in financing necessary highway-related programs; now, therefore, be it

RESOLVED: That We, your Memorialists, urge Congress to reject proposals to increase the federal motor fuel tax and to find other, more equitable and less damaging ways of reducing the federal budget deficit; and be it further

RESOLVED: That duly authenticated copies of this Memorial be submitted immediately by the Secretary of State to the Honorable George H.W. Bush, the President of the United States, the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States and to each Member of the Maine Congressional Delegation.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Pearson.

Senator PEARSON: Thank you Mr. President. President, men and women of the Senate. When the first moose Bill was passed to allow the taking of moose, I believe it was the first time since 1935, I was a member of the other Body. When the Bill was passed, the limit was at one thousand and it went out to all the voters of Maine and they ratified the action of the Maine Legislature. Many people have come into the Legislature since that time and many people have left. There are not a lot of us who are still here that were here then, but I felt, and still feel, that at that time we made a promise not only to ourselves, but to the people of Maine in as much as it went out to a statewide vote that it would be one thousand. That is why I feel it should say at that number. A promise was made in this particular Body at that time. There was considerable debate over the issue and I can remember very distinctly Senator Conley from Portland, who was against the passage of anything, added an amendment one time that said nobody could take a moose with anything other than a thirty-five millimeter camera. Some of you who were here will remember those days and how exciting they were and how much debate took place. My comrade, who is a Representative from Old Town, Representative Gould, in the last vote of the Maine Senate when it was finally enacted was out in the corridor with his There was a lot of feeling trombone playing taps. about that Bill and I still think there is. When I went home the last couple of weekends, going down to the general store that has a lunch counter, I wasn't able to get through breakfast without people talking to me about this particular Bill. The way they said it on several occasions was one thousand moose was enough.

THE PRESIDENT: The Chair recognizes the Senator

from Oxford, Senator Erwin.

Senator ERWIN: Thank you Mr. President. Mr. President, men and women of the Senate. When the vote was taken on this Bill last week, as I looked around the Chamber, I have to admit I was just a little surprised. I know there are strong feelings on the hunting and trapping issues and I respect the people with those strong feelings, but there were others that I couldn't quite figure out. Since then, I have been asking myself, why did they vote that way? The only answer I can come up with was that they must know something that I don't know. They must know something that some of the other members of the Fisheries and Wildlife Committee don't know.

The Commissioners of the various Departments have very important and a very tough job. They are picked for their capability, their dedication, their credibility and those are just three of the many things that I am sure goes through the Governor's mind when he is choosing someone for nomination to be

a Commissioner. It is not an easy job. We in the Legislature, in all our our wisdom, what I would call management tools to the different Commissioners to try to help them better run and operate their Departments. This Bill, under consideration today, I consider one of those management tools.

Existing statutes give Commissioner William Vail the right to issue zero permits or up to one thousand permits, it doesn't tell him that he has to issue This Bill would increase that range from zero permits to fifteen hundred permits. I don't know whether you have noticed it or not, but you have a letter that the Commissioner has had placed on each of your desks. I suggest you at least look at it, whether you spend time reading it or not is up to you, but I think you should at least look at it.

What we are deciding today, when you come right down to the nuts and bolts, is that we expect our Commissioners to run their Departments, we expect them to be capable, we demand on them certain things. Are we, or are we not, going to support our Commissioner? Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Waldo, Senator Gould.

Senator GOULD: Thank you Mr. President. Mr. President, men and women of the Senate. I rise today to support the Senator from Oxford, Senator Erwin's, position. I would like to read to you two paragraphs of the Commissioner's letter, because I think they are very important. "I think it is very important that you understand the fact that Maine's moose population is continuing to grow and that an increase in the number of permits available is virtually important to maintain the health and stability of the moose herd."

"I cannot overstate how critical it is to keep the moose population in line with the available habitat and to further be able to adjust the harvest either up or down depending on these changes. By increasing the ceiling from one thousand to fifteen hundred, you will be giving our agency the ability to more effectively adapt to these ever changing population levels and habitat differences." I urge you to follow the good Senator from Oxford, Senator Erwin's, motion to Recede and Concur. Thank you.

Loathe the Senate Majority Leader who stands up and thinks that she can add anything of meaning or influence to a Bill that deals with the number of moose permits issued to Maine residents, but allow me to speak as the individual Senator from Senate District 26, and share with you my experience, with reference to this measure and its predecessors.

While I would, in all sincerity, like to be able support the Senate Chair of the Committee on support the Fisheries and Wildlife this later afternoon, I must tell you that I have to vote against the pending motion on this Roll Call that we are about to take. In all of the years that I have served in public elected office in this Maine Legislature, in one Chamber or the other, there has never been a more unpopular vote than the one I cast in support of what

is now known as the "Maine Moose Hunt."

I am continually badgered by being not so gently reminded by a large number of my constituents that I voted not in the best interest of my constituents, or as the majority of them feel relative to harvesting of Maine moose. Yet, at the time I cast the vote, I thought I was doing so responsibly, reasonably, and intelligently, for I was a graduate of one of the numbers of Commissions whose charge had been to study the funding of the Department of Inland Fisheries and Wildlife and a moose hunt was part of the examination in the interim between sessions. I took that charge very seriously.

To this day, I continue to support the moose hunt, but in earlier debate there are those who suggested to do otherwise. In other words, to increase the number of moose that may be harvested would, in fact, be breaking faith with the people of the State of Maine and that is exactly why I must against the pending motion. As constituents from my area said to me today, as they were testifying on a Bill which originated locally within my district, "don't let them shoot more moose, Nancy. If they keep raising the ante, it just isn't fair to those of us who don't support Maine's moose hunt." hunt." I am not about to quote a friend of mine, has a father, her name is Ashley, but I do understand the Commissioner's letter and I would like in so many respects to personally recognize his administration for committing itself to manage this remarkable wildlife resource. To be true to my Senate District, I must vote against the pending motion. Thank vou Mr. President.

Ladies and gentlemen, we shouldn't be deciding moose hunting based on emotionalism. In fact, the Legislature shouldn't be deciding that issue at all. It should be the Department of Fisheries and Wildlife and the Commissioner. I can remember that debate and fighting for that issue during that year to get an opportunity for Maine hunters and sportsmen to have the opportunity to bring some increased revenue to the State of Maine through hunting and fishing to our northern part of the state. Ladies and gentlemen, we have all the scientific information that we should need from the Department. There were no deals struck, that I can remember, and I would think that the citizens of this state would want us to do the right thing based on biological evidence, based on the scientific research by the biologists, wardens, and other experts in the field. What we have here today is emotionalism and it doesn't make any sense at all. So, I hope you would reconsider your vote and allow the Department to do what it is charged to do and if we can benefit as sportsmen to have a little more of a hunting opportunity than so be it. I think that makes sense. Thank you.

Those are in the enzyme and scum areas and there wasn't anything done as far as that particular issue. Also the issue of perceptibility versus use and the issue of a time frame for the Board of Environmental Protection to implement the recommendations from that study to make sure that it wasn't just another study, but, in fact, ultimately became law. That basically is the amendment and it isn't before us today because of the consideration of whether this Body would Reconsider or whether there was support to do that. Why go ahead and draft something if the Body isn't going to be amenable to listening to any type of discussion on the issue.

THE PRESIDENT: The Chair recognizes the Senator from penobscot, Senator Pearson.

Senator PEARSON: Thank you Mr. President. President, men and women of the Senate. It seems to me that if we were to Reconsider this particular Committee Amendment, we all know that we would be doing that in order to consider another amendment.
