THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Berube.

Senator BERUBE: Thank you Mr. President. Mr. President, men and women of the Senate. I would like to explain the reason why some of us voted on the majority side of this Bill. This L.D. deals with two Constitutional Offices: the Attorney General's Office and the Secretary of State's Office. It extends the term of both, from the present two year to a four year term. Both Constitutional Offices would be popularly elected rather than selected by the Legislature.

Since it is a Constitutional Amendment, it would go to the people for their acceptance. The election would be held in 1992. There is only one state in our nation that elects the Attorney General by the legislative process and that is the State of Maine. There are only three states in the country, Maine, New Hampshire, and Tennessee, who elect the Secretary of State by the legislative process. I might add that the District Attorney's are elected by the people at large.

In the view of those of us who voted for the majority, it would make the position perhaps less political in that it would be less binding, if you will, to the party selecting that individual. The fact that they had a four year term would certainly

be a positive direction to take.

I personally view that presently those Constitutional Offices are merely an extension of the Legislature and I think that this would be a fair process to allow the public to be able to select their people. Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Cumberland, Senator Esty.

Senator ESTY: Thank you Mr. President. Mr. President, men and women of the Senate. This is a very straightforward issue and I don't want to spend a great deal of time discussing it. I would just like to say that the system we have, presently, works very well. We have outstanding leadership in both of positions and we have consistently had

the positions and we have consistently had outstanding leadership in both positions in the past. I don't believe that by approving this process that the positions will become less political. In fact, I believe they may very well become more political. I just tend to believe that it is a system that is working very fine now and that we should maintain it. Thank you.

THE PRESIDENT: The pending question before the Senate is the motion of Senator REPLIBE of

question before the Senator BERUBE of Senate is the motion of Androscoggin to ACCEPT the Majority OUGHT TO PASS AS AMENDED Report in NON-CONCURRENCE.

A vote of Yes will be in favor to ACCEPT the Majority OUGHT TO PASS AS AMENDED Report.

A vote of No will be opposed.

Senator WEBSTER: Thank you Mr. President. Mr. President, men and women of the Senate. Before we Accept the Majority Report, which I am sure we are going to do, I would like to just bring to your attention that perhaps a need for some type of Bill or some mechanism to inform members of the Legislature as to what is being done and the purpose for Legislators attending conferences. It would seem to me that at some point we ought to be reporting back to this Legislature or some mechanism ought to be made available so that the public would know exactly where the dollars are being spent and why and for what purpose Legislators out-of-state. Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Cumberland, Senator Clark.

Senator CLARK: Thank you Mr. President. Mr. President, men and women of the Senate. The good Senator from Franklin, Senator Webster, has suggested, ever so gently, that there may be need to report the expenses and the purposes for which Legislators attend educational and or legislative conferences. I do not disagree that there are mechanisms that provide for this reporting and that is, obviously, the public information and public access to all legislative documents, public hearings and meetings, not the least of which includes, as that good office that he represents knows, the expense sheets that Legislators submit.

That we should establish, in legislative mechanism and organization, a reporting much like one would report when one goes on a field trip that occurs sometimes in our lower grades in public schools, even a show and tell type of mechanism, I think does not legitimately address the value that gained by attending and participating in these legislative conferences and educational experiences.

Probably the single most visible mechanism for reporting the benefit of these experiences out of our

state and welcoming these conferences, occurred in our recent past in our state, are the expansion of horizons and an educational level which occurs within the various topic areas, the seminars. and the meetings which afford all Legislators, from all regions of the country, to share not only their legislative experiences and agenda, but the issues which are priorities and are currently before their sessions. I think probably prime among the reporting mechanisms are the Bills that we receive before our various standing and select committees which emanate and frequently are originated from these experiences and the knowledge gained at these various conferences.

Speaking personally, I never attended a legislative conference until I was elected to leadership. I simply have to say, if I were to assess that non-participation for twelve years of my legislative experience, that I deprived myself of opportunities that have been a continuing education experience in these last five years. I would encourage, with the Presiding Officer's permission, all Legislators to seek to attend one or more of these opportunities within your topic areas, subject areas, and Committee areas of interest during your two years in this 114th Legislature. It is an expanding experience, an educational experience, and certainly a challenge for all of us. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Webster.

Senator WEBSTER: Thank you Mr. President. Mr. President, men and women of the Senate. My reason for rising here today is to bring to your attention that the sponsors of this Bill brought this measure before the Legislature because of their concern with the expenses that are being accrued by this Legislature traveling throughout the country. I believe that in the future you are going to see similar legislation like this until something is done about it.

The legislative budget, in the last few years, has skyrocketed and, in my opinion, one of the reasons, without question, is because of out-of-state travel. It seems to me that the concerns of the taxpayers of this state ought to be the concerns of the people of this Body and I know they are, but I think we ought to be looking at how we are spending our money. In my opinion, traveling, as frequently as we do, outside this state is not the best use of

taxpayers money. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Gauvreau.

Senator GAUVREAU: Thank you Mr. President. Mr. President, men and women of the Senate. I rise in support of the Majority Report from the Joint Standing Committee on State and Local Government. In my view, quite honestly, I think it would be a penny wise and a pound foolish if we were to impose limitations or disincentives for our membership to engage in educational seminars and workshops. As you I serve on the Joint Standing Committee on Human Resources and I can't begin to tell you how many times our members have gleaned important and relevant information on federal and state policy and brought that back to the Committee and assisted us immeasurably in crafting reasonable legislation. Human Resources areas, of course, involve major joint, state, and federal financial participation. In areas dealing with welfare reform, health care initiatives, mental health policy, in all of these areas we have learned and profited greatly from our members going about the country to various conferences.

I would also point out, as a matter of some pride, that when I have attended these conferences quite often it is members of the Maine Delegation who take the lead in Committee discussions, who are well versed, who understand the issues. For example, at a conference I went to last year, Senator Gill, was one of the presiding officers and Senator Gill, the Senator from Cumberland, is certainly held in high esteem by her colleagues around the country. I really think that we would be embarking on poor policy if we were to discourage our members from taking advantage of these conferences. I, for one, strongly support the Majority Report from the Joint Standing Committee on State and Local Government.

THE PRESIDENT: The Chair recognizes the Senator

Senator BALDACCI: Thank you Mr. President. Mr. President, men and women of the Senate. In reading the Bill on this particular matter, it was of great interest having been on one educational conference in my four terms in the Senate back in 1983, if I recall correctly. The thing that disappointed me in the legislation was that there were a lot of things that take place in these conferences and seminars that you go to that are not within a room, are not with teachers, are not with specialists in those particular fields, but they happen outside of the classroom.

The trip that I went on, and I guess that is why been on any other educational trips since then, was with the former Presiding Officer, Gerard Conley, and at that time the Chair of the Appropriations Committee, Senator Mary Najarian of Cumberland, and the other Senator from York, Senator Danton. We went on a field trip to Mexico, a town just across the Mexican border. We were there to inspect the situation and to see all the different things that were going on in Mexico. We had parked the automobile next to the side of the road and there was a young boy that was there and he said to the President of the Senate that if he would give him a dollar he would watch the automobile. When we got back to the car all the chrome was gone off the automobile, the chrome was completely peeled. The President of the Senate probably figured it was on the streets shortly after that. On the way back, our car had conked out and we ended up in this small mexican community and it was very interesting because you got to meet with the people in that particular community and they helped us with our automobile to get it cooled down. We got to talk with the natives and we tried very hard to get out of town before it was dark. When we got back into town, we were suppose to pick up the Speaker of the House in the shopping center because he was inspecting shopping When we picked him up we were not suppose to say anything about this little incident and excursion and when the Presiding Officer of the other Body got into the automobile, the automobile started billowing with smoke and we were suppose to ignore this and pretend nothing was happening. When the Speaker of the House asked us what was wrong everybody said nothing was wrong and everything was fine.

It was a very educational experience that I had encountered and it happened outside of the seminars that you go to and the speakers that you listen to. I think the point here is that to document all of those things that do go on would be very hard to do and this Bill calls for that kind of documentation and that kind of report. I remember the Presiding Officer saying that when we came back we were just walking encyclopedias and I believe that, I really do, I felt like the World Book when I got back here

and I just think that you can't document all of that. Thank you.

Off Record Remarks

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Clark.

Senator CLARK: Thank you Mr. President. President, men and women of the Senate. I hope that during this short debate that many of you may have turned to L.D. 1011 and reviewed, as did I, the precise particulars of this document, because not only has the State and Local Government Committee acted wisely, but we would have, as a result of passage of this Bill, still another report on our desks. A compilation, if you will, of all the data, filed appropriately, and I am sure bound, at no inconsiderable costs to the taxpayers of this state, of all that was experienced by members of the Legislature. Suffice it to say, I don't know what color that report would be, but I think perhaps it is not one that would be of great demand on behalf of the citizens whom we serve.

More precisely, there has been an allegation that the taxpayers money, which by the way includes the members of this Legislature who are coincidentally taxpayers too, that it is an unwise expenditure and that if we proceeded, as this measure would have us proceed, that it would be an efficient use of

taxpayers money.

I think it is probably unnecessary today to review with you what one must endure or experience if one wishes to journey to one of the conferences, seminars, or meetings of a number of the legislative organizations which provide these opportunities for expansion of our horizons as well as our educations. But, when we receive the material, usually we receive it individually, as Senators, or we receive a memo accompanied by a request to see if we are interested, from our Presiding Officer or one of the floor leaders. We then follow, as a procedure, filling out a request for authorization for out-of-state travel on legislative business. The source of this form is the President's Office. You not only have to record your name and the date you request permission, but meeting information, which includes sponsoring organization or committee, if you are a member, if you have attended previous meetings of the same group, the topic of particular interest, the dates of the meeting or seminar, the location, your preferred with a number travel arrangements, sub-informational sections, hotel reservations, and an admonishment from our Presiding Officer to submit this form at least fifteen days prior to registration. This also needs to be approved by the Presiding Officer.

Once your request for out-of-state travel has been approved, you will receive a packet from the office of the Executive Director of the Legislative Council, which includes your travel and expense account voucher plus an instruction sheet, in case we have forgotten on how to fill out one of those expense account vouchers, and a listing of what is an expense and what is not a legitimate expense. addition to that, there is a facsimile of a completed voucher filled out. Many of us have traveled, not extensively but at least more than once, and are familiar with this process and this increases not only the legitimacy of our request and the legitimacy of that which we seek to attend, but the expenditure of legislative monies which are provided by the

taxpayers of this state.

To suggest that it is not a legitimate expenditure and that the taxpayers question how we spend our money in this area of the exercise of our offices, I think is specious. This submission of materials prior to our attendance and the submission of our expense forms after our attendance, are all accessible and are matters of public record should any taxpayer seek to review them, as has been the case multiply times within my area of knowledge.

Suffice it to say, that those who choose not to travel choose only to experience the educational opportunities in some respects limited that are afforded within the boundaries of our great state. Again, I would invite all members of this Maine Senate, within the term of your office in the 114th Legislature, to expand your horizons with one or more of these legislative conferences through the usual procedure and or process. Education continues to be exciting. Thank you Mr. President.

THE PRESIDENT: The pending question before the Senate is the motion by Senator BERUBE of Androscoggin, to ACCEPT the Majority OUGHT NOT TO PASS Report, in concurrence.

The Chair ordered a Division.

Will all those Senators in favor of the motion by Senator BERUBE of Androscoggin, to ACCEPT the Majority OUGHT NOT TO PASS Report, please rise in their places and remain standing until counted.

Will all those opposed please rise in their places and remain standing until counted.

26 Senators having voted in the affirmative and 2 Senators having voted in the negative, the motion by Senator BERUBE of Androscoggin, to ACCEPT the Majority OUGHT NOT TO PASS Report, in concurrence, PREVAILED.

On motion by Senator WEBSTER of Franklin, ADJOURNED until Wednesday, May 17, 1989, at 12:00 in the afternoon.
