### JOINT RESOLUTION MEMORIALIZING THE PRIME MINISTER OF ISRAEL RECOGNIZING HIS RESTRAINT IN NOT EXERCISING ISRAEL'S RIGHT TO RETALIATE AGAINST IRAQ

We your Memorialists, the Members of the One Hundred and Fifteenth Legislature of the State of Maine, now assembled in the First Regular Session, most respectfully present to the Prime Minister of Israel as follows:

WHEREAS, we are outraged at the attacks against the civilian population of Israel by the Iraqis; and

WHEREAS, we condemn the wanton destruction of the lives of innocent men, women and children; and

WHEREAS, we want the people of Israel to know we are supportive of their efforts to work harmoniously with United States and allied forces during this period of war in the Middle East; and

WHEREAS, we admire the restraint of the Prime Minister in the face of repeated, unprovoked attacks; now, therefore, be it

RESOLVED: That we commend the people of Israel for their close cooperation with the United States, fortitude in a time of stress and forbearance in dealing with an unprovoked aggressor nation and assure them that Americans are with them wholeheartedly; and be it further

RESOLVED: That We, your Memorialists, respectfully commend the Prime Minister of Israel on his restraint; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable George H.W. Bush, President of the United States, the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States, each Member of the Maine Congressional Delegation and the Israeli Ambassador to the United States for transmission to the Prime Minister of Israel.

# JOINT RESOLUTION PETITIONING THE GOVERNOR TO RESCIND HIS ACTIONS IMPLEMENTING DELAYED PAY DATES

WHEREAS, state employees provide vital and necessary services, as determined by the Legislature and approved by the Governor, to the citizens of the State; and

WHEREAS, the timely and efficient provision of services requires sufficient personnel to operate in

# a productive and cost-effective manner; and

WHEREAS, the Governor has ordered the systematic deferral of paychecks resulting ultimately in an additional week's delay in pay dates for the purpose of depriving employees of a portion of their salary; and

WHEREAS, the imposition of lag pay dates effectively constitutes the levy of a special tax or assessment on state workers between now and the end of the fiscal year on June 30, 1991; and

WHEREAS, several budgetary alternatives to the lag pay-date plan have been presented and received bipartisan support from a majority of the Legislature; now, therefore, be it

RESOLVED: That we, the members of the One Hundred and Fifteenth Legislature, now assembled in the First Regular Session petition the Governor to rescind his letter of February 13, 1991 that implements lag pay dates; and be it further

RESOLVED: That a suitable copy of this joint resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable John R. McKernan, Jr.

# Was read.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Waterville, Representative Joseph. Representative JOSEPH: Mr. Speaker, Ladies and Gentlemen of the House: I am asking for your support on this Resolution. If you will notice, this Resolution is asking the Governor to rescind his letter and Executive Order dealing with the delayed pay dates. State employees did not cause this problem, state employees are one percent of Maine's population and I am asking, why are we targeting this select group? This one percent of Maine's population is paying for 8 percent of the problem in this fiscal

year. My question would be, why is that? This policy of delaying pay dates forces state employees to lend the state money. The pay back to these employees could be months or it could be years.

This is a tax. This is a tax on a select group of people. When you derive people of a portion of their income for the purpose of funding of the state budget, what do you call it? It is a tax and at a cost to each state employee of one week's wages. We tend to forget that state employees have voluntarily given \$11 million to alleviate the shortfall that this state government is now experiencing, \$11 million to help balance the state budget through the voluntary cost saving programs.... this year, this fiscal year of 1990 to 1991.

Through this Supplemental Budget process, several alternatives have been put forward to balance the budget and those alternatives still continue to exist, alternatives proposed by the Appropriations Committee, alternatives proposed by the ad hoc committee. The legislature did not propose the furloughs, the legislature did not propose a delayed pay date. The majority of this legislature did not want to do that. L.D. 274 did not propose this action.

We are now asking the Governor to rescind his letter and his Executive Order.

Mr. Speaker, when the vote is taken, I ask that it be taken by the yeas and nays.

The SPEAKER PRO TEM: The Chair recognizes the

Representative from Belfast, Representative Marsano. Representative MARSANO: Mr. Speaker, Ladies and Gentlemen of the House: I appreciated the opportunity which the House afforded me the other afternoon to have this matter considered today rather than the day we last met here.

I have objection with respect to one of the paragraphs to which the Representative from Waterville alluded to and that is specifically the alternatives to the lag pay day plan have been presented and received bipartisan support from a majority of the legislature. Now the phrase "the majority of the legislature" has been one that has been bantered about at great length in the halls of this House during the recent concluded budgetary debates.

The rules are clear that a majority in this House are of two sorts, one is a simple majority and the other is a two-thirds majority. Too often we take the position that simply because the Democrats have a simple majority of the numbers in the legislature that the rule of a two-thirds majority means nothing but, in fact, it does.

It is my suggestion to you, ladies and gentlemen of the House, that there has never been bipartisan support from a majority of the legislature with respect to alternatives to using the money which was derived from the action we took which released the \$8.3 million and which supported the furlough days and this rollback. We are subject to the rollback, the rest of the members of state government are subjected to the rollback — I don't say that it is pleasant, I don't say that it is not one of those things that I would not vote to undo if it were fiscally possible to do that, but the simple immutable facts are that it is not. By passing this Resolution, we are simply, again, acting with a fiscal irresponsibility which cannot continue to be our course if we are to help Maine through these troubled times.

For that reason, I would urge the House to vote against the adoption of the pending Resolution.

The SPEAKER PRO TEM: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor

will vote yes; those opposed will vote no. A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER PRO TEM: The pending question before the House is adoption of Joint Resolution (H.P. 793). Those in favor will vote yes; those opposed will vote no.

# (At Ease)

The House was called to order by the Speaker protem.

Representative Erwin of Rumford was granted unanimous consent to address the House:

Representative ERWIN: Mr. Speaker, Ladies and Gentlemen of the House: When we voted on the budget last Wednesday, how many people knew exactly what they were voting for. Representative Paul-Jacques of Waterville was wise beyond his years when he refused to vote for something he didn't fully understand. It is our responsibility to know what we are voting for. How many in this chamber knew exactly what they were voting for? Why, after the agreement had been reached, that each side have their staff go over what was being printed so very carefully?

The members of the Appropriations Committee and the staff are dedicated, capable people who have given much of themselves these last several months. They have made many sacrifices of their time and self for the betterment of the people of the State of Maine. One of the best legislators that will ever serve the State of Maine made the supreme sacrifice, Representative Donald Carter. I appreciate the work of the committee and staff and would never deliberately say or do anything to indicate otherwise. However, if I had known that the Human Services Regional Office in Mexico was going to be closed, I would not have voted for the budget. When I picked up the Sun Journal to read early Friday morning, headlines of an article on the front page were, "Mexico DHS Office to Close." I am sure you can understand that my telephone was very busy that day.

I was told that the reason for the closing was the low caseload so I called the Mexico Office and requested information as to the size of the caseload in comparison to the Farmington Office which was not chosen to be closed. Three offices of Human Services are being closed, two are in Oxford County, Mexico and South Paris and one in Bangor. The Bangor Office being closed is a small branch of the main Bangor Office. People will be inconvenienced but they will still have the main office. The South Paris Office is only open one or two days a week and may be considered a branch office. Are the people being served going to have the means to travel? If so, are they physically able to travel and spend the better part of a day away from home? The Mexico Office serves a rural area and may be smaller than those in a city but when you compare it to offices in other areas as to their caseload capabilities and so forth, you will find that Mexico will come out ahead. For instance, the Public Health Nursing Unit For instance, the Public Health Nursing Unit in Mexico conducts one or two well-child clinics in office each month. These clinics are offered to pre-school children of middle income families. Those families are not covered by Medicaid. These clinics take in children from Wilton, Canton, Dixfield, Peru, North Turner, Dryden, Farmington, Frye, Roxsbury, Byron and other areas as well as Mexico and Rumford. This service is not offered in other Human Services Office in this region. How was the Mexico Office chosen? The people are capable, dedicated and carry out their responsibilities just as efficiently as the Office in Farmington so it can't be because of the workers. The caseload in Mexico is larger than in Farmington so it can't be that. In the past five months, the caseload in Mexico was 2,910 and in Farmington, 2,646.

The unemployment in the Mexico/Rumford area and in the Norway/South Paris area is very high. In fact, our area had the second highest unemployment in the state. In the 1950's, Rumford had over 10,000 people and Mexico had about 5,500; today Rumford has about 7,000 and Mexico, 3,500. Why the decline in population? Jobs. We are working very hard trying to attract more businesses to the area so our people may find work. We certainly need to keep what we have. Thank you for allowing me to make this statement on the Record.
