SPEAKER: The Chair recognizes The Representative from Augusta, Representative Daggett.

Representative DAGGETT: Mr. Speaker, Ladies and Gentlemen of the House: I move indefinite postponement of this bill and all accompanying papers.

Whenever we find ourselves discussing issues such as gun safety, it is an incredibly emotional issue. Sometimes it is very difficult to separate the emotion from the rationality. Just to address that, I would like to read a few sentences from a letter which appeared in the Kennebec Journal addressing this particular bill. There can be excesses on all sides and I think this speaks to the kind of excess that can happen on an issue such as this.

The letter says in part, "Thus, both groups are part of the problem, meaning SAM and NRA, part of the sickness making our country the most violent society in the world. Saddam Hussein for all his atrocities doesn't even come close to the blood bath their anti-control tactics are responsible for." That is only an example to give you an idea of the reaches that this kind of issue can make. I would like to kind of bring it back into some kind of scope looking at exactly what happens in Maine and what isn't happening in Maine.

Gun safety in Maine, frankly, is not a compelling issue. According to the John Hopkins Injury Prevention Center in 1989 statistics, death from firearms doesn't even make the top 10 causes of death for Maine children. It doesn't even make the top ten. It does make the top ten nationally. In fact, the accident rate from firearms in Maine has been decreasing at a fairly constant rate over a period of years in large part due to the hunter safety and

firearms awareness programs that are, in fact, presented here. Part of our safety program requires that first-time hunters go through a safety program. It also requires those wanting to have a hand gun permit to exhibit some knowledge of hand guns. Although this may be applied a little differently in different municipalities, in some it is better than others, but it does require a knowledge of hand guns. So there are some pretty effective education programs going on, not to mention some of the programs that are going on in schools as well. The safety record in Maine is quite strong and it is not at all comparable to a couple of the other states that have passed this kind of legislation.

Just to speak briefly about the locks themselves, a lot of people don't understand and, I will be frank, I really didn't know a lot about trigger locks or trigger locking devices until we started dealing with this bill. There are many trigger locking devices available. There are a variety of different kinds. Some work only on hand guns, some work only on double action guns. There is one for hand guns that, in fact, uses thumb pressure. It is based on the assumption that an adult would have enough strength to release it and a child wouldn't. However, there probably are a lot of kids in their early teens that would have the strength to release that particular one. There is another one that uses a plastic band that wraps through the gun around the hammer, the plastic band could easily be cut. Master Lock has one, one key can work on all the locks, you can buy those at K-Mart or Zayres. A number of the locks simply lock up the trigger, they don't do anything with the rest of the mechanism with the hammer. There are many different kinds. In fact, they do not fit and there are not those available to fit 100 percent of the firearms that are available. So, we are talking about a portion, maybe about 80 percent of the guns that are sold. Companies that include locks with their guns admit that the gun should not be locked at all times, that they would be part of a comprehensive way of securing your firearms. For example, if I was keeping a firearm in my house for my personal protection, I probably wouldn't want to have it locked because if I needed it, I wouldn't want to have it locked in those circumstances. There are circumstances under which many people agree that you just wouldn't lock it. Again, it would only be used perhaps a certain amount

The bill also requires only registered firearms dealers to sell these locks. That is what Amendment "A" requires, registered firearms dealers to sell these. In fact, the large majority of firearms sales are casual sales and not through registered firearms dealers.

The other amendment requires a brochure from a nationally organized non-profit organization to be distributed. I have concerns over our putting into law that a brochure should be distributed over which we have absolutely no control or review. We might feel comfortable with the brochure today, but it might change in a way that we don't feel comfortable having it represent a comprehensive policy. I am not comfortable with the alternative which would be "B" to distribute the brochure because, under the current circumstances, the financial difficulties the state is under is in no position to create its own brochure so it would have to rely on another organization's brochure and I question whether that should be a part

of state policy.

Just to sum up, we are talking about a bill that will require some trigger locking devices which would be for use part of the time on part of the firearms which are a fraction of all the sales or we would like to have a brochure distributed over which we have absolutely no control over the contents of that brochure, now or in the future. That is why I hope that you will join me in indefinitely postponing this bill.

The SPEAKER: The Chair recognizes Representative from Kittery, Representative Lawrence.

Representative LAWRENCE: Mr. Speaker, Men and Women of the House: I hope you will vote against this motion to indefinitely postpone this bill and

all its accompanying papers.

This bill is a fairly innocuous bill and I am surprised it has raised the hackles of so many people that it has. All this bill requires is that a person selling firearms, a firearm dealer, sell a trigger lock with the firearm, a fairly inexpensive device. It is analogous to back when seat belts weren't included on automobiles. Now we require seat belts It doesn't mean that be sold on automobiles. everybody has to wear a seat belt but the probability of someone wearing a seat belt increases when a seat belt is in the car. Similarly, the probability that someone is going to use a safety device on a firearm increases when they own a safety device on a firearm. If they don't own a safety device on a firearm, they aren't going to use one. All this bill does is try to get safety devices in the hands of people owning firearms.

I hope you will vote against the motion to

indefinitely postpone.

SPEAKER: The Chair recognizes The

Representative from Standish, Representative Greenlaw.
Representative GREENLAW: Mr. Speaker, Ladies and Gentlemen of the House: I don't speak very often but I am going to address this one subject for one second. This safety device, so-called, if it is attempted to be installed in a loaded gun, it may cause a loaded gun to go off because you have to push the trigger ahead. As I stated before, no one in Maine ever got shot with a loaded gun, so I think you should consider this before we mandate the using of what could be a dangerous addition to a firearm.

SPEAKER: The Chair recognizes The Representative from Winthrop, Representative Norton.
Representative NORTON: Mr. Speaker, Members of

the House: This is a bill intended to recognize safety. I am only 58, I am not sensitive about it but I mention it because I have been around weapons all my life. I am not now an active hunter but my family has been engaged in that sport for years and I have participated. I had never seen a trigger locking device until one of the dealers in my town where I live showed it to me. I thought it was a good idea because a constituent had mentioned it to me, a life long member of the NRA, a real sportsman, and he had acquainted me with the notion. I went in and looked at one and bought one for my shotgun I

have at home. I didn't buy that to attempt to lock a loaded weapon. No bill can make up for stupidity.

I was trying to send and the constituent that suggested this bill was trying to send a message of safety, nothing more nothing, nothing less. As far as the statistics not being overwhelming, five children in the last 18 months have died as a result

of playing with guns.

Two companies have put forth trigger locking devices because they feel it will forsake or forestall potential lawsuits. Again, we get too complicated.

I believe the essence of this bill is simple safety. It will not address elements devoid of common sense. It isn't a big step (as the Kennebec Journal said) in supporting this bill. It is not a big step but it is a step in the direction of safety and calling attention to the danger of the safe storage of weapons or the holding of weapons in one's home.

I feel safer in my home for two reasons - should someone get in my closet, they would only find an unloaded weapon, the shells are stored elsewhere, sometimes I have a hard time finding them for I don't use that weapon much now. I can't use it when my wife is home because she won't let me shoot woodchucks and that's what the intent was for having the gun in the closet. I have visitors and they do go in the closet, they have no concern whatsoever, that gun will not go off, it is a real perfection of a device. It interlocks just like a car door locks, one section into the other. I feel it is sending a message of safety to me. I feel that message would

be sent to other people.

I have voted on this floor against any form of gun control. I do not consider this a matter of gun control. Gun control will only protect those who are already legal because most gun control measures are violated by the outlaws to begin with. This is not that kind of a bill. I make the case to this point, I feel debate should be heard because there are other amendments to this bill and, therefore, I urge you tonight to vote against the impending motion.

The SPEAKER: The Chair recognizes Representative from Sabattus, Representative Stevens.

Representative STEVENS: Mr. Speaker, Men and Women of the House: I voted on the "A" Amendment here for the simple reason this gives one more opportunity to have a safety device on a new weapon when it is purchased in the hands of people in their homes in case they did need one. It is not a mandate that you have to use it but it is there in case you want it.

The SPEAKER: The pending question before the House is the motion of Representative Daggett of Augusta to indefinitely postpone the Bill and all accompanying papers. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

52 having voted in the affirmative and 69 in the negative, the motion to indefinitely postpone did not prevail.

Representative Plourde of Biddeford requested a vote on acceptance of Report "A."

The SPEAKER: The pending question before the House is the motion of Representative Lawrence of Kittery that the House accept Report "A." Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken. 52 having voted in the affirmative and 73 in the negative, the motion to accept Report "A" did not prevail.

Bill "An Act to Protect Children from Illegal Tobacco Sales" (S.P. 506) (L.D. 1344)

(Committee on Legal Affairs suggested)

In Senate, Referred to Committee on Business Legislation. TABLED - April 16, 1991 (Till Later Today) by

Representative GWADOSKY of Fairfield. PENDING - Reference in concurrence.

Representative Sheltra of Biddeford moved that the Bill be referred to the Committee on Business Legislation in concurrence.

The SPEAKER: The Chair recognizes the Representative from Kittery, Representative Lawrence. Representative LAWRENCE: Mr. Speaker, I ask for

Mr. Speaker, Ladies and Gentlemen of the House: I really don't like speaking to this body on a reference fight but this is a serious bill. It makes a dramatic change in the policy of this state. It would require that people selling tobacco be licensed and that license be issued by the Liquor Commission and that the Bureau of Alcoholic Beverages be expanded to enforce the licensing procedure.

One section of this bill deals with vending machines that would outlaw the sale of cigarettes in

vending machines. The Legal Affairs Committee deals with all matters dealing with the Liquor Commission. The Legal Affairs Committee deals with the drug policy of this state, it deals with the Liquor Commission, it deals with the Bureau of Alcoholic Beverages. If this bill was referred to the Committee on Business Legislation, it would in effect split the Bureau of Alcoholic Beverages between the Committee on Business Legislation and the Committee on Legal Affairs. I would request your support in defeating this motion to refer it to the Committee on Business Legislation so that we can refer it to the Committee on Legal Affairs.

The SPEAKER: Chair The recognizes Representative from Biddeford, Representative Sheltra.
Representative SHELTRA: Mr. Speaker, Ladies and Gentlemen of the House: This bill came before this last session, the 114th, and the Committee on Reference of Bills at that point in time did refer it to Business Legislation. It is the identical title that it had in the prior session, with the very same Statement of Fact. The question being, as far as the Bureau of Alcoholic Beverage is concerned, this is a matter whereby we will have enforcement. We are actually dealing with children. This bill is a child health protection measure. All of you have heard the important statistics about kids and cigarettes. Twenty-three percent of Maine high school students are addicted to tobacco by the time they graduate. 90 percent of all smokers became addicted before the age of 18, the legal age of purchase in Maine. These statistics are clear proof that our current law which plainly prohibits tobacco sales to children under the age of 18 is just not being enforced. That is why this bill is before you, to create a mechanism for enforcing the law this legislature passed several years ago to protect the health of the children.

Actually what we did last session, we came through as far as vending machines were concerned that they had to be conspicuous in the establishments.

that they had to be conspicuous in the establishments whereby they might be housed and this bill deals with doing away with the vending machines entirely.

If we were to take in hand every bill that comes in here before us, if we were to dissect it and try to figure out as to what committee it should go before, we would be writing paper here until next Christmas. Where we have handled this bill before, we have done a good job, we would like to have it referred to our comments set everything straight.

CDEAKER: The Chair referred to our committee once again so that we can

recognizes the Representative from Kittery, Representative Lawrence.

Representative LAWRENCE: Mr. Speaker, Ladies and Gentlemen of the House: This bill was referred to the Committee on Business Legislation two years ago. It was sponsored by the Chair of the Committee on Business Legislation. Why it got referred to the Business Legislation Committee, I do not know. I was not Chair of Legal Affairs at that time but no legislature is bound to repeat its mistakes every two years. 97 percent of this bill that is 20 pages long, only one paragraph deals with vending machines, the entire rest of the bill deals with the Liquor Commission and the Bureau of Alcoholic Beverages.

The Representative from Biddeford spoke highly about what we should do about tobacco sales but I will remind you that the Business Legislation Committee killed this bill last year. The tobacco industry is lobbying heavily to have this bill go to the Business Legislation Committee again this year. This bill rightfully belongs in the Committee on Legal Affairs where we can look at the drug policy of this state and where we can look at the effects of this bill on the Liquor Commission and the Bureau of Alcoholic Beverages.

The SPEAKEŘ: The Chair recognizes Representative from Houlton, Representative Graham.

Representative GRAHAM: Mr. Speaker, Men and Women of the House: Before we get too carried away, let's relax a little bit, take a breath on this one, the world won't come crashing down, regardless of which committee gets this bill. Although my committee, Business Legislation, killed this bill last time, I don't think that is going to happen again this time. Last time we asked that vending machines be placed in the direct supervision of persons where those vending machines were. That is not being carried out and it is highly likely that we will be looking at banning vending machines altogether.

Also, the aspect of licensure of tobacco sales has always been the purview of the Committee on Business Legislation. As a matter of fact, we do it for 42 professions, including M.D.'s, Osteopaths, chiropractors, electricians, plumbers, beauticians, maybe aestheticists before we are through this year. Quite frankly, I think that if we can deal with those issues of health and safety of the consumer, I think we can deal with this one as well.

However, we must recognize that committees sometimes have overlapping jurisdiction. Usually where there is overlapping jurisdiction, we tend to go along with the committee on reference and go with recommendation because where there overlapping jurisdiction, we recognize committees all have a certain amount of expertise and that none of them will cause great harm if we allow them to work on a bill.

Although this has been referred to the Committee on Legal Affairs, it has always been a bill that came to Business Legislation, it should continue to do so because of one important factor, we have dealt with the bill, we have dealt with the parties involved, we have the legislative memory on this one, we tried last year to deal with this in a rational manner, we took the word of people on this bill and they were not carried out. We are in no mood this year to kill this bill, I can guarantee you. The bill needs modification to make it acceptable and I think the modifications that would be made would be the same modifications whether it is the Legal Affairs Committee or Business Legislation because I think we see eye to eye.

I would much prefer, if you would, please, refer this bill to the Committee on Business Legislation, but if you choose to send it to the Committee on Legal Affairs, it is not going to be a big deal.
The SPEAKER: The Chair recognizes

Representative from Saco, Representative Nadeau.

Representative NADEAU: Mr. Speaker, Men and Women of the House: The previous speaker alluded to the fact that his advice to you is, when in doubt, let's go with the recommendation of the Committee on Reference of Bills. I might point out to you that in the printing of this item, the Committee on Reference suggested the Committee on Legal Affairs.

I also reiterate the fact that an error that might have been created in the past does not necessarily have to be recreated presently or in the future. Those are the two points that I wish to bring. The comment, when in doubt, let's go with the Committee on Reference's suggestion, and the second is, if, in fact, we might have made an error two years ago, why do we have to repeat it?

The SPEAKER: The Chair recognizes

Representative from Portland, Representative Manning. Representative MANNING: Mr. Speaker, Ladies and Gentlemen of the House: The way the Representative from Biddeford described it, it really should be going to Human Resources. We are the ones who protect the children of this state. I don't think it is the business community who is really protecting it but I have got to go along with my colleague from Kittery and say that that is the area that I think it should be going to. Although when it first came out people said, shouldn't we be dealing with it? said, no, I think when you look at this bill, really deals with liquor enforcement and I think that is the area that that bill should go to.

I would hope you would follow Representative Lawrence's light and put this in the Committee on Legal Affairs.
