Re: Reestablishment of the Commission's Jurisdiction in Brighton Plantation

Dear Speaker Martin, President Dutremble, Senate Chair and House Chair:

Please find enclosed a copy of a rule, entitled "Chapter 17; Reestablishment of Commission Jurisdiction" which was adopted on July 30, 1992 by the Maine Land Use Regulation Commission. The effect of this rule is to reestablish the jurisdiction of the Maine Land Use Regulation Commission in Brighton Plantation, a plantation which is not a municipality and has no local land use program.

By way of background, Brighton Plantation, located in Somerset County, assumed local land use control in 1990 after approval of a local Comprehensive Land Use Plan and Zoning Ordinance by the Maine Land Use Regulation Commission and Town voters, in accordance with land use regulation law, 12 MRSA, section 685-A(4). In March of 1992, the Plantation abolished its Planning Board and voted to return to the jurisdiction of the Commission. It reaffirmed its earlier decision in May of 1992.

In addition, 12 MRSA, section 685-A(4) provides that the Commission reestablish its jurisdiction in a community that was at one time within the Commission's jurisdiction, but which abolishes its administrative bodies and no longer administers its comprehensive land use plan and related land use ordinances.

This rule reestablishes Commission jurisdiction in Brighton Plantation, as provided by 12 MRSA, section 685-A(4). Because Brighton Plantation has abolished its Planning Board, development and other land use permits could not be issued by the Plantation nor could other land use functions be performed. Reestablishment of Commission jurisdiction within Brighton Plantation will provide for continued land use planning, development permit review and land use enforcement for the Plantation. The reestablishment of Commission jurisdiction in Brighton Plantation meets the legislative purposes of applying sound planning, zoning and subdivision control to the unorganized and deorganized townships of the State; to preserve public health, safety and general welfare; to prevent inappropriate residential, recreational, commercial and industrial uses detrimental to the proper use or value of these areas; to prevent the intermixing of incompatible industrial, commercial, residential and recreational activities; to provide for appropriate residential, recreational, commercial and industrial uses; to prevent the development in these areas of substandard structures or structures located unduly proximate to waters or roads; to prevent the despoliation, pollution and inappropriate use of the water in these areas; and to preserve ecological and natural values.

12 M.R.S.A., section 685-A(4), specifies that action taken by the Commission to reestablish its jurisdiction over a plantation or municipality shall be effective immediately, but shall be submitted to the current or next regular session of the Legislature for approval. If the Legislature fails to act, the action shall continue in effect.

This submission is to fulfill the Commission's obligation under 12 MRSA, section 685-A(4).

Emergency Measure

An Act to Make Supplemental Appropriations for the Expenditures of State Government for the Fiscal Year Ending June 30, 1993 (H.P. 17) (L.D. 18)

Was reported by the Committee on **Engrossed Bills** as truly and strictly engrossed.

The SPEAKER: The Chair recognizes the Representative from Fairfield, Representative Gwadosky.

Representative GWADOSKY: Mr. Speaker, Ladies and Gentlemen of the House: Before we enact this bill, I just want to put on the Record a couple of the concerns that have been expressed by members of the Democratic caucus as we proceed with this item. We fully expect to support this issue. Our concern is the importance that those state employees at the Augusta Mental Health Institute and Bangor Mental Health Institute receive their paychecks for work that they have provided for the last couple of weeks and that there also be some funds available for the next payroll period beyond that. That's paramount and our concern is that we make money available. We know that if we don't take action today, those employees will not receive their checks this week.

Secondly, we have been assured that the funds being made available are not going to, in any way, harm those clients or services within the mental health community and that is critical as we progress from this point on.

The past couple of years have been difficult to say the least and we can fully expect the next two years to be very similar in terms of the depth of the budget and the impact upon people. We are fortunate today that the funds that are being utilized are not going to impact on people or services. We won't have that luxury in the next six months when we begin the biennial budget because those will be affecting people and services across this state.

I have been very much impressed by the willingness of both parties to work together. They have come here this year working hand in hand to work cooperatively on the issues that confront us. We know that in order to meet the challenges that we are going to have to rise perhaps to a new level of cooperation between parties. We know that individually and collectively that we have philosophical differences but I sense a willingness to set those aside, to do the business of the people of this great state, and to tackle the many problems that confront us. In that element, it is also going to be critical for the Governor of this state and the Administration to fully engage and come to the table as an active participant in this process and that is a process that will begin on Friday with the submission of our biennial budget for the next two years.

We have had two circumstances so far during this session, the first dealing with the transfer of funds from the University and the second dealing with the ability to make payroll checks at AMHI. I think the communication through the Administration to this Legislative Branch has been less than ideal. I think communication between the Administration and members of Democratic and Republican leadership has been less than ideal. I know the communication with Appropriations, Democratic and Republicans, has been less than ideal. We would like to think that those events and those instances are not going to be the standard. In fact, we need to insist upon taking a proactive stance as we begin to deal with this budget over the next two years. We cannot continue to do business the way we have done business today and the way we have done business on our opening day when we transferred those funds. There needs to be a greater sense of cooperation and communication between the Legislative Branch and the Executive Branch, if indeed that is going to happen. We need to ensure that the budget we deal with on Friday that we receive that budget with a commitment from the Administration, that they are going to be active participants in this process. That is something that I hope we can receive and ensure that that is going to be a realistic budget. Many members of our caucus were concerned at the thought of dipping into community-based monies when in fact the whole direction we have taken in mental health in the last couple of years has been to shift towards a community-based setting.

The budget we passed in 1991-1992 envisioned savings in the amount of \$3.8 million by shifting towards the community-based setting. We know now, tragically, that we are not going to realize those savings and for a variety of reasons. Appropriations had a very enlightening discussion about — Democrats and Republicans have shared their concerns as to why we haven't moved more quickly in the areas of a community-based setting for mental health. They discussed the issues of Certificate of Need and what they can do to create an accelerated process and where we need to go from here prospectively.

I have been very impressed by the working relationship I have seen between Democrats and Republicans, rank-and-file members, and leadership to deal with this circumstance, the bill we had previously dealing with the borrowing at the University of Maine and I am encouraged that we will continue that working relationship when we receive the Governor's budget for the next two years on Friday.

I hope that we all insist that the Administration be an active participant in that process and I hope that we also insist that that budget will be a realistic budget and will attempt to meet the needs of Maine people for the next two years. The Governor will be providing us with a budget that doesn't include the temporary taxes and I think that is a goal we should all strive for but that goal can only be met if that budget is put together realistically. We want to ensure the types of things we have seen in these first two instances are not repeated. As we move into a more proactive approach, opening up the Appropriations process, taking a longer term view, reaching an earlier consensus on revenues as a collective body of legislators, let's insist upon the active participation of this Administration to work with us as an equal partner in solving the problems and meeting the goals and needs of Maine people.

With that being said, I hope that you will support this document. I can only express the frustration of members of my caucus. As I talked with some Republican legislators, they are equally frustrated at being pushed to vote yes or no to deny somebody their paychecks for work they have already done because we weren't able to get this information to us in a manner in which we could present it over a longer term view in a timely fashion. No one likes to be put in that position and frankly no one should be put in that position. It is not the way to do business. We can change the process if you and I have the willingness to do that. I would urge you to do just that.

With that said, I hope you will indeed vote to enact this measure today so we can be ensured that those state employees who have worked so hard for us under some terrible conditions within the areas of mental health receive the payments they deserve.

The SPEAKER: The Chair recognizes the Representative from Waldo, Representative Whitcomb.

Representative WHITCOMB: Mr. Speaker, Ladies and Gentlemen of the House: I want to concur with the Representative from Fairfield in regard to his comments that stressed the importance of us working together under an immense problem that we will be facing over the next six months.

I think today, although it had some rocky edges, some rough edges, a rocky beginning, we did prove that we can do what we have to do as a legislature and that is to come up with a bipartisan solution to a difficult problem. I want to commend this body for being on the verge of taking that action. I want to being on the verge of taking that action. I want to commend Democratic leaders and other Republican leaders who worked together late last night to identify what we thought would be some difficulties between the two caucuses, to remove those difficulties and to come up with an interim solution recognizing that the tiny part of the problem we have been dealing with today will be immersed in an immense problem we will be exposed to on Friday.

Obviously, we have to expect full communication with the Executive Branch but we as legislators have a job to do after the budget document is given to us and I look forward to working with all of you in a bipartisan way to come up with some mutually acceptable solution.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative DiPietro.

Representative DIPIETRO: Mr. Speaker, may I ask a question?

Mr. Speaker, is this the tone that the session is going to have this year, that we stand here our first day with a gun to our heads to vote on a bill either yes or no?

Is this what the rest of the session is going to

be like, if you can possibly answer my question? The SPEAKER: The Chair has many ways he could answer the question. I made comments at the Democratic caucus, which I do not believe need to be repeated to you.

I certainly concur with the remarks of both Majority and Minority Leaders that total cooperation through this session. That cooperation requires the cooperation of the Administration and everyone in every single department at all levels of this government.

This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken. 133 voted in favor of the same and 6 against and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

By unanimous consent, ordered sent forthwith to the Senate.
