The Findings of Fact and Opinion on the appeal of Clayton L. Fowlie from the results of the election in House District 82 did not accurately state the difference in the views of the members of the Commission who voted in favor of the motion to deny that appeal (February 3, 1993, p. 3, final paragraph). To clarify, some members believe that Mr. Fowlie did present evidence that the knowledge of the special absentee voting place gave Mrs. Melendy an unfair advantage. But they feel that this unfairness does not provide sufficient grounds to recommend a special election in District 82, and so voted with the majority to deny Mr. Fowlie's appeal.

Please attach this letter to our February 3, 1993 report so it is fully consistent with the transcript of our January 28, 1993 hearing.
