I am transmitting herewith an initiative entitled "An Act to Impose Term Limitations on State Legislators and Officers," and the results of the examination by this office of the initiative relative to it.

The minimum number of valid signatures required to initiate this legislation is 52,308. These petitions were filed in this office on January 13, 1993 which met the requirement of the Maine Constitution. After extensive review we have determined the number of valid signatures is 88,297.

In view of the foregoing determination, I hereby certify that these petitions have met the constitutional requirement of the minimum of 52,308 valid signatures. Since these petitions have previously satisfied the constitutional requirements in all respects, under the provisions of Article IV, Part Third, Section 18, of the Constitution of Maine, I do hereby declare this initiative petition to be valid.

In the event the Legislature rejects this initiative proposal, a referendum election will be called.
