#### JOINT RESOLUTION MEMORIALIZING THE PRESIDENT AND THE CONGRESS OF THE UNITED STATES TO ENACT EMERGENCY LEGISLATION WAIVING UNFUNDED FEDERAL MANDATES THAT HAVE BEEN IMPOSED ON THE SEVERAL STATES OR THEIR POLITICAL SUBDIVISIONS

WE, your Memorialists, the Members of the One Hundred and Sixteenth Legislature of the State of Maine, now assembled in the First Regular Session, most respectfully present and petition the President and the Congress of the United States, as follows:

WHEREAS, the Federal Government has mandated new programs and transferred the responsibility of funding these programs to the several states and their political subdivisions; and

WHEREAS, the Federal Government has also reduced or eliminated funding for certain programs administered at the state or local government level; and

WHEREAS, the several states and their political subdivisions, as a result of economic recession and the substantial costs of these programs are experiencing severe revenue shortfalls and budget imbalances that are further exacerbated by having to fund these unfunded federal mandates; and

WHEREAS, the several states, unlike the Federal

Government, are required by their constitutions to balance their budgets, which further reduces their ability to absorb unfunded federal mandates; and

WHEREAS, the State of Maine, recognizing the inequity of passing unfunded mandates on to its political subdivisions amended its Constitution in November of 1992 to prohibit state legislation or state administrative rules that require additional local government expenditures unless the Maine State Legislature funds those mandates; and

WHEREAS, the federal practice of deferring program costs to the states is inherently unfair because many states, such as Maine, lack the resources to fund these programs; and

WHEREAS, relief from unfunded mandates is most especially needed in the federal laws and rules governing benefits and utilization for Medicaid recipients, benefit levels for other entitlements and environmental regulation so that the several states and their political subdivisions can regain greater authority over their respective budgets and increase their ability to create jobs; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully recommend and urge the Congress of the United States to enact legislation that provides waivers to unfunded federal mandates, be they wholly or partially unfunded; and be it further

RESOLVED: That this legislation direct the various agencies of the Federal Government to streamline the process by which federal mandates will be waived; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the Honorable William J. Clinton, President of the United States, to the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States, to the governor of each state, the Speaker of the Lower House and the President of the Senate in each state and to each Member of the Maine Congressional Delegation.

House Order Propounding Questions to the Justices of the Supreme Judicial Court

WHEREAS, it appears to the House of Representatives of the 116th Legislature that the following are important questions of law and that this is a solemn occasion; and

WHEREAS, the Constitution of Maine, Article VI, Section 3, provides for the Justices of the Supreme Judicial Court to render their opinion on these questions; and

WHEREAS, there is now before the 116th Legislature for its consideration Initiated Bill 1, Legislative Document 751, "An Act to Impose Term Limitations on Legislators, Constitutional Officers and the State Auditor"; and

WHEREAS, that bill has been submitted to the Legislature as a result of a petition for direct initiative of legislation pursuant to the Constitution of Maine, Article IV, Part Third, Section 18; and

WHEREAS, that bill may have constitutional infirmities that can not be corrected by revision or amendment; and

WHEREAS, it is important that the Legislature be informed as to the questions raised in this order; now, therefore, be it

Ordered, that in accordance with the provisions of the Constitution of Maine, the House of Representatives respectfully requests the Justices of the Supreme Judicial Court to give the House of Representatives their opinion on the following questions of law:

Question No. 1. If Legislative Document 751 becomes law, would its limitations on the terms of Legislators be valid in light of the lack of those limitations in the Constitution of Maine, Article IV, Parts First and Second? Question No. 2. If Legislative Document 751 becomes law, would its limitations on the terms of the Secretary of State, Treasurer of State and Attorney General be valid in light of the lack of those limitations in the Constitution of Maine, Article V, Parts Second and Third and Article IX, Section 11?

Question No. 3. If the answer to question 1 or 2 is negative, must the initiative nevertheless be submitted in its current form to the voters at referendum pursuant to the Constitution of Maine, Article IV, Part Third, Section 18?

Was read.

This gets to be a very complex issue with the Public Advocate in the residual market and Workers' Compensation. It took me a little bit of education to understand it myself.

Basically, what the Public Advocate is going to do here is it is going to increase what they get from the NCCI, which is some kind of an assessment firm. They are going to get an increase of \$50,000 to help them get a case for setting the rates for Fresh Start, which is the Workers' Compensation deficit in the years, 1988, 1989, 1990, 1991 and 1992, and the employers and the insurance companies will share 50/50 in those deficits.

A previous member of the body felt that the argument was that the insurance companies and the Public Advocate, who said that he represented employers, is going after the same end argument and that is that insurance companies and employers or the Public Advocate who represents the employers wants to keep that deficit as low as possible and wants to keep that assessment as low as possible and he felt that this was a duplication of a procedure that needs not to be done and that the funding should not be allowed. I wanted to present that argument on his behalf.

The SPEAKER: The Chair recognizes the Representative from Jay, Representative Pineau.

Representative PINEAU: Mr. Speaker, Ladies and Gentlemen of the House: Part of the Blue Ribbon Commission bill of the 115th adopted last year did, in a big way, take away a lot of the funds and the interaction the Public Advocate's Office could have on rate filings and Fresh Start proceedings on these hearings coming up to deal with the deficit that the good Representative Kutasi just mentioned. What we have done in this bill is that we have

What we have done in this bill is that we have increased the money on insurance assessment so that Maine employers will be properly represented at the Fresh Start filing. With the last Fresh Start filing, there was a \$40 million amount that the Superintendent of Insurance did not grant the insurers because of (in part) some of the work the Public Advocate's Office had done.

If we do not do this and do not do this by an emergency, we are going to be putting Maine employers at the hands of the NCCI in dealing with these Fresh Start proceedings because the Public Advocate's Office doesn't have what it needs to come in and argue for the employers.

I ask you to vote with the Majority "Ought to Pass" Report, and Mr. Speaker, I ask for the yeas and nays.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.
