The SPEAKER: The Chair recognizes the Representative from Buxton, Representative Libby. Representative LIBBY: Mr. Speaker, Men and Women

of the House: I didn't have a chance to come in here and speak to you during your Democratic caucus because I was in my Republican caucus so I couldn't be two places at once - I really wish I could.

I think this issue comes down to an issue of priorities. I want to speak to you about it just for a moment.

Does the state need to pay for mediation? That is the question that we are discussing today, doos the state need to pay for mediation? Should it? No one argues that mediation doesn't work, it definitely works. It is a fantastic method to resolve disputes, that is not in question here at all. Mediation is a service and it certainly provides a benefit to those parties that are seeking mediation, but I believe those parties should split the cost, share the payment for those services and benefits. already have been for the past year. They

Passage of this proposal would change the way we are not funding mediation at the current time. The parties are currently splitting the cost for mediation, I want you to know that. There has been no noticeable drop in mediation

cases since the parties have been asked to split the cost of mediation. I am a former member of the Maine Labor Relations Board, which some of you people know, and I have been on the board for the last two years. I have spoken to some people on the board, they concur there has been no change at all in the mediation cases since the two parties involved have been asked to pick up the cost.

Second, I believe that if this bill was in front of the Appropriations Committee today (this is my opinion now) with a price tag of \$43,000, I don't think it would get by. That is just my opinion. The state has not been paying for this service.

Should we pick up the tab now? Should we pick up the tab after this legislature has asked me to vote, for instance, to reduce payments to AFDC recipients or lower outlays to those in need of mental health services? No, I just can't accept these kinds of priorities and it would be impossible for me to vote that way.

I hope that some of the members of the House will feel the same way that I do.

Locally, I think there are some great built-in incentives to the current method of the parties splitting the cost. When the mediation shows up on a local budget instead of a state budget, the local people fight to keep the mediation costs down or they even push to avoid mediation, arbitration or court costs altogether. It is another good reason I think to settle labor negotiations and avoid mediation, arbitration, etcetera.

Mediation works but the payment mechanism that we are asking for in this bill does not. It is my hope that you will say no to more needless state spending. Aren't those the decisions that we are supposed to be making here? There is no comfort in the fact that committee members voted a certain way on this bill. There is comfort in the fact that your vote will allow us to spend money somewhere else where it is needed for people that cannot afford services.

So, the question is, should the state begin to pick up this tab? I believe the answer is no. realize that I am going it alone on this particular one but I feel like I am in a pretty good position to say that, so I am asking for your support.

The SPEAKER: The Chair recognizes the Representative from Brewer, Representative Ruhlin. Representative RUHLIN: Mr. Speaker, Ladies and

Gentlemen of the House: Twelve members of the Labor Committee on a bipartisan basis felt it is the responsibility of the policy committees of this legislature to decide what is the best policy for the areas within the state, whether it be Labor, Public Utilities or Transportation. The Labor Committee deals with what is best to keep the social labor fabric of this state at peace, to continue, hopefully, the good feeling in labor. You do that by encouraging mediation.

We felt, as a committee, again both Republicans and Democrats, 12 out of 13 felt that they should be making the policy statement, a policy statement which has a long history of success in the State of Maine. That history has been that the state will <u>never</u> pay for all mediation unless it is very brief mediation, but it will start the first two or three sessions of mediation to encourage the two parties to come together at that table, to bring about that social peace that labor feels we need. That has worked. The number of cases over the years has remained somewhat constant. Over the years, the solution had a nice ratio of solutions to the number of cases.

What we have seen in the past two years is because of the stressed financial situation of this state, we have had cutbacks in the budget. When people look at services — the gentleman from Buxton was absolutely correct, I would rather not see this service than have a child go hungry. I would rather end this service than see the educational system cut back.

Of course, we have to establish priorities, that is what the whole chamber does together, they do it after the Appropriations Committee has made the recommendations. The Labor Committee's job is recommending to this legislature what good policy is in the field of labor. That is why we have made the recommendations that we have.

In the last two years, how has it worked? It is true the number of cases going to mediation has not increased or decreased but the key factor is, what about the solution? The successful conclusion to those mediations, and I hold because some of them have been delayed, are off 30 some odd percent. That nave been delayed, are off 30 some odd percent. That is the thing that you should be asking yourself. When you ask that question, I really feel that solutions, you will have to agree, are really what we should be looking for. We should be looking for a statement of policy. If this legislature passes this policy, it will be up to Appropriations and then again the full legislature to put a weight on that value. Is it going to be funded this year? I don't know. But, the committee of responsibility feels by a vote of 12 to 1 that it is our recommendation to you that the good labor policy in the State of Maine is to advocate the funding of this position.

The SPEAKER: The Chair recognizes the Representative from Poland, Representative Aikman.

Representative AIKMAN: Mr. Speaker, Ladies and Gentlemen of the House: This bill does restore funding for state provided mediation services under the Municipal Public Employees Relation Law. This restores state funding for only up to three days. The cost of any mediation beyond three days must be equally shared by the parties. During the 115th Legislative session, state

funding was eliminated for a number of services that were offered through the Maine Labor Relations Board. You have to remember that mediation is considered by all to be a very successful method for disputed resolutions.

I ask you to support the "Ought to Pass" Report.

The SPEAKER: The Chair recognizes Representative from Bethel, Representative Barth. the

Representative BARTH: Mr. Speaker, I would like to pose a question through the Chair.

Is there a fiscal note on this bill and how much would that be if anyone knows?

The SPEAKER: The Representative from Bethel, Representative Barth, has posed a question through

the Chair to anyone who may respond if they so desire. The Chair recognizes the Representative from Brewer, Representative Ruhlin.

Representative RUHLIN: Mr. Speaker, Ladies and Gentlemen of the House: I thank you for the question Representative Barth. There is a fiscal note, I don't have it right in front of me, but it is very close to \$44,000.

Excuse me, I have that fiscal note (it was another fiscal note that I was thinking about) --give me two minutes and I will get back to you with the right answer.

The SPEAKER: The Chair would advise the

Representative from Brewer, Representative Ruhlin, and members of the House that he is absolutely correct. The amount of money is \$43,570. Representative RUHLIN: Then I got that answer confused with another fiscal note I had before me a few minutes ago. I will go back to my original answer, around \$44,000. The SPEAKER:

Chair recognizes The the Representative from Mount Desert, Representative Zirnkilton.

Representative ZIRNKILTON: Mr. Speaker, you addressed my concerns with your answer.

The SPEAKER: The Chair will order a vote. The pending question before the House is the motion of

the Representative from Brewer, Representative Ruhlin, that the House accept the Majority "Ought to Pass" as Amended Report. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.
