# STATE OF MAINE COMMISSION ON GOVERNMENTAL ETHICS AND ELECTION PRACTICES

IN RE: APPEAL OF ELDEN MCKEEN, Election of House Representatives

FINDINGS OF FACT AND OPINION

District 35

On March 31, 1993, the Commission on Governmental Ethics and Election Practices ("Commission") held a hearing to consider the election appeal and request for investigation filed by Mr. Elden McKeen, concerning the election held on November 3, 1992 for the position of Representative from District 35 to the Maine House of Representatives. The following are the Commission's findings of fact and conclusions of law, and its recommendations concerning the election, pursuant to 21-A M.R.S.A. section 744.

Present at the hearing were Commission Chairman Robert P. McArthur, and Commission members Virginia Chamberlin, Gregory G. Cyr, Joseph B. Ezhaya, Richard G. Morton, Richard L. Trafton, Paul E. Violette and Peter B. Webster. Also present were the Executive

Director of the Commission, Marilyn E. Canavan and Commission counsel, Deputy Attorney General Cabanne Howard. Mr. McKeen was represented by Mr. James W. Case, Esquire. The respondent, Representative Gerald A. Hillock, was represented by Mr. Sumner H. Lipman, Esquire.

#### I. BALLOT COUNT

The parties stipulated, and the Commission finds, that at the election on November 3, 1992 in House District 35, Representative Hillock received 2,297 votes, Mr. McKeen received 2,294 votes (a difference of 3 votes) and 5 ballots were in dispute.

#### II. DISPUTED BALLOTS

With regard to the 5 disputed ballots, the Commission makes the following determinations:

- A. One voter in Windham placed a dot in between the arrows next to Mr. McKeen's name, and made no other mark in the box provided for House District 35. The Commission found, by a 6-2 vote, that the voter's action was insufficient to permit the Commission to determine his choice, and that this ballot should not be counted for either candidate. Commission Chairman McArthur, and Commission members Chamberlin, Cyr, Morton, Trafton, and Webster voted in favor of not counting this ballot, and Commission members Ezhaya and Violette voted in opposition.
- B. One voter in Westbrook placed an "X" in the box next to Mr. McKeen's name, and placed an extra "X" to the right of Mr. McKeen's name as well. The Commission voted unanimously to count this ballot for Mr. McKeen.
- C. One voter in Westbrook placed a mark in the box for Representative Hillock that was fainter than the other marks for other candidates on the same ballot. The Commission voted unanimously (Commission member Ezhaya absent) to count this ballot for Mr. Hillock.
- D. One voter in Westbrook apparently placed an "X" in the box for Mr. McKeen, then crossed out that mark, and wrote in the name "O'Gara, Bill" in the space for write-in candidates, but did not check the box provided for write-in votes. The Commission voted, by a 6-1 vote, with one member abstaining, not to count this ballot for either candidate. Commission Chairman McArthur, and Commission members Chamberlin, Ezhaya, Morton, Trafton, and Webster voting in favor, Commission member Cyr voting opposed, and Commission member Violette abstaining.
- E. One voter in Westbrook placed a mark on the edge of the box for Representative Hillock. The Commission voted unanimously to count this ballot for Mr. Hillock.

As a result of these determinations, the Commission found that the adjusted vote totals for the candidates were 2,299 votes for Representative Hillock, and 2,295 votes for Mr. McKeen (a difference of 4 votes).

#### III. CONTESTED ISSUES

The Commission then received documentary evidence and heard argument with regard to a single issue raised by Mr. McKeen with regard to the validity of the election. Essentially, Mr. McKeen contended that there was an undisputed discrepancy of 41 ballots between the number of ballots counted that had been cast for the candidates in House District 35 in precinct 3-2 of the city of Westbrook and the number of ballots cast in the same precinct in a local referendum. The Commission voted, by a 7-1 vote, that this alleged discrepancy was not a sufficient reason for finding that a violation of law affecting the outcome of the election, within the meaning of 21-A M.R.S.A, section 743(2), had occurred, and therefore denied Mr. McKeen's request that a new election be held. Commission Chairman McArthur, and Commission members Chamberlin, Ezhaya, Morton, Trafton, Violette, and Webster voting in favor, and Commission member Cyr voting opposed.

#### IV. RECOMMENDATION

In view of the foregoing determinations, the Commission recommends that the House of Representatives declare that Representatives declare that Representative Gerald A. Hillock was duly elected to represent District 35 in the Maine House of Representatives.

#### (Off Record Remarks)

Representative Aliberti of Lewiston was granted unanimous consent to address the House.

Representative ALIBERTI: Mr. Speaker, Men and Women of the House: I solicited this unanimous consent for a very, very special concern.

Approximately a month ago, I felt I could address a crisis and a critically identified need, the unfunded liability of the Maine Retirement System.

The options were limited, the need critical.

Two months ago, I began an in-depth movement to address this shortfall. I consulted a most respected legislator of the Minority Party. He offered some

encouragement and a willingness to help me.

Having addressed the preliminary concerns and naving addressed the preliminary concerns and satisfying an increased need for action, I solicited the approval of the Legislative Council for an after deadline approval of the legislation. This sensitive and fair body approved this request unanimously to activate this legislation for the standard and approved process of initiating this legislation. I am grateful to the council and their courteous fairness and unanimous approval.

This was just the beginning of a more complex process, one, I solicited and received the most professional and credible input of the executive personnel of the retirement system, namely Claude Perrier, Joe Gahagan and F.G. Nault, the Attorney General his staff associably Par Harlay

General, his staff, especially Pam Hawley.

Two, the Revisor's Office, which for nine years has been my favorite service organization of the Legislature. Revisor Dave Kennedy who has led this office in a traditional creditable and fair manner responded to my wishes and concerns with great and dedicated responsibility. He drafted the bill L.R. 2142, the Unfunded Liability of the Maine State Retirement System. This draft was superior and credibly accurate in defining my concerns for introducing this legislation. Then the unexpected surfaced, the constitutionality of the legislation.

I will have copies available of the draft legislation and the Attorney General's Office opinion

on the constitutional issue on request.

I deliberately delayed and put a "stop where you are" action.

My options:

1. Continue to activate this legislation, printing, reference, hearings etcetera, etcetera at additional specified costs.

2. Prepare this body for the constitutional

challenges of the courts at additional costs.

My decision again was "stop where your at." What messages have surfaced and prevailed by my intended legislation to address the Unfunded Liability of the Maine State Retirement System, one, the negative and irresponsible obligation to address the unfunded liability.

Two, the overall concern and responsibility of the unfunded obligation, the responsibility and concern of the legislature, the Maine State Retirement System, the Committee on Aging and Retirement and the Executive Branch that maintains the credibility and financial security of this unfunded commitment.

I also wish to thank Clerk Mayo for his advice and consent and Madeline Masselli of the Majority

Office for her stenographic services.

With that Mr. Speaker, there is no doubt what the message is, I will not pursue this legislation. At your request, you made quite a strong message to identify these areas where we could save the legislature a great deal of time and money. So, I very humbly suggest that you give me the opportunity to withdraw this legislation.

Representative Lemke of Westbrook was granted unanimous consent to address the House:

Representative LEMKE: Mr. Speaker, Men and Women of the House: Twenty-five years ago today, a hundred American cities burned with fires of anger and frustration and dismay because twenty-five years ago yesterday, Reverend Martin Luther King, Jr. was assassinated in Memphis.

Dr. King was a man of conscience and compassion and courage. He became in the 1950's and 1960's, which some of us can remember, unquestionably the great spokesman of his people but he was much more. He was the dreamer who forced us to confront the American nightmare and the dream was the American dream of equal justice for all, regardless of race, creed, gender or ethnic background.

Twenty-five years later, today, that dream remains unfulfilled but if an assassin's bullet killed the dreamer, the dream does endure, the work

continues.

On this awful anniversary, I ask the House of Representatives for a moment to remember Martin Luther King. Like his namesake 500 years earlier, he took a stand, actually several stands, and was indeed a most controversial person. Indeed, nearly 20 years after his death, Martin Luther King remains so controversial that debate on this floor regarded that lingering sense of controversy. There may be those who still question Dr. King's specific politics, but I would hope there are none who question his contribution to America, because in a time when others reach for the gun and the bomb, Martin Luther King preached peace and non-violent resolution of issues. For that, I hope we may all quietly today honor Martin Luther King Jr..
