Representative from Norway, Representative Bennett.
Representative BENNETT: Mr. Speaker, Friends and Colleagues of the House: This bill would require a reelected governor to repost and the legislature to reconfirm all continuing cabinet members for the second term. This bill would not apply to the current governor and his cabinet.

Those of us who opposed this bill in committee believe that when a governor is reelected, his or her election is properly considered a referendum of approval for that governor's policies, programs and personnel. I urge you, if you share this view, to vote against the enactment of this bill.

I request a Division.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Joseph.

Representative JOSEPH: Mr. Speaker, Men and Women of the House: L.D. 282 was a Majority Report out of the State and Local Government Committee, a 9 to 4 report with three members of this body objecting.

The Representative is correct that in fact, as a governor is reelected, the commissioners that were nominated and confirmed in the first term if they were still serving and renominated, they would have to be confirmed. It was the feeling of the committee, upon listening to all of the testimony before the committee, that this would be a check and balance. All of us that have watched state government have recognized that when commissioners are carried on from one term to another term to another term often are not accountable and often newer legislators are not familiar with their role.

It is the feeling of the committee as well is, why not confirmation? Why should confirmation be a

process to fear rather than a process that would enlighten and provide legislators with the policies in that particular department or agency? I would urge you to vote for enactment of L.D. 282.

The SPEAKER: The Chair will order a vote. The pending question before the House is passage to be enacted. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

SPEAKER: The Chair recognizes Representative from Norway, Representative Bennett.

Representative BENNETT: Mr. Speaker, Friends and Colleagues of the House: I move that this bill and all its accompanying papers be indefinitely postponed. Some of you may recall my proposing an amendment a couple of weeks ago to this bill that would establish a commission to take a comprehensive look

at establishing limitations for a political activity

H-533

by members of all boards and all commissions in state government. You also may recall that that amendment was ruled not germane.

I am pleased tell to you today Representative Joseph has filed, and the Legislative Council has approved, a bill request to set up such a commission. I have, just a few minutes ago before the session, signed as a cosponsor to that bill because I think it is a much more cautious and considered approach. I hope you will join me in working to pass that bill, but the same reasons that argue for that bill, however, argue against the bill before us.

First, whenever we limit a citizens full and free participation in the political process, we ought to be extremely cautious. We are talking about individual's fundamental rights of political involvement.

Second, we are discussing volunteer members of part-time boards and commissions. It is often difficult to find people now (at times) to serve on these boards. We would be establishing more limitations and more difficulties to such service.

Third, it has been suggested that the Workers' Comp board is by its nature a fragile board. It has a special nature and the special nature of its issues demand a special sensitivity to political

participation by its members.

Well, there are 298 boards and commissions in state government that I know members of this body would find just as fragile and perhaps just as special in their sensitivity on issues, boards like the DEP, LURC, the Maine Labor Relations Board, the Maine Turnpike Authority, the State Harness Commission, the Commission on Governmental Ethics and Campaign Practices. If these restrictions are appropriate for the Workers' Comp Board, I believe they should be appropriate for all boards and commissions.

Fourth, this bill would not apply. Despite the proponents' argument that this is a fragile and special board, this bill would not apply to the current members of the Workers' Comp Board anyway. So, why the rush? Let us take the time and proceed judiciously. Let us use Representative Joseph's bill as a vehicle do what is right and do it in a cautious and considered manner. Let us do the wise thing and indefinitely postpone this bill and its papers.
I request the yeas and nays.

The SPEAKER: The Chair recognizes Representative from Waterville, Representative Joseph. Representative JOSEPH: Mr. Speaker, Men and Women of the House: I urge you to vote against the motion to indefinitely postpone this bill and all its accompanying papers. I do so because the issue before us is dealing with <u>one</u> board, actually the board of Workers' Compensation Commission — excuse me, the board that replaced the Workers' Compensation Commission. Just in those few words, you can tell that the role of this board is different from the advisory boards that are named throughout state government.

Because this board replaces the Workers' Comp Commission, because the 115th Legislature created a new system of Workers' Compensation and in fact this board has had difficulty in getting itself to work together — I was going to say something else, as you can tell — and I believe, and the majority of the committee believes that this committee, this board, should be immuned to the fray of political partisan

politics. Much has been said in the last decade in political campaigns about Workers' Compensation and the system that we have in this state. It is an inflammatory issue and this board has just begun its work. In an attempt to get a unanimous committee report, we did not have this legislation apply to the current board in that attempt to show that this is not directed toward any individual member of the current Workers' Compensation Board, then we believed that we would have this board immuned from politics and therefore not able to run for a statewide political office until the next set of nominees and persons were named to that board.

So, I would urge you to vote against the indefinite postponement of this piece of legislation.

The SPEAKER: The Chair recognizes the Representative from Limestone, Representative Young.

Representative YOUNG: Mr. Speaker, Ladies and Gentlemen of the House: I rise to ask that you support the motion to indefinitely postpone this bill

and all its accompanying papers.

Several weeks ago in the discussion regarding greyhound racing, I found very compelling Representative Daggett's argument. As a student of metaphysics, I have spent a great part of my life studying the problem of non-being and one of Representative Daggett's arguments was, you tread on certain, thin ontological ice when you start passing laws for problems that don't exist.

In addition to the reasons that Representative Bennett presented for voting to indefinitely postpone this bill, I would like to offer one further one. When the sponsor of this bill approached our committee he did claim, and I guess it is a certain matter of fact, that the Workers' Compensation Board is involved in a fray, so to speak. But, he also admitted that the fray they are involved in, the pressure they are involved in, is not political pressure.

I recognize that this board is different from all of the other boards and commissions that we have, but we are about to enact discriminatory legislation here which purports to solve a problem which no one has yet demonstrated exists. So, I would ask for your support and hope that you would vote in favor of the pending motion.

The SPEAKER: The Chair recognizes the Representative from Brewer, Representative Ruhlin. The SPEAKER:

Representative RUHLIN: Mr. Speaker, Ladies and Representative RUHLIN: Mr. Speaker, Ladies and Gentlemen of the House: I just want to share a few thoughts with you. During the reform of 1992, when this legislature in its wisdom established the Workers' Comp Board, we did so, I think collectively, to try to remove the Workers' Comp System in the State of Maine from the political process.

One of the great problems that we had through the years — I had a chance to watch it, I think it helped turn my hair a little white over the years is that you had many different parties appearing before the committees and before this legislature playing politics with the system. One would gain an advantage this session, the next session the opponent would have to come in and gain an advantage. Because of that, we never had a very durable and predictable Workers' Comp System. That was one of the problems. We are still living with the fallout from that problem.

So, in the wisdom of the 115th in its closing days it said, we will remove ourselves from the Workers' Comp business, we have not done well in the Workers' Comp business, let somebody else do it but let them be non-partisan.

As a person who advocated that position to the 115th and as a person who has observed very carefully the workings of this existing board, I say to you tonight that we have problems with that board. I think those problems are solvable. I hope I am not being the eternal optimist when I say they are solvable but I think they are. But, if politics does enter into that very critical board, which has a major impact economically and sociologically on all workers and all employers in the State of Maine, if workers and all employers in the State of Maine, if politics creep into that board — you think you had problems when we tried to manage it, you are going to have them multiplied many times. They key, the very essence of success to that board is those members on the board forgetting where they came from, that they are management's representative or that they are labor's representative, they should get to the point of saying, I am not Republican, I am not management, I am not a Democrat, I am not labor, I am there for the people to help a Workers' Comp System. To do that, they are going to have to be absolutely and totally non-partisan.

I ask you to support the reform movement that was made in 1992 and see to it that that particular delicate board that affects everybody in the State of Maine remains non-political.

The Chair recognizes The SPEAKER:

Representative from Norway, Representative Bennett.
Representative BENNETT: Mr. Speaker, Friends and Colleagues of the House: I will not disagree at all with the good Representative from Brewer, Representative Ruhlin. This board is significant, it is sensitive, it is fragile and if it is fragile at any point in its history it is fragile now, but this bill does not address the current board members, it addresses board members of the future.

I would contend that there is no harm in waiting until later this year so the next session we can come up with a comprehensive policy that covers all boards and commissions. Perhaps we will decide then that the Workers' Comp Board should be considered separately, maybe it's unique in some respect.

I think the amendment that was created could

just as easily apply to members of the DEP and LURC and all these other very important boards as well as the Workers' Comp Board.

I think it is good to have some consistency in state government. These are volunteers and when we ask volunteers to get involved, it would be nice to be able to tell them that all volunteer board members are under the same rules.

So, that is the goal I am seeking. I respect Representative Ruhlin and his point, it is very apt but there is no harm in waiting because this bill does not apply to current board members.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The pending question before the House is the motion of Representative Bennett of Norway that L.D. 9 and all it's accompanying papers be indefinitely postponed. Those in favor will vote

yes; those opposed will vote no.
