Dear Speaker Martin:

We are pleased to submit the sixth Single Audit of the State of Maine, covering the fiscal year ended June 30, 1992.

We conducted the audit pursuant to Title 5 MRSA, Chapter 11 which authorizes the State Department of Audit:

To perform a postaudit of all accounts and other financial records of the state government or any department or agency thereof, including the Judiciary and the Executive Department of the Governor, except the Governor's expense account, and to report annually on this audit, and at such other times as the Legislature may require.

The state expended \$1.054 billion in federal financial assistance. The audit was conducted to meet the requirements of the Single Audit Act of 1984, authorized under the United States Code, USC 31, Chapter 75 and the regulations established by the U.S. Office of Management and Budget (OMB) Circular A-128, "Audits of State and Local Governments."

The objectives of the audit were:

- To examine the state's financial statements and determine if they were presented fairly and in accordance with generally accepted accounting principles;
- To assess whether the state's systems and procedures for financial accounting, reporting and internal controls were adequate;
- To assess the state's accountability for revenues; to determine the propriety of

- expenditures, the extent to which funds have been expended in accordance with prescribed state and federal laws and regulations; and to examine the state's compliance with federal regulations pertaining to financial reports and claims for reimbursements; and
- To recommend corrective actions for any deficiencies noted; and to include management's responses to our findings and recommendations.

The State of Maine's accounting system and procedures, internal control, and compliance with rules and regulations have certain weaknesses which we have included in the following reports:

- Reports on Compliance and Internal Controls include those audit findings which, in our opinion, represent material weaknesses. There are two findings which identify material weaknesses in internal control; these can be found on pages 65 and 71; one that affects compliance with state laws and regulations is on page 94.
- Schedule of Reportable Conditions includes those audit findings which we consider to be reportable conditions under standards established by the American Institute of Certified Public Accountants. The fifteen reportable conditions begin on page 75.
- Schedule of Findings and Questioned Costs includes eighty findings which resulted from our review of the federal programs administered by the State of Maine. These findings begin on page 105.
- Management Letter includes one hundred audit findings designed to strengthen internal controls and operating efficiencies that affect many state agencies. These findings begin on page 189.

We again must render a qualified opinion on the state's financial statements because the state does not record certain accruals as required by generally accepted accounting principles.

In addition, we do not express an opinion on the General Fixed Assets Account Group (GFAAG) because the state's accounting records for GFAAG are incomplete.

I commend the staff of the Department of Audit, whose professionalism and dedication made the preparation of this report possible. Through our efforts, and the ongoing cooperation of the Maine Department of Administrative and Financial Services and other state agencies, we will continue to provide financial information that serves the needs of governmental decision makers, federal regulators, credit rating agencies, financial institutions and interested citizens of Maine.

We would be pleased to respond to any of your questions or comments about the 1992 Single Audit Report.

Land Use Regulation Commission member Robert Hazelwood's term expired on July 9, 1993, and he has continued to serve in that capacity. As you know, by law he can only serve 90 days beyond the expiration of his term unless I notify the Legislature of my findings that extension of a member's term beyond this period is in the best interest of the work of the Commission. Pursuant to 12 MRSA, Section 683, I hereby submit a formal notification of my intention to extend Mr. Hazelwood's term beyond October 9, 1993.

It is my intention to have a nominee posted for this position when the Legislature returns for the Second Regular Session in January. In the meantime, it is important that Robert Hazelwood continue to participate as a member of the Commission. The Commission has pending before it three applications for which public hearings have been held and which will be presented to the Commission for final decision within the next several months. SUBJECT: FY 94 Report of All School Administrative Unit State and Local Revenues

In accordance with 20-A MRSA, section 15618-A, a report of all school administrative unit state and local revenues designated in K-12 education in their FY 94 budgets has been compiled and a copy is provided for your use.

It should be noted that the amounts budgeted in the various categories may not be the same as actual expenditures for these categories, for the following reasons:

- Some budgeted amounts may be unexpended and carried forward to the following year. The statewide balance forward, for all budget categories, is usually between 2% and 3%.
- School administrative units which do not utilize a line-item budget may transfer funds to other categories.
- 3. For certain types of funds that are transferred between school administrative units (for tuition costs and for transportation and other services provided to another school administrative unit), the amount is budgeted in both school administrative units, since each unit must appropriate these funds. Since these instances cannot be netted out in the State Total Summary, the state totals will overestimate actual expenditures to some degree.

Dear Speaker Martin:

When the Legislature enacted significant revisions to Maine's hospital payment system in 1989, it directed the Commission to conduct a review of two of the newly enacted provisions, the special exception adjustment and the variable adjustment factor. This review was to be conducted after these new provisions had been in place for two payment year cycles. The second payment year cycle following the statutory implementation date for these two provisions was completed on September 30, 1993.

The Legislature also directed the Commission to submit a report on its review with any recommendations for changes to the special exception adjustment and the variable adjustment factor. Enclosed is a copy of the Commission's report and its recommendations.

On the basis of its review, the Commission is not recommending further changes to the special exception adjustment at this time. A 1991 statutory amendment supplied an important clarification of the provision and the Commission believes that it is otherwise meeting the objectives identified at the time of its enactment.

In contrast, the Commission's review of the variable adjustment factor has led it to the conclusion that the statutory upper and lower limits on the factor should be eliminated. The Commission believes that the retention of these limits will add to the cost of hospital services in a manner that is not consistent with the purposes of the variable adjustment factor. The Commission will be requesting that the Legislature modify the variable adjustment factor in the Second Regular Session in order to avoid this unintended consequence of the current statutory language.
