This was after a public hearing, work sessions, and compromise within the committee who worked with our legal counsel. It was a carefully carfted bill to exclude irrelevant materials. This bill will allow us to shed the light on the relevent and pertinent documents, the statements and testimony regarding what is described as Ballotgate. It is part of the healing process to fully disclose what has happened. We can never really close this chapter on our darkest days until the lights are allowed to shine.

I would ask you to support the motion and I would ask for a roll call Mr. Speaker.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

Chair recognizes Representative from Eastport, Representative Townsend. Representative TOWNSEND: Mr. Speaker, Ladies and Gentlemen of the House: Just to revise your memory, this is my helicopter bill I had in in the last session. It passed in the House I believe 81 to 50

and died in the other body.

Though I have not had a continued problem in my area — as a matter of fact, the State Police ran that program in my area this past summer and I sent them a letter commending them on the way they handled it, I am very pleased.
