The SPEAKER: A roll call has been requested. For the Chair to order a roll call it must have the expressed desire of one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The Chair recognizes the Representative from Jay, Representative Pineau.

Representative PINEAU: Mr. Speaker, Ladies and Gentlemen of the House: This bill was in front of our committee and what it dealt with was legislation we passed last time that we could not have Social Security Numbers on cards, credit cards, other cards, cards and what not. With all the health deliberations that are going on around the health industry now, the bill was put in so that Social Security Numbers could be on cards.

It came out as a unanimous committee report. The Representative from Wilton, Representative Heeschen, still had problems with the Social Security Numbers because he thought there should be a better way of doing it.

A compromise was struck with Representative Heeschen saying that in fact we would determine Jo Gill's outfit for the Maine Select to come back to the committee prior to Social Security Numbers having to come off and she would have to come back to the committee and say what in fact other alternatives there are out there for us to do it. If we don't do this, it is going to cost money to get the cards that are now issued - reissued. That is one part.

The other part is, with all the discussion going on in these areas, if you go down to the Clinton Administration's proposal, the Health Security Act, that was the number he was considering to put on that. Therefore, I think this is timely, I think the compromise was met. I think all sides gave a little on this. I would appreciate your vote on this so that we can in fact enact this today.

The SPEAKER: The Chair recognizes the Representative from Wilton, Representative Heeschen. Representative HEESCHEN: Mr. Speaker and Members

of the House: I apologize to the House for the confusion I caused by not signaling that in fact this was a compromise that I had worked out and I will be supporting this. I urge you to as well.

The SPEAKER: A roll call has been ordered. The pending question before the House is passage to be enacted. Those in favor will vote yes; those opposed will vote no.

The following Joint Resolution: (S.P. 732)

JOINT RESOLUTION RECOGNIZING BOWDOIN COLLEGE ON ITS 200TH ANNIVERSARY

WHEREAS, in 1787, the people of the District of Maine first petitioned the General Court of the Commonwealth of Massachusetts for the establishment of a local college in Maine for the higher education of the citizens of the district; and

WHEREAS, on June 24, 1794, the General Court of the Commonwealth of Massachusetts directed that "there be erected and established in the Town of Brunswick in the District of Maine, a College for the purpose of educating youth, to be called Bowdoin College"; and

WHEREAS, in 1802, Bowdoin College matriculated its first class of 8 students on the principle that "literary institutions are founded and endowed for the common good, and not for the private advantage of those who resort to them for education"; and

WHEREAS, in the first 200 years of its existence, Bowdoin College and its alumni and alumnae have made significant contributions to the common good far exceeding the size of this institution; and

WHEREAS, in the field of law, Bowdoin College and its alumni and alumnae have contributed to and occupied the highest positions and have been leaders in the governance of this State and the other states of this nation, as well as in the governance of the United States of America and the many nations of the world; and

WHEREAS, in the field of science, Bowdoin College and its alumni and alumnae have been at the forefront in explorations and discoveries that have benefited humankind, including the disciplines of engineering, human sexuality, mathematics, medicine, mental philosophy and mineralogy; and

WHEREAS, in the fields of letters and history, Bowdoin College and its alumni and alumnae have contributed literature that has enlightened the world and changed the course of human events; and

WHEREAS, in the field of art, Bowdoin College and its alumni and alumnae have made major contributions to the disciplines of photography, music and painting, to name a few; and

WHEREAS, in the field of education, Bowdoin College and its alumni and alumnae have played a significant role in the establishment and promotion of educational institutions of all types in this country and throughout the world; and

WHEREAS, in these fields and numerous more, Bowdoin College and its alumni and alumnae have fulfilled its founding principles to serve for the good of humankind; now, therefore, be it

RESOLVED: That We, the Senate and the House of Representatives of the State of Maine, join in recognizing Bowdoin College upon its 200th anniversary, for its enormous contribution and continuing dedication to the service of the common good; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President, Chair of the Board of Overseers and Chair of the Board of Trustees of Bowdoin College.

Came from the Senate, read and adopted.

Was read.

The SPEAKER: The Chair recognizes the Representative from Caribou, Representative Robichaud. Representative ROBICHAUD: Mr. Speaker, Colleagues of the House: I am proud today to rise and support this Resolution. As a graduate of Bowdoin College I am proud not only to have had that experience but to have been able to be a student at an institution that has played such a pivotal role in Maine's educational history.

As you can see by the Resolution the reason for it, 200 years of participation in educating Maine people to go on to higher pursuits is a very proud and illustrious history and I am pleased.

As we began this session last year, I had the Bowdoin College gavel (so to speak) passed to me from the former Minority Whip, Francis Marsano, and I gratefully accepted it as being, I believe, the only Bowdoin graduate in this body during the 116th Legislature.

I appreciate your support of this Resolution.
