In Senate Chamber Tuesday February 16, 1993

Senate called to Order by the President, Dennis L. Dutremble of York.

Prayer by Pastor Isaiah Hill of the Sebec Baptist Church in Dover-Foxcroft.

PASTOR ISAIAH HILL: I appreciate the privilege of being here and having my friend Senator Hall inviting me and I thank the Lord for the privilege of being able to come and share a few moments with you folks as we all bow our heads and hearts and honor our Lord together.
