Senator **HANDY** of Androscoggin moved that the Senate **ACCEPT** the Majority **OUGHT NOT TO PASS** Report, in concurrence.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Begley.

Senator **BEGLEY:** Thank you Mr. President, Ladies and Gentlemen of the Senate. L.D. 235 amends the overtime pay exemption for commissioned sales persons under Maine law to be consistent with the exemption under Federal law. What we are concerned with here, as far as I'm concerned, is we are trying to cater to the consumer as much as anybody else because at times the major retail people are interested in having salespeople on commission, during hours, when they could not afford to have them on time and a half. If they do not have them then the people coming into the stores would not be serviced because they would not be allowed to have the expertise of those people. There is presently an exemption in Maine's overtime law for outside salespersons, who earnings are derived in whole or in part from sales commissions and whose hours and places of employment are not substantially controlled by the employer. Maine's overtime law also presently has an exemption for automobile sales representatives, however, unlike the Federal overtime law the Maine overtime law does not currently contain an exception for other commissioned sales persons. The proposed amendment uses the same language as the Federal law to create an exemption from Maine's overtime law for persons employed by a retail or service establishment, provided that their regular rate of pay is in excess of one and one half times the State minimum wage and more than one half of the employee's compensation represents commissions. This law will be to the benefit of the consumer in Maine. The amendment to the law also contains a provision that requires the Maine Department of Labor to report back to the Labor Committee by January 30, 1995, to allow a formal opportunity to reconsider the Bill if there are any unforseen, adverse consequences. It is my opinion that we should not accept the Ought Not to Pass Report. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Handy.

Senator **HANDY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. To recap, this Bill would exempt from paying of overtime to people who work with inside commission sales so long as they make one and a half times the minimum wage. This Bill, in Committee, became known as the Sears Bill because Sears and their Brand Central would be the people primarily affected by this. It was put across in our Committee public hearing as well as the numerous work sessions we had on this Bill that the employees of Sears had been duly informed of the pending legislation. Quite a bit of time has transpired since this Bill was heard in a public hearing on February 26th. In order to afford myself and other members of the Committee time to look into this and to really get a first hand sense from the employees perspective as to how they would be affected by this law. Let me point out that I was originally a cosponsor of this legislation. I spoke to no fewer than a dozen and a half Sears employees employed throughout the State of Maine, not just in my hometown of Lewiston. Without exception all of them found this as detrimental to their ability to earn what one might term a fair wage. Most of these employees do make one and a half times the minimum wage so they would meet that qualification under this. The representatives from Sears put it across that this would enhance their opportunity to have more take home pay. Upon the investigation of myself and some of my other colleagues on the Labor Committee found that these employees, as it stands right now, don't spend a whole lot of time doing sales as it was propounded by the representatives who

spoke before the Labor Committee from Sears. They spend time cleaning, stocking shelves, working in the storeroom, in fact some of them said they spend an inordinate amount of time as required by some of the store's policies telemarketing send and service contracts. If the rationale here is to allow for more time to be spent on the sales floor, enabling the employee to take home more money, enabling Sears to turn over more stock, they're not exercising that ability within their own confines of forty hours and this is simply a way for Sears to get out from and around paying overtime. I hope you support the Majority Ought Not to Pass Report. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Begley.

Senator **BEGLEY:** Thank you Mr. President, Ladies and Gentlemen of the Senate. I would take exception to the use of "Sears Bill". It is a term that has been used and I don't think it fully represents the [Due to technical difficulties, all of Senator Begley's remarks were not recorded.] Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Carpenter.

Senator **CARPENTER:** Thank you Mr. President, Ladies and Gentlemen of the Senate. I'd like to pose a question. I also had a question as to why it was a Sears Bill and always mentioned Sears. I just have a question as are some of my small retail establishments such as furniture, TV, Refrigerator sales, retail outlets, also going to come under this Bill?

THE PRESIDENT: The Senator from York, Senator Carpenter has posed a question through the Chair to any Senator who may care to respond. The Chair recognizes the Senator from Androscoggin, Senator Handy.

Senator **HANDY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. This became known as the Sears Bill because Sears was the only company in the entire State of Maine that spoke in favor of the legislation first of all. To answer specifically the question from the good Senator from York, this would affect any company in the State of Maine that pays their employees time and a half the minimum wage. So it would affect simply more than Sears sir. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Carpenter.

Senator **CARPENTER**: Thank you Mr. President, Ladies and Gentlemen of the Senate. I've been in sales pretty much most of my life, one type of sales or another, and it's always been commission sales. Being a commission salesman in the first place if you elect that type of employment the hours really mean nothing. You're going to spend the number of hours that you need in order to make a decent wage, whether it's inside sales or outside sales. It seems a little difficult to me not to understand why we shouldn't pass this Bill as amended to make it comply with Federal law and with that I hope we vote that way and I request a Division.

Senator CARPENTER of York requested a Division.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Begley.

Senator **BEGLEY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. One other comment in regards to questioning workers at these particular retail outlets. In talking with the management people who presented themselves at the public hearing the question was would you insist on any worker working this particular system and the answer of course was no. They also stated outside of the hearing they did not intend to question or to even concern themselves with any kind of a position before their employer fees to find out where they stood because they felt it may be an unjust concern at that time. Thank you.

On motion by Senator **ESTY** of Cumberland, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

The President noted the absence of Senator **CAREY** of Kennebec, and Senator **MCCORMICK** of Kennebec, and excused them from today's Roll Call votes.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Begley.

Senator **BEGLEY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. The Bill "An Act to Promote Equity in Wages and Benefits in Public Contracts with Private Contractors" is another one of those Bills that is going to look fairly favorable for Labor but is going to be somewhat detrimental to the private contractor and to, eventually, the State of Maine. The State depends a great deal on private contractors on basically small programs throughout the State depending on, not only urban, but rural areas. The private contractor cannot, from his own admissions, compete with that type of wage and stay in competition and in business. If he were to be forced to do that because of a Bill such as this he would probably not bid on State contracts and some of those contracts the State is not ready to do itself. So you are in a situation whereby it is going to cost the State more money and eliminate the opportunity of competition by small, private contractors when they bid on State jobs. Thank you.

THE **PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Luther.

Out of order and under suspension of the Rules, the Senate considered the following:

Senator **LUTHER:** Thank you Mr. President, Ladies and Gentlemen of the Senate. I recognize that this concept that we're dealing with is difficult, but I don't know how to separate the concept from the reality that what we're doing here is going to take work away from people who work for the State who do not earn a lot of money. This is just a way to lower people's wages and this Bill has been watered down a great deal from what was originally intended and I would like to read into the Record the Statement of Fact. "The original Bill required that all State contracts for services prescribed wage rates based on the prevailing wage rates in the State. The Amendment specifies that the prescribed wage rates are only required on contracts for services that are provided by State employees as of the effective date of the legislation. The amendment also provides that the wage rates to be used are those rates paid to State employees in comparable job classifications rather than prevailing rates in the State. The amendment transfers the responsibility for determining these rates from the Commissioner of Labor to the Bureau of Human Resources. The Amendment also adds a fiscal note." I think that what this is asking is that we treat State workers fairly. We have asked them to balance our budget twice, most of the State workers are not hired to long jobs, they do not earn a lot of money. All we're asking is that if you put this out to bid at least make them comparable, make the State workers able to compete. This is what the Bill is asking us to do. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Begley.

Senator **BEGLEY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. [Due to technical difficulties, all of Senator Begley's remarks were not recorded.] ... when he attempts to keep the employment in his area to the benefit of the State. Thank you.

Senator **BEGLEY** of Lincoln requested a Division.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Handy.

Senator **HANDY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. This Bill as it has been amended in the Committee simply maintains that if we're paying a State employee a certain wage rate that if we're to contract out for similar services that those people that we hire through the State are afforded the same kind of wage. I request the yeas and nays. Thank you.

On motion by Senator **HANDY** of Androscoggin, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Cianchette.

Senator **CIANCHETTE:** Thank you Mr. President, Ladies and Gentlemen of the Senate. I'd just like to add a few comments to this and I understand the good intentions of the Majority Report but let me just read the fiscal note that's on the L.D. The fiscal note says, "requiring private contractors to adhere to wage and benefit guidelines when contracting with the State will increase the costs of contracts to all State Departments and Agencies who have access to these services. The amount of increased cost cannot be determined at this time since the projected use of these private contracts cannot be estimated." I don't know if that's correct or not but I believe if we pass this Bill the public will feel that we are again adding costs. I keep getting letters from constituents and other citizens in the State of Maine and I keep reading in the newspapers that this Legislature still doesn't get it. I keep hearing that phrase over and over again. I'm not sure this is true, the fiscal note really will add a lot of cost, but at least it will go out in public that it does. I just think that it is absolutely wrong for this Legislature to overlook and forget the reputation we're getting and they say we "still don't get it". I'm going to ask you to vote against the motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Handy.

Senator **HANDY**: Thank you Mr. President, Ladies and Gentlemen of the Senate. This Senator gets it. This Senator got it when this State made the move toward privatization of State services. For those of you who support that now is the time to belly up to the bar and pay the piper. It may be a mixed metaphor but I think it applies. If we're going to pay someone to do a job on behalf of the State we ought to make sure we're not taking advantage of that person, be it in wages or benefits. I think our constituents only expect us to do the right thing in this case. Thank you.

THE PRESIDENT: The pending question before the Senate is the motion of Senator HANDY of Androscoggin that the Senate ACCEPT the Majority OUGHT TO PASS AS AMENDED Report.
