STATE OF MAINE PROCLAMATION

An Act to Impose Term Limitations on Legislators, Constitutional Officers and the State Auditor

WHEREAS, the electors of the State of Maine presented to the One Hundred and Sixteenth Legislature in the First Regular Session an initiated bill entitled, "An Act to Impose Term Limitations on Legislators, Constitutional Officers and the State Auditor,"

under the provisions of Article IV, Part Third, Section 18 of the Constitution of Maine, and

We are pleased to submit the sixth Single Audit of the State of Maine, covering the fiscal year ended June 30, 1992.

We conducted the audit pursuant to Title 5 MRSA, Chapter 11 which authorized the State Department of Audit:

To perform a postaudit of all accounts and other financial records of the state government or any department or agency thereof, including the Judiciary and the Executive Department of the Governor, except the Governor's expense account, and to report annually on this audit, and at such other times as the Legislature may require.

The state expended \$1.054 billion in federal financial assistance. The audit was conducted to meet the requirements of the Single Audit Act of 1984, authorized under the United States Code, USC 31, Chapter 75 and the regulations established by the U.S. Office of Management and Budget (OMB) Circular A-128, "Audits of State and Local Governments."

The objectives of the audit were:

To examine the state's financial statements and determine if they were presented fairly and in accordance with generally accepted accounting principles;

To assess whether the state's systems and procedures for financial accounting, reporting and internal controls were adequate;

To assess the state's accountability for revenues; to determine the propriety of expenditures, the extent to which funds have been expended in accordance with prescribed state and federal laws and regulations; and to examine the state's compliance with federal regulations pertaining to financial reports and claims for reimbursements; and

To recommend corrective actions for any deficiencies noted; and to include management's responses to our findings and recommendations.

The State of Maine's accounting system and procedures, internal control, and compliance with rules and regulations have certain weaknesses which we have included in the following reports:

Reports on Compliance and Internal Controls - include those audit findings which, in our opinion, represent material weaknesses. There are two findings which identify material weaknesses in internal control; these can be found on pages 65 and 71; one that affects compliance with state laws and regulations is on page 94.

Schedule of Reportable Conditions - includes those audit findings which we consider to be reportable conditions under standards established by the American Institute of Certified Public Accountants. The fifteen reportable conditions begin on page 75.

Schedule of Findings and Questioned Costs - includes eighty findings which resulted from our review of the federal programs administered by the State of Maine. These findings begin on page 105.

Management Letter includes one hundred audit findings designed to strengthen internal controls and operating efficiencies that affect many state agencies. These findings begin on page 189.

We again must render a qualified opinion on the state's financial statements because the state does not record certain accruals as required by generally accepted accounting principles.

In addition, we do not express an opinion on the General Fixed Assets Account Group (GFAAG) because the state's accounting records for GFAAG are incomplete.

I commend the staff of the Department of Audit, whose professionalism and dedication made the preparation of this report possible. Through our efforts, and the ongoing cooperation of the Maine Department of Administrative and Financial Services and other state agencies, we will continue to provide financial information that serves the needs of governmental decision makers, federal regulators, credit rating agencies, financial institutions and interested citizens of Maine.

We would be pleased to respond to any of your questions or comments about the 1992 Single Audit Report.

When the Legislature enacted significant revisions to Maine's hospital payment system in 1989, it directed the Commission to conduct a review of two of the newly enacted provisions, the special exception adjustment and the variable adjustment factor. This review was to be conducted after these new provisions had been in place for two payment year cycles. The second payment year cycle following the statutory implementation date for these two provisions was completed on September 30, 1993.

The Legislature also directed the Commission to submit a report on its review with any recommendations for changes to the special exception adjustment and the variable adjustment factor. Enclosed is a copy of the Commission's report and its recommendations.

On the basis of its review, the Commission is not recommending further changes to the special exception adjustment at this time. A 1991 statutory amendment supplied an important clarification of the provision and the Commission believes that it is otherwise meeting the objectives identified at the time of its enactment.

In contrast, the Commission's review of the variable adjustment factor has led it to the conclusion that the statutory upper and lower limits on the factor should be eliminated. The Commission believes that the retention of these limits will add to the cost of hospital services in a manner that is not consistent with the purposes of the variable adjustment factor. The Commission will be requesting that the Legislature modify the variable adjustment factor in the Second Regular Session in order to avoid this unintended consequence of the current statutory language.

- 3. For certain types of funds that are transferred between school administrative units (for tuition costs and for transportation and other services provided to another school administrative unit), the amount is budgeted in both school administrative units, since each unit must appropriate these funds. Since these instances cannot be netted out in the State Total Summary, the state totals will overestimate actual expenditures to some degree.

School Year

In accordance with 20-A MRSA Section 5051, I am hereby submitting our annual report of habitual truants identified by school superintendents during the school year 1992-93. A habitual truant is defined as a student of compulsory school age (7 to 17) who has attained the equivalent of 10 full days of non-excused absences or 7 consecutive days of non-excused absences during a school year.

The number of identified habitual truants under age 15 has decreased as compared to the previous school year while the number of habitual truants age 15 or older has increased. We believe the decrease reflects the attention being given to irregular school attendance by school officials across the state. The Department's continuing efforts to provide assistance to schools stress the need to intervene at earlier grades by identifying students at risk and developing ongoing positive strategies. A summary report for the most recent ten years is included for your review and information.
