In accordance with Title 9-B MRSA section 217, as amended, I am submitting to the members of the Maine House and Senate a report entitled "The Status of Maine's Financial Institutions."

This report contains the number, type and legal structure of all financial institutions operating in the State of Maine, as well as the location of offices and total deposits held by these institutions. This past year continued to show improvement in the financial condition of the banking industry in Maine, with earnings exceeding prior year's record performance and future improvement in bank asset quality.

In recent months, major legislation has been passed by Congress authorizing nationwide interstate banking within one year and permitting interstate branching within three years. Maine must now reassess its structure of interstate bank regulation, particularly the Net New Funds provision, a basis element of this annual report and a safeguard against an outflow of our limited capital resources. The Bureau intends to present legislation this session to address these issues.

Copies of this report have been distributed to the Office of the Clerk of the House of Representatives in order to provide one copy for each member of the House.

Dear President Butland and Speaker Gwadosky:

I am writing to you pursuant to 5 MRSA section
17103, sub-section 11, which requires that the Board
of Trustees of the Maine State Retirement System make

of Trustees of the Maine State Retirement System make a written report to the Legislature each year. The statute provides that the report be submitted "to the appropriate legislative committee on or before January 15 of each year." Because the "appropriate committee" and its membership have not yet been identified, I have decided to submit the report to you, with 15 additional copies being sent to the Executive Director of the Legislative Council for distribution to the "appropriate committee" chairs and members when known.

This report is to cover areas of policy and administration which in the Board's opinion should be brought to the attention of the Committee, any proposed legislation which the Board recommends to improve the Retirement System, a review of the operations of the Retirement System, including a summary of administrative expenses and the status of these expenses relative to the operating budget, and changes in the delivery of services to the members.

Overview

The Board of Trustees continues to hold the opinion that the Retirement System is in need of substantial plan simplification and a sound, consistent funding policy. Although the System's funding status has improved to date, the System's current financial condition is not satisfactory and is in need of further improvements which are directly related to the State's continued willingness to pay contributions in accordance with a sound and rational funding policy.

The Board remains concerned that the level of service to both the membership and employers is not yet adequate, though recent improvements have been made and more are scheduled. In the past, change has been difficult. The change in the System's organization to a public instrumentality is the opportunity of the System to redesign its operations and services to carry out its particular role. Aspects of the change have been more difficult than anticipated, but service improvements are already

evident.

As previously indicated, the Board is committed to the notion of plan simplification. The System's plan provisions continue to be extremely complex, making them difficult both to administer and understand. The Board continues to hold the opinion that the resolution of these issues is critical to the long term success and viability of the System and will continue to devote effort and resources to plan simplification and ongoing operational reforms. **Legislation**

Currently known or anticipated legislation will deal with the System's operating budget and its legal representation. Consideration should be given to the nature of the legislative role in plan design and simplification. The System continues to work with constituent organizations on matters of common interest and concern.

Investments

The Board of Trustees is charged responsibility to invest all assets of the Maine State Retirement System in accordance with the prudent person standard. The Board is assisted in this task by the Executive Director and Investment Advisory Committee comprised of selected Board members, staff and individuals who have investment expertise.

The Board continued to invest the System's assets in accordance with the investment program first adopted in 1987, revised in 1991 and 1992 and continuously reviewed and monitored by the Board, the staff, the Investment Advisory Committee and the System's investment consultants. Overall, the long term investment returns generated by the portfolio have exceeded expectations. Investment returns are as follows:

In general, the capital markets have been favorable for the past decade resulting in better than expected returns. The Board continues monitor the capital markets and evaluate the need for change as events unfold. The Board continues to maintain an investment program that it considers prudent and well positioned to generate superior returns in the long term, while recognizing that the capital markets are volatile and can result in poor returns in the short term.

Consolidated Retirement Plan The efforts of the Participating Local District Advisory Committee and the System to create a Consolidated Plan for participating local districts resulted in the adoption in May, 1993 of the Board's governing the Consolidated Plan. Consolidated Plan became effective July 1, 1993 and went into operation on July 1, 1994, the enrollment minimums specified in the rule having been greatly exceeded. Current participating local districts not yet in the Consolidated Plan have until July 1, 1996 to join. The Participating Local District Advisory Committee remains essential in the implementation of the Consolidated Plan, as it was in its creation. <u>Trustees</u>

In the FY93-95 biennial budget bill, Legislature provided that all seven of the System's trustees would be subject to legislative confirmation. Previously, only the four trustees who

are appointed by the Governor were so subject. Legislature also altered the criteria for two of the gubernatorial appointees, substituting actuarial experience for that of law, and further provided that all trustees "have a working knowledge of retirement policy and legal issues and a general knowledge and understanding of banking, finance and investment practices."

Actuarial Assumptions Actuarial assumptions were modified in 1994 as the result of recommendations by the System's Actuary and legislative changes enacted in 1993. The System continues to employ the same methodology implemented in 1987 to determine its liabilities and establish amortization schedules to liquidate the unfunded liabilities.

Representative from Portland, Representative Adams. Representative ADAMS: Mr. Speaker, Men and Women of the House: Today's session marks the final day of service in this Chamber for one of our colleagues for whom the word "service" has a very sure and certain and a special meaning. Representative James. V. Oliver will be departing service with us to take up national service, soon as the occupant of the post as Director of the United States Peace Corps in the nations of Suriname and Guyana.

Near the end of his own long life, spent in the service of others, Dr. Albert Schweitzer, was asked if he had found any special meaning or special message in long life. He was asked if there was a secret to a satisfying life. He answered this, "I have discovered no secret for living but I do know that the only ones among you who will be happy are those who have learned how to serve." Dr. Schweitzer passed on in 1965, 30 years ago. It is a sad thing that his name is so little remembered today or for that matter that service as a calling has lost so much of its meaning as well.

For Representative Jim Oliver, that word service has always held the highest and its best meaning. He has served in the Peace Corps before, some of you may know, as a Director is Venezuela, back in the decades when some members of this House were in fact born. For two decades since then he has served as director of the Portland West Neighborhood Planning Council.

He has served as a state Legislator here, representing one of the smallest districts in the State of Maine. Smallest because it is the most populous and because it is the most populous it is among the most diverse, the most difficult and the most interesting. Almost 30 foreign languages are spoken in the grade schools that sits across the street from the office where Jim Oliver works every day. He would have it no other way.

For all of that time, the service in this nation and in others he has been a voice for those people that the world has pushed to the side or left behind or who are struggling against the odds of life and living just to keep the average guys place in line for those opportunities that American life holds out in promise -- which description (you know) fits most of us. To devote a lifetime to such service requires a strong conscience and a willing heart and a steady head and steady hands. Jim has all of those.

The nation for which he now goes to work is a lucky one. We, with whom he has served, have been lucky people too. I have been very lucky myself to know him as my neighbor, my colleague, my district mate, and indeed my friend.

Mr. Speaker, I move that we now pass the measure before us in his honor and when the House adjourns today that we do so in tribute to the service rendered to the people of the State of Maine by our friend and our colleague, Representative James V. Oliver of Portland.

The Chair SPEAKER: recognizes The Representative from Portland, Representative Oliver.

Representative OLIVER: Mr. Speaker, Ladies and Gentlemen of the House: This is a very difficult day for me in the sense that we will be leaving Maine as a family. My son was born in Machias, my daughter in Portland, my wife in Kittery. I should run for Governor. But, it is an exciting time for my family.

I want to first thank Representative Adams and the Portland Delegation for the very kind words. This has been the greatest honor that I have ever had in my life. I appreciate all the kindnesses towards me. I appreciate all the civility that we do business with each other. I love the challenges. I was always excited with the great debates. I love the decorum, the fact that this body really respects each individual. I have seen that happen and I have seen the way we treat each other and I guess it makes me very proud to have represented my district in this

One of the things that I stood for (I hope all my life) was an old Jesuit saying that, "It is better to ask forgiveness than permission." The only criticism that I have is of the media. I feel that I have that opportunity since I have the mike and if you grant me one little last wish I would appreciate it. The fact is that in Saddam Hussein's country the debate probably is very quiet. I love the debate here. I don't mind the partisanship. When I get the Portland paper down in Latin America and I hear of the raging debates and the great issues that were facing each other and trying to convince each other, I will know democracy is very well served in Maine. This is a

great body, you should be honored to be here.
In a way I envy you because the challenges you face this session are going to be particularly interesting.

I leave with a good feeling of friendships on both sides of the aisle. I have been treated with kindness by the staff. By the way, I have been around enough at my age to know that if someone makes an offer to you and you are 62 you should be flattered and that is why I accepted it. I am being recycled, I was in the Peace Corps.

I wanted to particularly thank the state workers who I have had an opportunity to get service from. I don't think you will every find a more dedicated, hard working, civil servant than we have in Maine. I just appreciate the great debates and the great issues. I think Maine is very well served by this great diversity of people here who have Maine's interest at heart and I thank you very much for your friendship.
