It is my pleasure to provide you with an advance copy of the Report on Improving Access to the Maine Technical College System. The study, which will be presented to the MTCS Board of Trustees next week, was requested by the 116th Maine Legislature, in follow-up to a 1991 report which revealed a striking gap between the demand for skilled technicians in Maine and the enrollment capacity of the Technical Colleges.

The findings and recommendations in this report are the result of a thoughtful and thorough review by a five-member study committee and address four areas of concern outlined by the 116th Maine Legislature. Specifically, those areas included a review of current and projected applicant data, technical college curriculum, equipment needs, and the locations of campuses in relation to population distribution.

In addition to addressing the concerns raised by the Legislature, the Committee found during its deliberations that the role of the MTCS in the area of economic development was a significant importance to Maine and, as such, merited consideration as well. Those findings are included in a final section of this report.

Representative GWADOSKY: Mr. Speaker, Ladies and Gentlemen of the House: I had forgotten how good if felt to speak form this corner -- but it doesn't feel that good Representative Jacques.

I have offered the proposed change to this particular House Rule for a very important reason. The Order that I have submitted (which will require a thirds vote) is designed to change the organization of the House Standing Committees in the House that we currently adopted from seven members to eight members.

This will ensure that the committees are evenly split between the two parties of the House, reflecting what I believe (obviously, as we all know) the more current composition of the House in and of itself. This is an item that for whatever reason has been (over the years) thought of as being a partisan split and for the life of me I can't understand the reason for that to be the case.

These are not Joint Standing Committees, these are committees of the House as the Senate has its own committees. My perspective is that these should be evenly split between the parties. This amendment will ensure that by going from seven to eight members

on each of these committees we will be in a position then to assign an equal proportion of representation of both house democrats and republicans on each particular committee.

It also does one other thing. It changes the name of the committee on elections. We currently have a House Committee on Elections. This amendment would also change that to become the House Committee on Ethics and Elections to more accurately reflect the types of scenarios and situations that we could refer to a committee should they ever rise during the course of our session.

So, it is a technical amendment but it is an important message and I think it sends an important signal that we are going to try to achieve a balance on the committees of jurisdiction, particularly those that we are dealing with on House committees. And, particularly on a committee as important as the House Committee on Ethics and Elections that will change the name to reflect the types of scenarios that could be confronted to deal with but will also ensure that will be an equal proportional balance of Democrats and Republicans on that particular committee to ensure that any recommendation that they make is one that has been made from a balanced, thoughtful, discussion before the House is in a position to make any final position on that.

So, I hope and encourage you to support the change. The SPEAKER PRO TEM: The Chair will order a vote. The pending question before the House is passage of the House Order (H.O. 6). Those in favor will vote yes; those opposed will vote no.
