whereas, Representative Hale began her many years of legislative service as the Representative from Sanford in the 112th Legislature and has served continuously with us since that time; and

WHEREAS, among her many accomplishments, Representative Hale served on the Joint Standing Committees on Labor, Transportation, Banking and Insurance and the former Ways and Means and Audit and Program Review, and provided consistent and valued contributions to those committees; and

WHEREAS, Representative Hale was not only a tireless, independent, hardworking and feisty representative of her district, but was also recognized as a representative of all the people of Maine in her dedication and service to the State; and

WHEREAS, Mona Walker Hale was known to all of us for her ready smile and wit, her caring, her fighting spirit and her commitment to the average person and we will greatly miss those precious qualities; and

WHEREAS, Mona Walker Hale died as she lived, in the service of the State and the people of Maine; now, therefore, be it

The SPEAKER PRO TEM: The Chair recognizes the Representative from Fairfield, Representative Gwadosky.

Representative GWADOSKY: Mr. Speaker, Ladies and Gentlemen of the House: We pause this morning to remember a member of our extended family, a close friend, admired colleague. As we grieve over Mona's passing we also remember joyfully our many moments with her.

In addition to her many other roles in life, as a daughter, as a mother, as a wife, as a grandmother, a neighbor, as a confidant — Mona Walker Hale was a public servant. She served her community with distinction, integrity and compassion. She served as she lived — with a feisty determination, a sparkle in her eyes and, a commitment to the people in her life. Mona's death deprives her community of Sanford and the entire state of her caring service as an elected official.

As elected officials and members of this great body we sometimes forget that while we deal with one another in a professional capacity on a day-to-day basis that each of us have a personal side. We have families, friends, neighbors and communities of individuals who both represent our life outside this legislature and sometimes decide and define why we serve as a member of this legislature.

Public service takes people away from their families. We all accept that responsibility. We know it comes with the territory. But, that doesn't

always make it any easier when you have to explain to your spouse or your wife or your children or grandchildren that you won't be home tonight or you won't be home tomorrow or you won't be home next week. Mona never hesitated from her commitment to public service. Yet, she was equally determined to find time to spend with her loved ones to somehow compensate for the many long days and nights she spent as a member of this great body.

I had the great opportunity to speak on your

behalf about Mona at the funeral services.

The day before I had talked to many of you and asked your recollections and observations and your reflections about Mona. The words you used were typical and not surprising because you used words like "strong-willed," "unbending," "tenacious." Someone said "outspoken" — but I am not sure by whom. You said that she was always willing to help anyone whether it was a member of her constituency or a member of her extended family here in Augusta. She was a fighter, someone who was always looking out for the little guy. She felt her role as a Representative was to look out for and take care of the average person.

She had a personal relationship with her constituency that was unique, I think, for any

legislator.

She played a prominent role in politics in the City of Sanford for nearly two decades. She was the first female selectperson elected in that community.

She held a legendary make-shift office at a corner table at Dunkin Donuts on Main Street and people know that either Mona or her husband Regie would be there. It was at that location where she was available, accessible and they argued the great issues of the day in Dunkin Donuts.

I called her former seatmate, a former Representative from Portland, Peter Manning. Peter and Mona used to sit side by side right up here. They spent day after day debating smoking bills. Peter — Mona, as you know, was a strong advocate for smokers rights, Peter felt somewhat different on that issue. Often they would begin that debate with Mona in the smoking room and Peter was nice enough to wait so she could get back here and listen to every single word that he said.

One of the comments that Peter made to me was that she always referred to her constituents as "my people" and she took it personal. Whether the issue was workers' compensation, minimum wage, you could always count on Mona to accurately reflect the views of her constituents. She would stand and say "My people feel that..."

of her constituents. She would stand and say "My people feel that..." "My people believe that...".

She was very proud to be a member of the York County Delegation. That was very important to her. She served with another good friend, Representative Eleanor Murphy, as one of two female members of that delegation. The convention of wisdom of the York County Delegation was that if there was a specific issue being proposed and Mona and/or Eleanor were against it, you were in for a real challenge. But, if Mona and Eleanor were both against it, you were in deep trouble.

I tried to think of a particular bill that I think best represented Mona. If there was one item that I think meant more than anything else to her it was establishing a technical college in York County. I can't begin to imagine how many people she talked to about this. I can't tell you how many times she came into my office or Representative Jacques office, sat

down - she would often be out of breath. She would grab my arm to make sure I was paying attention. Sometimes for 20 minutes and it was difficult not to pay attention when Mona was talking to you -- and she never had an appointment - and she would talk about the changes in York County and the needs of the people in York County and how badly they were in need of a Technical College. She said to me on one occasion, "Before I die we will pass a bill to establish a technical college in York County." Mona got her wish.

She was fun. She liked to have fun. She was a caring person. She cared for people and people cared for her.

Representative Kilkelly reminded me of the incident five years ago — a very unusual time for Mona, she was absent, she was hospitalized, the session was going in late that night and it was being covered live by Maine Public Television. The decorum then was the same as it is now, there were certain then was the same as it is now, there were certain things you could and could not get away with. But, during the publication on this side of the House, there began to appear five by seven note cards with letters upon them. One letter said "H," the next letter that was taped to a members desk was an "I" and as the camera faded you could begin to pick up a message that her seatmates had left to Mona (who they knew was watching on television) which said, "Hi, Mona."

She cared about people and they cared about her.

I have said before that serving in the legislature is like having an extended family. We share in the joys, the births of our sons and daughters and grandchildren. We have also shared the sorrow of the loss of many of our members and members of their families.

Not long ago Mona lost her son. It was an ordeal that she struggled with for over two years. She confided in only a few people.

Mona had a big heart but when her son Jesse died,

her heart broke. I am not sure it ever really healed. Each of us, I think, has an expectation that sometime we are going to be called upon to leave this world -- but to Mona and to many others losing a son or a daughter somehow seemed to violate life's natural cycle. She received a tremendous amount of support from her daughter Tambre, she was a tremendous source of inspiration during that time.

Representative Hatch was such another good friend of Mona. She told me how often Mona talked about Regie, her husband. How supportive he was during that time but throughout their life.

Representative Hatch also told me that Mona was somebody who always tended to business, that if she felt sick, felt tired, she still came to session, she still rushed back to go to the Council meetings. Nothing epitomized that more, I think, than the convening of session last December. I remember talking to Mona about it for days at a time. Over the weekend, prior to the swearing in date, her attendance was an issue that we discussed privately and at one time on the speaker phone with Representative Mitchell and Representative Jacques. We told her we were concerned about her health. I begged her not to come the day before. She told me that she would consider my thoughts but that she had to leave now to get her hair done just in case.

And, when the roll call was being read and she struggled to her feet to say "present" I had tears in

my eyes -- it is a moment I will never forget for as long as I shall live.

Yesterday would have been Mona's birthday. It was birth date that she shared with myself and Representative Luther.

People deal with death in many different ways. Some feel frustrated, some are angry, some are confused. If there is a reason, a rationale for Mona's death, I am at a loss to explain it. But, I know that she is with her son Jesse now. For that, am grateful.

Her death should remind us all of our shared mortality. It should remind us that our life and our time here is temporary. That our time for life is the moment that we are living here today.

Not long ago we lost another member, the former Representative from Winslow, Representative Carter. He was killed tragically leaving an Appropriations meeting on a stormy day.

I remember coming into the Chamber after his funeral late in the afternoon, the Chamber vacant. There was a television camera crew here that day, they had hoped to get a picture of Don Carter's desk and his name plate as kind of a lasting tribute to part of their story.

I remember talking to the reporter at the time because they were struck with emotion when they came into the empty House, not knowing exactly where it was that Don sat, to find on seat 122 that all the papers were gone, the books were gone but there was but a simple flower appearing on his desk. I told him, as I will tell you, that that is the tradition that we have used as members of the Maine House, it was not for the press, it was not for the public, but rather it was tradition for us. It was an opportunity for us to show our respect for a member we had lost, to be mindful of their commitment to public service and to be mindful of the sacrifices they made for that commitment.

When Don Carter passed away I stood on the floor of the House and offered two quotes that I will offer today. "Memory", said Cicero, "is the treasurer and guardian of all things." "Praising what is lost", said Shakespeare, "is what makes the remembrance so dear." We meet here today in an attempt to treasure and praise one who has been lost to us to somehow make that memory so much more meaningful. As we remember and say good-bye to Mona Walker Hale today each of us can draw from a memory or remembrance that will make her life so much more meaningful for each of us forever.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Waldo, Representative Whitcomb.

Representative WHITCOMB: Mr. Speaker, Members of the House: Fortunately for all of us this is the kind of day that, in the memory of those of us who have been here a session or few, doesn't occur very often but it does occur. I think it is a testimony to the fact that there are many many days in this chamber when we assume adversarial roles while we are in the Chamber and that as soon as we walk through those doors those roles are dropped and we are friends.

Mona Walker Hale was that kind of person.

Mona began her service the same time I did in 1984. I can share with you that we probably never cosponsored a piece of legislation. Mona and I — are from different parts of the state, different views on many subjects and yet in this Chamber and outside of this Chamber we were friends, not personal

friends, rarely knew each other, knew very little about each other. But, it dawned on me as I watched the expressions on your faces as the Speaker made his comments, some of the words he shared with Mona's family and the rest of us at the services in Sanford — that most of you did not know Mona, in fact many of you saw her only once in a condition that Mona was not at all like Mona. Mona was constantly on the move prior to that day in December.

Mona typified the service that I hope you strive to provide your constituents in this Chamber. There is not a thing that she would not do for her people.

That was said over and over again in Sanford.

It has been said by several members in the last few days, that it is sometimes hard to find the impact that you make on the people of Maine as you strive very vigorously to change the laws, to redirect the government to help your people.

Sometimes it is hard but I think Mona approached her work with the vigor and the sensitivity that is a model. I say that as one who probably day after day disagreed with the direction that she wanted to take

ıssues.

It struck me, as it probably struck you, to approach the Chamber and see the flag at half mast, to see the Maine State Flag at half mast. In Sanford, see the flags there in the same position, at half mast. And, to hear the comments of the people in her community about the things she had done there that most of us were unaware of in Augusta.

It is a tragedy in a sense, beyond the personal loss, the loss of a friend, the loss of someone who works with us in committees. A tragedy in a sense that many of you will not have an opportunity to work with Mona, to try to he an opponent of Mona — try, few of us have ever claimed that we were successful in out debating Mona.

Mona's service to this state was outstanding. Mona's service to her people in her district was very

much appreciated.

The impact, as is the impact of your work, will be felt over time. Perhaps someday the Technical College in southern Maine will reflect on one of its buildings the contribution that Mona has made.

She was a wonderful person and many of us will

miss her.

The SPEAKER PRO TEM: The Chair recognizes the

Representative Berwick, Representative Murphy.

Representative MURPHY: Mr. Speaker, Men and Women of the House: There are few times in this House when you meet and make a true friend. We are all friends, we all like one another, we all work together.

we all like one another, we all work together.

With Mona and I it was a little different. She was a Democrat, I was a Republican. Our lives kind of started in the same way for public service. She was a selectwoman in Sanford, I, the term before her, I guess, was a selectwoman in the town of Berwick. I came to the Legislature in the 111th, Mona came in the 112th. I will never forget the first time I saw Mona, it was at the Senator, she stayed that night when we were up here for the swearing in. The minute I met her I liked her. I really believe she felt the same way.

We did a lot of things together. We cosponsored — Mona sponsored and I cosponsored the York County Technical College in 1988 and we have worked ever since to get it through.

Mona and I never had a disagreement over politics. We didn't agree on things, we might discuss them and drop them, we never had a harsh word

over it. We would go out to dinner and we would sit there like teenage girls for hours just talking with one another. We shared our family secrets, we shared our problems. There are very few people you will meet here that you can do that with. I will personally miss her and I would like to say, not good-bye Mona, someday we will meet.

Subsequently, the Order was passed and sent up for concurrence.

At this point the House members stood in a moment of silence in memory of Representative Mona Walker Hale of Sanford.

At this point Speaker Gwadosky resumed the Chair.

The SPEAKER PRO TEM: The Chair recognizes the Fairfield, Representative from Representative

Representative GWADOSKY: Mr. Speaker, Ladies and Gentlemen of the House: I will be extremely brief. The Order itself, I think, is relatively straight

It is the result of discussions many of you have had for the last couple of weeks as we proceed with our eventual enactment of the Supplemental Budget

today, in the other body.

Most of you (I believe all of you) are in receipt of a letter from Governor King which he described his interest in a process that has been discussed, once again, by many of you to move ahead with adoption of the Supplemental Budget. A process that involves decoupling the Health Care Program from Maine consideration of the Supplemental Budget, a process that embodied in this particular Order that would allow the Human Resources Committee to put together a bill to fund a limited transitional drug benefit program for those persons who remain on the Maine Health Care Program as of March 31st, 1995 to ensure that those people who may be in a catastrophic or other type of condition who are required and have, by necessity, an obligation and responsibility maintain themselves on these particular prescriptions will not be denied those and there will be no shortage of coverage.

Finally, in our discussions over the last several weeks and more importantly, the last couple of days, of long going and outstanding interest as to how do we provide health care in this state, a commitment from the Governor, to work with the Human Resources Committee as well as the new commissioner of Human Services, Kevin Concannon, to look at comprehensive alternative methods of expanding our current managed care initiatives in the state, including the development of 1115, a demonstration waiver, if that

is ultimately deemed the appropriate way to proceed.

It is with the knowledge that the Human Resources
Committee, the members of this body and the Governor
of the State of Maine as well as Commissioner of Human Services have committed to work together collaborativly to find an answer that I offer this particular order which, once again, would require the Human Resources Committee to report out a bill no

later than March 15th of this year to fund a limited transitional drug benefit program for those persons to remain on the program as of March 31, 1995.

I urge your support.

Subsequently, was passed and sent up for concurrence.

The following item was taken up out of order by unanimous consent:

On motion of Representative GWADOSKY of Fairfield,

the following Joint Order: (H.P. 406)

ORDERED, the Senate concurring, that the Joint Standing Committee on Human Resources report to the Governor of the State of Maine, the President of the State Senate, and the Speaker of the Maine House of Representatives, recommendations for a health insurance program for uninsured Maine Children based on the "Caring for Children Program" currently operating in several states across the nation. The recommendations may include legislation, if necessary; and be it further

ORDERED, that the Joint Standing Committee on Human Resources work with Blue Cross of Maine and the Commissioner of Human Services to design a health insurance program for children that includes a public-private partnership, the formation of a 501(C)(3) foundation to which tax deductible contributions may be made, and a provision that targets all contributions exclusively to health insurance and restricts these contributions from administrative costs; and be it further

ORDERED, that the Joint Standing Committee on Human Resources develop eligibility criteria and medical services that focus primarily on uninsured children in households that do not qualify for Medicaid and are close to the poverty line. At a minimum, these services must include primary and preventative health care; and be it further

ORDERED, that state agencies cooperate with the Joint Standing Committee on Human Resources and provide the Committee with timely information that it requires, including statistical and cost data; and be it further

ORDERED, that the Joint Standing Committee on Human Resources report its findings and recommendations, including any necessary legislation, no later than May 1, 1995.

Was read.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Fairfield, Representative Gwadosky.

Representative GWADOSKY: Mr. Speaker, Ladies and Gentlemen of the House: Approximately two or three weeks ago we began discussions on the issue of health care and how we were to provide it in the State of Maine. There seemed to be a consensus in many areas that we ought to be also not forgetting the many many children who are currently uninsurred in the State of Maine. We know that there are many children who come from families who are to poor to afford health insurance coverage but they may not be poor enough to qualify for Medicaid coverage so in fact they are falling between the cracks.

We began to look around the state. We contacted the National Conference of State Legislatures, contacted the Council of State Governments, and we are asking for models that we can take a look at as to finding an effective mechanism that might fit well for Maine and dovetail with our own efforts in the State of Maine.

We came across a program that was called Caring for Children that currently exists in 25 different areas, not necessarily 25 different states, but in 25 different areas. While these are different in each area, they have proved to be relatively effective in providing primary and preventative care for children of families who are, once again, falling between the cracks.

While each state is a little bit different for the most part, they envision the creation of a foundation that is developed. It is a 510C3 type of foundation which is tax deductible. Most often than not they are administered by Blue Cross Blue Shield. When they are done most effectively, Blue Cross Blue Shield does these at no administrative cost. So, when they are in fact soliciting funds from charitable trusts, foundations, corporations or individuals they can tell people who are donating that 100 percent of the monies will go directly to Caring for Children for health purposes.

The programs themselves are funded by donations from corporations, whether it be civic groups, foundations, grants or individuals — in many states such as Kansas they also have a general fund obligation so it becomes a true public private type of partnership, very unique for a state to find a new way to provide a care that I think we all agree exists in the State of Maine.

A range of benefits in these states are provided from well child physician exams to routine immunizations and there are a variety of different types of services that are provided but they tend to be diagnostic, they are designed to be preventative to assure that children are getting the type of care that they need early on in the process before they develop a serious illness and/or sickness that will become a future drain on the Medicaid system in and of itself.

The average cost of a premium for children has been much less than what you would imagine obviously with adults. It has ranged anywhere from \$212 a year to as high as \$700 in the State of Pennsylvania which has probably the cadillac of programs. We believe that for \$300 or so per year you will be able to cover more kids and get more coverage than we currently get in some of these existing programs.

Caring programs for Children have been successful in other states because they provide businesses, civic organizations and other individuals with incentives to make a contribution because the contributions are in fact tax deductible. In many states the contributions can be designated to a particular county or regional area so that you can be insurred the money goes to an area that is important.

All the donations are going to the cost of providing insurance to children and individuals can contribute and feel that they are having a direct impact on the health care for children.

The purpose of this order is to have the Human Resources Committee take action on this issue. The reason, the rationale that it is not in a bill form is because really and frankly I am less interested in my name or anybody elses name being on this versus getting care that I think we all agree is necessary for children. So, I am willing to take this, offer it as a tool for the Human Resources Committee to look at, to examine.

We have talked to ten or twelve states now, have information that we would like to provide the Human Resources Committee, allow them the opportunity to take a look at this program, see how it dovetails with other efforts that Commissioner Concannon may have to provide additional coverage for children and families in the State of Maine.

The experiences in the other states have been very promising to start, while some have only been in existence for two to three years, their experience has been as kids become healthier their parents have missed less time at work, the parents then end up getting bumped up higher in their own economic condition at their work place and eventually the kids are off the program in two to three years.

So, we think it is is a very exciting new way of looking at providing health care, it is a true

public/private type of partnership.

It may not work, frankly. We don't know if it will but I am entrusting the Human Resources Committee to take a look at it to see if it is a model. I am very optimistic about it myself. I hope that you will support it today and it can become part of the mix of items that we have within the Human Resources Committee to provide the type of health care we believe are important to Maine people.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Caribou, Representative Robichaud. Representative ROBICHAUD: Mr. Speaker, I would

pose a question through the Chair.

My question is this Order in the proposal that the Human Resources Committee study, is this designed to be an additional program to encompass those children currently not covered under any other program or is it such that the scope could include, where it found, that this idea would actually work to include and or replace some of the existing programs? What I am getting at is is it an addition to the governmental structure that we already have or is this a possible improvement/replacement that will incorporate more children?

The SPEAKER PRO TEM: Representative Robichaud of Caribou has posed a question through the Chair to any member who may respond if they so desire.

The Chair recognizes the Representative

Fairfield, Representative Gwadosky.

Representative GWADOSKY: Mr. Speaker, Ladies and Gentlemen of the House: I have deliberately kept the Order itself as vague as possible to allow as much flexibility of the committee in and of itself to provide whatever option they felt was necessary.

We know currently in the state of Maine that children between the ages of 0 and 1 are covered under Medicaid if their total household income is under 185 percent of the Federal poverty level. Children between the ages of 1 and 5 are covered if their total household income is less than 1/33 percent of the Federal poverty level and between the ages of 6 to 18 they are covered if they make more than 1/25 percent of the Federal poverty level.

So, we are covering some kids now by Medicaid and

by options.

This is attempting to pick up those who are falling between the cracks. So, it could be a program that could supplement any efforts that we have that Commissioner Concannon views that might work well in the State of Maine in terms of drawing down additional federal funds or applying federal funds towards. But, it is unique in that it is a public/private partnership aspect of it that would be

somewhat separate from the existing structure in that it does envision creating a separate foundation 510C3 type of foundation that hopefully will be administered by Blue Cross Blue Shield.

We have talked with Blue Cross Blue Shield, they are very excited about working on this mechanism at this point. They certainly can't give us a guarantee that they can provide the administrative costs until they have a chance to see the proposal itself as to how it might work, but the fact that they have been willing to very enthusiastically sit down and talk about it is a good sign (I think) and the direction I think we want to go towards the future.

Subsequently, the Order was passed and sent up for

concurrence. Ordered sent forthwith.

At this point, the Speaker resumed the Chair.

The House was called to order by the Speaker.

By unanimous consent, all matters having been acted upon were ordered sent forthwith.

On motion of Representative MURPHY of Berwick, the House adjourned at 1:40 p.m., pursuant to the Joint Order (S.P. 231), in honor and lasting tribute to the memory of Representative Mona Walker Hale of Sanford.
