JOINT RESOLUTION MEMORIALIZING THE PRESIDENT AND THE CONGRESS OF THE UNITED STATES TO SUPPORT THE LOW INCOME HOME ENERGY ASSISTANCE PROGRAM

WE, your Memorialists, the Members of the One Hundred and Seventeenth Legislature of the State of Maine, now assembled in the First Regular Session, most respectfully present and petition the President and the Congress of the United States, as follows:

WHEREAS, the federal House Appropriations Subcommittee has voted to eliminate funding for the Low Income Home Energy Assistance Program; and

WHEREAS, approximately 60,000 families in Maine receive aid through the Low Income Home Energy Assistance Program; and

WHEREAS, the Low Income Home Energy Assistance Program is crucial to the Maine families who rely on the federal program to help with weatherization costs for their homes and winter fuel bills; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge that legislation be enacted by the Senate and the House of Representatives of the Congress of the United States to restore funding for the Low Income Home Energy Assistance Program; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable William J. Clinton, President of the United States, the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States and to each Member of the Maine Congressional Delegation.

The SPEAKER: The Chair recognizes the Representative from Buxton, Representative Libby.

Representative LIBBY: Mr. Speaker, Men and Women of the House: I introduced this Joint Resolution to the House because I feel strongly that the Home Energy Assistance Program is a program that works. It is one of those few federal programs that we have that is specifically tailored to the northeast. It is a program that brings into Maine \$14.7 million. It serves over 60,000 families.

I have seen it work in the Town of Buxton and in the Town of Hollis. I have been to families homes that use the fuel assistance, the weatherization, and I can tell you from first hand experience, based on those visits, that this program, when properly run—and I think it is run very well here especially in the State of Maine—is a program that works. The program is in jeopardy at the federal level. The funding for the program was voted down in the House Appropriations Subcommittee at the federal level. It concerned me greatly.

It is the type of bill I think that can be a bipartisan effort. And, I want to thank all the members of the House and Senate (and there are several who signed on to this Joint Resolution) I would like to thank them for their understanding of the need for programs like this coming from the federal level. Not every program that is working

properly should be handed to the states to run, can cause some confusion and difficulties. I think this would be one example of that. appreciate your support on this Joint Resolution.

The diversity of agriculture in this state from full-time farmers with hundreds of acres to backyard gardeners and horse owners, all are interested in the future of agriculture in Maine and committed to working together towards that end.

At this time I would like to introduce Elaine Beal of Avon. She is with the Maine Farm Bureau and is currently serving as the State Women's Chairman and she has a presentation for the Speaker if the Sergeant-at-arms would escort her to the Rostrum.

Representative from Biddeford, Representative Joyce. Representative JOYCE: Mr. Speaker, Men and Women of the House: I request a roll call and would speak

to my motion.

According to the Department of Labor it is true that the unemployment fund will be depleted by 1998. It is also true that we cannot allow the unemployment system to collapse and thereby start borrowing funds from the federal government.

It is not true that the bill before us is the This bill, merely allows us to do nothing for two years and then face the same dire emergency that we should be dealing with right now. We need to put days of band-aid bills and hidden taxes behind us.

L.D. 842 has gotten this far with virtually no public knowledge or involvement. It was a complete surprise to most of the Labor Committee yesterday morning and there was very little testimony, opponents or proponents. You can use whatever term you want to describe this bill, in truth though, it is nothing, it is just another retroactive tax increase. We don't need any more retroactive tax increases in this state whether they be for business or the unemployed.

In 1993 the Department of Labor came to this body and requested a surcharge on employers and a reduction in benefits for the unemployed. It was granted to them. Two years later, (today) they are asking for the exact same thing. No properly run organization needs a government bailout every two years. I think there is a serious problem here. we continue to avoid the realities of true reform on employment issues, we may just as well pass a bill to help our best employers move out of state and get it over with.

Not quite two months ago we voted to provide \$100 million in FAME loan guarantees to attract new

business and to increase employment.

Now, today, we are going to vote to tax our existing businesses \$40 million. That satisfies absolutely no understandable test of fairness, in my view. This band-aid measure is going to take almost \$40 million out of Maine's economy in the next three years for the sake of Maine's small business and the unemployed who will suffer.

I urge you to vote your conscience and vote no on

this measure.

The SPEAKER PRO TEM: A roll call has heen requested. For the Chair to order a roll call. must have the expressed desire of more than one-fifth of the members present and voting. All those in favor will vote yes; those opposed will vote no.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative TUTTLE: Mr. Speaker, Men and Women of the House: We were all passed a memo on actually what this bill does. I think it pretty much explains about the present situation of the solvency of the unemployment fund. This bill -- it says here that Legislative action is needed to continue that solvency over the next few years. Essentially what the bill does is it reduces the weekly benefit payments by \$3.00, limiting the increase also of maximum weekly benefits from the present 100 percent level to a 94 percent increase which would amount to a \$12.2 million savings in the trust fund.

It also would assist dislocated workers — this program would provide an additional 26 weeks of compensation for displaced workers like those laid off at the Portsmouth Naval Shipyard and people within my community of Sanford and Biddeford and around the state.

As far as alternative base period, the provision allows the use of wages one quarter sooner for claimants that would otherwise not be qualified.

This bill also reduces the surtax for employers. Presently the surtaxes were seven percent in 1993, eight percent in 1994 and will be reduced to Maine employers, which is the concern of many of us, by four percent in the 1995 and 1997.

This also asks those workers of the state to have flat surtax on taxable wages for their first \$7,000 paid and this is paid by the worker. Essentially, no action is taken today the trust fund solvency will be in jeopardy by 1997 with complete insolvency in 1998. If the solvency plan is adopted indebtedness will be avoided to the year 2000. I think it is a fair proposal. It requires both labor and management workers and employers to work together to solve our solvency fund problem.

I think it is a common sense approach and I would

encourage your support.

The SPEAKER PRO TEM: The Chair recognizes the Representative from China. Representative Chase.

Representative from China, Representative Chase.
Representative CHASE: Mr. Speaker, Men and Women of the House: Briefly. The good Representative from Biddeford, Representative Joyce, is absolutely correct that two years ago the Department of Labor brought forward a similar bill because of the condition of the Unemployment Insurance Fund.

The problem is that when we have sustained unemployment. As you know, the fund is being used more than it has been in past years. When we have sustained unemployment employers as a class are paying in less because there are fewer employees upon whose wages to base the tax. There is less money. Frankly, less dollars going into the unemployment insurance fund and there are more demands of it. It is a counter cyclical problem and we do face it. It is real. I has little to do with government being run poorly and more to do with a sustained problem in our economy.

If you could read the statement of fact you would see that this is a bill based on the recommendations of the State Advisory Council and the Commissioner of Labor. The State Advisory Council is made up of representatives of employers both large and small employers who fairly/fiercely represent their constituents and, representatives of labor who fairly/fiercely represent their constituents. Nobody likes the bill. The office of the Executive, no doubt, does not like the bill. Certainly representatives of labor don't like the bill and representatives of employers don't like the bill. I don't like the bill.

I urge your support of this bill that no one likes on the basis that it is a compromise between all parties involved. Benefits are decreased, the tax is increased by I believe 4/10's of one percent and it is a way to get us through these times until there will be increase employment, more money going into the fund and fewer people who are legitimately drawing on the fund.

I urge your support of the bill.
