On motion of Representative LEMKE of Westbrook, the House reconsidered its action whereby the Majority "Ought Not to Pass" Report was accepted.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Lemke.

Representative LEMKE: Mr. Speaker, Men and Women of the House: I urge the House to vote against the Majority "Ought Not to Pass" Report.

I request a division.

Now that I have confused you, I might have a real

opportunity of passing this.

Mr. Speaker, I urge opposition, to our previous action for a number of reason. I believe that this legislature should enact a bill allowing recall of State elected officials. There are a number of reasons for this, I have seven. I did not have the wit to think up ten but I do have seven reasons.

Number one, this is a bipartisan bill. It has 15 Democratic cosponsors and six Republican cosponsors. In the past this legislation was defeated or did not get the necessary two-thirds vote for a Constitutional Amendment because it was perceived through a partisan prism. That should not be the case today. The people of the state want to see us show we can vote in a bipartisan manner and this is the opportunity.

Secondly, this is a substantive accountability bill. It definitely is not a feel good bill. To ask you to vote for it might not make you feel good, but I believe it is the right thing to do. Supporting this bill, which means voting against the pending "Ought Not to Pass" motion will show the people of the State of Maine that this Legislature is serious about accountability.

Thirdly, it makes recall applicable to us as well as those on the municipal level. Why is recall okay in your town or city perhaps today but not for us in Augusta? There is no compelling answer. This bill is the right answer.

Fourth, it corrects a major omission in our State Constitution. Recall is not a new innovation or an unproven measure. It was first enacted on the municipal level in 1903 and on the State level in 1908. Most states have it. Why not the State of Maine? Every citizen that I have talked about on this issue, and there has been much discussion of it, was surprised to learn that it is not already in our State Constitution. At the very least, give them a chance to speak on this issue by sending it to referendum.

Number five, this legislation is crafted to preclude, to preclude, frivolous or misguided use of the recall method. It is modeled on states which have stringent rules for requirement for petitions to hold a recall election in the first place and then for the actual recall election. You will not be recalled for how you vote on a particular issue,

whether it be auto emissions or abortion or the lobster license plate. That recall remains where it should be, and that is at the ballot box.

record that Number six, there is an historical proves that recall works. And, as tightly crafted as this bill is, it is not abused. This issue has been around since the beginning of the 20th Century, there is plenty of historical material to back up what I said, but in deference to the members of the House,  $\boldsymbol{\mathrm{I}}$ won't get into that unless necessary.

Number seven, which I consider probably the clincher, in 1921 a leading advocate of recall was recalled by the State of North Dakota. He was the Attorney General of North Dakota and he was recalled along with the Governor of North Dakota at that time. That Attorney General and that Governor went on to be elected to the Congress to be elected to the U.S. Senate. They went on to secure passage of the one of the key pieces of new deal legislation. It saved hundreds of thousands of family farms from closure. Now, that was the Lemke-Frasier Act. So, now you know the rest of the story. It might be attractive to you that you will have an opportunity to recall me, at least the public might, the bad news is that I might come back. But, all the rest of you would have an opportunity under a well crafted bill.

Now, I will grant you, in the history of Maine ese kinds of things have happened very very these kinds rarely. I would hope in the future history of Maine

it will continue to be very rare, if nonexistent.

I think as publicly elected officials we should be willing to step up to the bat, step up to the plate and say, yes, I am happy to be held accountable. understand what it means for the public trust that has been given me and I am more than willing to be held accountable to that trust.

I agree with Representative Daggett that we will be held accountable at the ballot box. That is certainly true. But, unfortunately there are occasions that come up that we need to be held accountable at a earlier point than at the ballot box.

I think it is important that if these issues do come up that we can be held accountable right then and rather than cast a shadow over the electoral

The Chair would remind members that the current item before the body is the acceptance of the "Ought Not to Pass" Report and the Chair would encourage members to confine their comments to acceptance of lack of acceptance of the Majority "Ought Not to Pass" Report.

The Chair recognizes the Representative Portland, Representative Townsend.

Representative TOWNSEND: Mr. Speaker, Men and Women of the House: The reason I rose to ask the question was that I perhaps am misreading the bill as it stands. But, Section 5A, or under line 18, specifies that in order to recall an official those gathering signatures must -- the signature must be signed by a number of voters qualified to vote in a recall election of at least 35 percent of the number of votes cast in the preceding Gubernatorial election. That would suggest to me that in, for instance, my small district of 8,800 to 10,000 voters those who wish to recall me would have to gather a number of signatures equal to 35 percent of the number of votes cast in the Gubernatorial election? It does not specify in that district and I am confused about that. Perhaps someone could address

The SPEAKER: Representative Townsend of Portland has posed a question through the Chair to any member who may respond if they so desire.

Representative The Chair recognizes the Westbrook, Representative Lemke.

Representative LEMKE: Mr. Speaker, Men and Women of the House: In response to the good question from the Representative from Portland, the amendment to this bill does rectify a problem in the original one. Obviously it will be the 35 percent eligible your particular district Gubernatorial election.

The amendment provides for recall of county officials as well as state officials. It clarifies the number of signatures needed to initiate a recall proceeding which addresses the question of Representative Townsend and it adds as is necessary a fiscal note to the Resolution.

SPEAKER: The The Chair recognizes

Representative from Bangor, Representative Saxl. Representative SAXL: Mr. Speaker, Men and Women of the House: I urge you to uphold the position of the Majority Report. To me this motion for recall is redundant. In the Constitution we already address this question by removal by impeachment and address. And, if you will allow me I will read to you, "Every person holding any civil office under this state may be removed by impeachment for misdemeanor in office and every person holding any office may be removed by the Governor on address of both branches of the Legislature." It seems to me that we already take care of this. But, the problem, in all likelihood, the process itself to begin and really effect impeachment or recall would not fit in with the time requirements so that an election probably would take care of it and the matter would be taken care of at the ballot box in any case.

So, don't reopen the Constitution for something which is essentially already there by another name.

The SPEAKER: The Chair recognizes the Representative from Thomaston, Representative Simoneau.

Representative SIMONEAU: Mr. Speaker, Ladies and Gentlemen of the House: I cosponsored this bill with Representative Lemke. I would like to tell you why. I philosophically, I feel that the people of Maine should be given the opportunity from time to time to change their Constitution. Now this isn't a question of whether you are in favor or against recall. Now, in two elections I stuck to two or three basic things that I stood for and one of them was to sponsor legislation that would give the people of Maine a chance to change their Constitution as for the normal running of government. In the last election I had one of three in the state that had two incumbents facing each other because of the new districts. My opponent was dead set against sending this type of legislation out to the people and I am all for it. It became a real issue in the race.

I think that this is basic to our government. The people of Maine cannot change their Constitution unless we give them a chance to do it. This is not a frivolous bill. This is not a frivolous idea. I feel that we should return the trust that they give to us to them. To give them an opportunity to decide if they want to in fact have this as part of the process.

I urge you to follow Representative Lemke's light. The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Lemke.

Representative LEMKE: Mr. Speaker, Men and Women of the House: I would like to briefly respond to the issues that were raised by the Representative from Bangor.

Number one, the issue is often raised that time requirements and whether it would be applicable within the time frame we are in the Legislature. The answer is historically is clear, yes, it is applicable and it works in the majority of the states of this

country where it is applied.

Secondly, in terms of the issue of impeachment as being an alternative, the fact of the matter is that the impeachment process has been utilized seldom in the State of Maine, seldom. In fact, you can count it on one hand the number of times it has been utilized. One of the major reasons for that is that it is stated so broadly that there has been a tendency to even use it. You might be interested to know that in the State of Maine, unlike in other states, you can impeach a person for no specified activity but simply for a misdemeanor.

Secondly, on this issue, I agree with the Representative from Thomaston, there is a broader issue here. And, the broader issue is whether we give the people, the people directly, the opportunity to deal with us or we keep it linked within the present system, which is as I have just defined, is

not workable. I think this is a basic accountability bill. I also think it democratizes the process. There is absolutely nothing new or innovative about this, it already exists, it already works. The record is that when there are stringent requirements in terms of the petitions necessary, 35 percent of the people who voted in the election, the preceding election for the office, the high level, the high level of threshold requirement precludes, historically precludes, frivolous usage.

Secondly, I would point out in this bill there is an added protection. There have to be statements. There have to be statements of the reason for recall as well as the reasons against it when the recall election is held. It has to be tightly within the areas of basic misconduct to be there, to be on the ballot. This would establish the second highest threshold in the United States. The highest being 40 percent in the state of Kansas. We will be 35 percent. So, I believe that this is a rationally crafted bill based upon historical experience which fixes a major omission in the State Constitution. It will not mean that the minute this is passed hundreds of people are going to be subject to recall. That is not the record in the states where it exists. But, there will be a mechanism, there will be a mechanism if in fact you have those rare occasions where a recall is felt necessary by the people.

So, again, I urge you to vote against the pending motion so that we in this legislature can send a clear message that we stand up for accountability here.

The SPEAKER: The Chair recognizes the Representative from Falmouth, Representative Reed.

Representative REED: Mr. Speaker, I would pose a question through the Chair. A question to either Representative Lemke or anyone else who could answer.

Lines eight through ten of the bill state that a civil office holder is subject to recall by the legal voters of the state or of the political subdivision from which he or she was elected. That language seems to suggest to me that a statewide recall effort might be mounted against a particular district office holder such as a member of this body or the other body. I wonder if that is the intent of the sponsors or if I am misunderstanding the language? I would appreciate a response.

The SPEAKER: Representative Reed of Falmouth has posed a question through the Chair to any member who

may respond if they so desire.

The Chair recognizes the Representative from Jonesboro, Representative Look.

Representative LOOK: Mr. Speaker, Men and Women of the House: This is the third time in the years that I have been here that I have debated the recall bill. I hope that you will vote to support the

"Ought Not to Pass" position.

There are many instances that over the years we have observed with office holders that perhaps we don't necessarily agree with and we get real upset at perhaps what their performance has been. However, the ballot box is there, it does work. I think in my own experience I have seen about three times, not at the state level, but down at the local levels, and I mean levels (municipal and count) where I personally felt that certain persons should be subject to recall. However, recall was not there and I am glad looking in retrospect that it was not there. The matters have been settled by the ballot box. The issues that came up have been resolved and I think

that this can happen with the individuals using their

right of vote to do this.

It is indeed a serious issue. It is an issue that can put a stigma on a person that may never be lifted. They may be found guilty of something that really wasn't as accurate as it was intended to purport. But, let me tell you the most powerful thing we have in our method of government is the individuals right to cast their vote and let's keep that where it belongs.

Many times in a petition people will automatically sign it without being aware of exactly the impact that the wording has. I caution you on this and ask that you continue to support the "Ought Not to Pass"

position.

Representative AHEARNE of Madawaska, requested a roll call on the motion to accept the Majority "Ought

Not to Pass" Report.

The SPEAKER: A roll call has been requested. the Chair to order a roll call it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was

ordered.

The SPEAKER: A roll call has been ordered. pending question before the House is acceptance of the Majority "Ought Not to Pass" Report. Those in favor will vote yes; those opposed will vote no.
