Representative MURPHY: Thank you Mr. Speaker,
Ladies and Gentlemen of the House: This piece of legislation, I put in and I did it for a reason. had an incidence in Maine where a person who lived in Massachusetts was coming to his summer home in Epping, New Hampshire.

What this legislation really does is non-resident of Maine buy liquor and come into the state of Maine with some liquor in the trunk of his car. They come into Maine to do business. That is not happening down there. No matter who comes in, Maine is a tourist state. give out is not a good one. The perception that we

This gentlemen from Boston, Massachusetts on his way to his summer camp stopped at the Portsmouth Liquor Store to buy a bottle of wine. When he got in there, he found a thirty percent sale. So he bought four cases of wine for the summer. When he came out of the liquor store and got in the car his wife said to him, "I would like to go to South Portland to the Maine Mall to shop". That was the wrong decision.

In the <u>Boston Globe</u> there is a picture of him standing before our sign in Portsmouth that says North to All Maine Points and the arrow is this way to 95 and then it says Exit 6, Woodbury Avenue, Portsmouth. He made the wrong turn and he came to Maine. He was coming into Maine to do business. He was not coming into Maine to stay over night. He is not a resident of Maine. He had nothing to do but come into this state to leave some money for sales tax to us. When he did, the agent that we have sitting down there, on the border of the Berlin Wall that we have created between Maine and New Hampshire, arrested him.

When you cross you have forty-eight states, but when you come into Maine we are the forty-eighth and we are not a part of the rest of the country. We have agents on the border who are watching what you buy, whether you are a Maine resident or whether you are just somebody coming to Maine to do a business. When he crossed that border he was stopped and they confiscated forty-seven bottles of liquor. He went to court. He had to pay a fine and he wasn't very

happy about it.

I don't imagine that gentlemen will be coming to Maine to do anymore business. This is the perception that we are giving out there. There is no sign on the Kittery Bridge or any one of the Kittery Bridges saying if you come into Maine, do not bring more than one gallon of alcoholic beverages in the trunk of your car. We have tourists who come here. I have guests who come in who have liquor in their car. If they are stopped and they are found to have more than a gallon, it is not a real good welcome for people who want to come into this state and spend their vacation.

This gentlemen didn't want to stay overnight. wife wanted to do business. I am sure she doesn't come to Maine shopping anymore with him. They went back to Bostll and he hit the newspaper. This is the

picture and the big article that was in the Boston Globe, which is a very widely distributed newspaper in the state of Massachusetts. Here we are spending hundreds of thousands of dollars in advertising, Come to Maine. In our advertisements we don't say, don't bring any liquor with you, because you will be in the Maine Court.

This is the point I am trying to make. this bill "An Act to Allow Nonresidents to Transport into the State Liquor Purchased in New Hampshire" allows people to stop at the New Hampshire Liquor Store and continue into Maine to do business. If they should make a mistake and stop into the liquor store and come into Maine now and do business, we pick them up and we fine them. I think it is a good bill. I think it is time we sent a message out there. We want you to come into the state to do business. If you do happen to stop in New Hampshire and do some business, that is ok, but we do welcome you into Maine to do business.

That is the purpose of the bill. I would hope that you would not vote for the "Ought Not to Pass", but you would go on and vote for the "Ought to Pass". Just to send a message that we welcome people and we want them in the state of Maine to do business with us. We will not have them in our Maine Courts. We will not fine them. We will tear down the Berlin Wall that we have built up between Maine and New Hampshire, because we do not want one little cent to get out of this state that we think should be spent in Maine.

The more we pass these laws and the more we jump people coming in, the more we are hurting ourselves. We are losing tax dollars that we would be getting if we were a little more congenial and get along with our neighbors a little bit and didn't quite act like when you come into Maine you either do business here or we will have you in jail. I am surprised we didn't put him in jail. We didn't do that. We did let him go, but we did fine him. The man wasn't very happy about it. There are other cases that haven't been very happy either.

This is the United States and I believe we have a right to spend our money any place in the United States that we so choose. In fact, I think I am free, I think I can spend anywhere in the world I choose, but not in Maine. You spend it in Maine or you are fined. I hope you will support the "Ought to Pass" Report and vote against the "Ought Not to "Pass" Report so that we can have people come into the state and enjoy our state and not have to be afraid of being stopped, harassed and having whatever they have in the trunk of their car taken away from them and taken to jail. Thank you.
The SPEAKER: The

The Chair recognizes Representative from Saco, Representative Nadeau.

Representative NADEAU: Thank you Mr. Speaker, Men and Women of the House: I think there is a couple of facts that you should know about. One, this is probably the most important, we are the Maine Legislature. We are not the Massachusetts Assembly. We are not the New Hampshire Assembly. We are the Maine Legislature. That is the first point. I don't think we should go out of our way to try to penalize out-of-staters, but we don't need to be fooling around with policy to appease out-of-staters. is the first point.

Second, currently you are acceptable quantities of liquor. are allowed legally Now the number forty-seven, forty-seven bottles of liquor, was just brought up to you. I think forty-seven is a little

more than adequate for most people.

Thirdly, we are here to try to establish policy. We are not necessarily here to try to take care of individual constituent problems or individual citizen

problems where ever they may eminent from.

With those three points I will say that, Representative from Berwick obviously thought she had a strong idea and obviously thought it was worthwhile legislation, however, I do want to remind you this is a twelve to one committee recommendation and I want to assure you that all the concerns that were presented to you five minutes ago were, in fact, presented to the committee and were rejected. I appreciate your consideration.

Representative MURPHY: Thank you Mr. Speaker,
Ladies and Gentlemen of the House: I did intend to speak twice on this one. I realize it was forty-seven bottles. The gentlemen bought it because he was going to have it for all summer at his home. He came into Maine to do business. He is not a constituent. I do not know the gentlemen. I have never met the gentlemen.

I run a little guest house, as most of you know, and it was my guest who cut this out. People who come to my place in the summer cut this out of the Boston Globe and sent it to me. I have a letter they wrote with it also. That is why I put this bill in. I didn't put it in to help this gentlemen. I have never seen him. All I knew was his name and his picture in the paper. I do not know him. He is not a constituent or friend or a friend of anybody I know.

I do think our tax policies are wrong when we do these things. Our perception of the state of Maine is wrong when a person can't come into this state to do business without cleaning out his trunk. I mean it is like going from East Germany to West Germany during the war. You just couldn't do it. That is what we are doing, we are saying don't come into Maine. I feel very strongly about it. I feel it is a wrong perception that we are sending out. We don't want you in this state. I request a division.

The SPEAKER: The Chair recognizes Representative from Auburn, Representative Dore.

Representative DORE: Thank you Mr. Speaker, Ladies and Gentlemen of the House: I was not here for the debate on Thursday night for the property tax exemption, the doubling of the exemption, for church parsonages.

I understand there were few and far between who were not on the side of God that evening and they suffered an overwhelming defeat at the hands of this body. I want you to consider this amendment and I want you to consider it carefully. When you double a property tax exemption the state has a legal obligation, according to state law, to pay for fifty percent of that cost. That is the fiscal note you have looked at so far in this bill. Who pays for the other fifty percent? That parsonage wants the Fire Department to come when they call. They want the Police Department to come if here is vandalism. People in the parsonage, if they send there kids to public school, they want that public school education available for their children.
We pay for that. All of us. It doesn't matter if

we go to that church or any other church. I want you to think about something else and some people may consider this a problem. The non-church going people are over fifty percent of your population. Some of you may think that is where all the trouble begins. That is the truth. Those are your voters and constituents and many of them don't belong to any church. I would suggest to you that very few of them belong to churches with parsonages. I am not going to read debate on whether or not parsonages ought to have an exemption. They already do have an exemption, but this doubles their exemption. have an exemption.

Here is what I am proposing we do. We put our money where our mouth is and instead of talking the talk, we walk the walk. The way we do that is to fund one hundred percent of this exemption. You can either be on the roll call now saying no, we are going to double the exemption and the towns are going

to have to bear fifty percent of the cost of doubling the exemption or you can be on a roll call that says we think this is so important and what the people and parsonages do for their communities is so vital that the state should bear one hundred percent of the cost.

It seems to me the responsible thing to do. you believe it is so important to have a doubling of a parsonage exemption this year, then we pay for one hundred percent of doubling that exemption. I hope you will join me and vote for that amendment.

The SPEAKER: The Chair recognizes Representative from Berwick, Representative Murphy.

Representative MURPHY: Thank you Mr. Speaker. Ladies and Gentlemen of the House: Last Thursday night we debated this bill and I thought we debated it well. I do not believe there is anybody in any town who minds the difference in their tax bill to give exemptions to the parsonage and the rectories of

True, not everybody goes to church, but most people have a sympathy for churches and most people will tell you I don't go every Sunday, but I am a Catholic, Baptist, Methodist, they certainly relate to a church. When you are taxing the churches, who are you taxing? You are taxing the people in that community. They will pay for that on Sunday by giving money to the churches or pay for it otherwise.

I know that the churches in my community have given so much to the community. They let us use the rooms for Girl Scouts, use their kitchens to put on dinners for Girl Scouts. For ten years as a Girl Scout leader, I met every Tuesday night during the school year in Our Lady of Peace Church. I had full use of the kitchen and other rooms. We used that at our own discretion. They never charged us one single penny. We went in and started charging tax on a \$20,000 dollar exemption on the rectory and to the parsonages in the town.

Other Girl Scout leaders met in the Methodist Church and they were not charged. They had the same use of that church. If we had to pay for those rooms, the electricity, heat and gas we used to make meals so we could make money, we could not have done it. I think it is wrong when Maine is the only New England state that doesn't give a good tax exemption

to the parsonages.

Three of the New England states give a total exemption and Massachusetts gives a \$90,000 exemption and I think Vermont gives \$75,000. We are giving only \$20,000. I would hope that we would all stick with what we did the other night and pass this bill and defeat this amendment. This is not hurting any community in this state and I believe if you put it out for a vote of the people they would say, We don't

mind supporting our churches.

I have never had anyone tell me that they ever minded supporting the churches in our community, whether it was for police. We don't need police in our churches. We don't call the police in our People don't act that way in churches. our We have been fortunate, one has never been vandalized. One has never caught fire. We did have lightening strike the steeple of one of our churches. It is a minimal cost for what the churches do for our town. I feel as the people of that community, we should give exemptions to those

Please vote against this amendment and I would like a roll call. Thank you.

First, give them the exemption for the parsonage and you can pay it in property taxes. Everyone else in town will pick it up in property taxes. Secondly, you can shift it over to the state. They will pay it and you will pay the state. Lets face the facts. All you have to do is make up your minds which way you want to pay the tariff. You are going to pay it anyway. Make up your mind what you think is the easiest way and vote accordingly. Thank you.
The SPEAKER: The Chair

Chair SPEAKER: recognizes Representative from Nobleboro, Representative Spear.

Representative SPEAR: Thank you Mr. Ladies and Gentlemen of the House: Speaker Representative from Auburn, Representative Dore says that we are doubling the exemption. That is true. We are moving the exemption from \$20,000 to \$40,000 dollars, but you must remember that these parsonages are anywhere from \$60,000, \$80,000, \$100,000 and \$150,000 dollars. Therefore the towns are still getting a lot of tax revenue from that property to take care of fire, police and all the other things that go along with that. I would recommend that we vote against the pending motion and go on with the bill we passed the other night. Thank you.

SPEAKER: The The Chair recognizes

Representative from Auburn, Representative Dore. Representative DORE: Thank you Mr. Sp Speaker. Ladies and Gentlemen of the House: I just want to clarify something, because there seems to be misunderstanding here. Churches are tax exempt. All religious affiliations are tax exempt, whatever you

This is parsonages and this is part of compensation package. You compare your minister who doesn't have a parsonage with your minister who does have a parsonage and invariably the minister with the parsonage gets paid less, because that housing is part of the compensation package. That is ok. It is kind of nice to have a home right next to the church. I am not killing this bill. I heard about the roll call the other night, I wasn't here to see it, but this is not an attempt to kill the bill.

Put your money where your mouth is. You say, "Well it doesn't matter." I will tell you what happens if you vote against the amendment. If you vote against the amendment, you have doubled the exemption and you have only paid for half of the bill. If you believe this is the right thing to do, pick up the whole check. This is your meal. This is your restaurant and if you want to order the hot fudge sundae, I have no objection to that. You can vote for this and you are still supporting church exemptions and you still are supporting your You are supporting church exemption doubling and you are supporting your communities by paying one hundred percent for doubling the exemption for parsonages. I think it is a win, win situation. You decide for yourself.

SPEAKEŘ: The The Chair recognizes the Representative from Bangor, Representative Stone.

Representative STONE: Thank you Mr. Speaker, Ladies and Gentlemen of the House: I stand to support Representative Dore's amendment. As a Representative from a regional service center, I believe any tax that adds to the property taxes in any community is inappropriate. Every community I know of is strapped for money and I think this is a good amendment. Thank you.

The SPEAKER: The Chair recognizes the Representative from Thomaston, Representative

Simoneau.

Representative SIMONEAU: Thank you Mr. Speaker, Men and Women of the House: I would like to correct my good friend from Auburn, Representative Dore. You are right. Parsonages are part of the compensation package, but a minister of the gospel who receives cash income in leu of the parsonage receives the same tax break. It is not taxed to that person in any event. Thank you.

The SPEAKER: The Chair recognizes the Representative from Corinth, Representative Strout.

Representative STROUT: Thank you Mr. Speaker, Men and Women of the House: Lets go back twenty years ago and look at what the exemption allowed churches and what it is allowed today. Lets look twenty years ago what the valuations were to your community and what it is today.

The exemptions on these parsonages haven't changed. I have been in municipal government since 1979 so I know it was before that. I will give you one municipality. Our evaluation in 1979 was \$18,000,000 dollars. Today it is \$64,000,000 dollars. That church parsonage evaluation is still \$20,000 dollars. The time has come when the church parsonages in this state where the exemption should be increased.

You can hear the lady from Auburn say that she is not moving this amendment to kill the bill. Lets be honest. That is exactly what she intends to do. You know that if you put one hundred percent reimbursement on this. Once it gets to the table it is dead. I am willing to take that chance and split part of the cost. I think it is time that we increase the exemption on church parsonages and I think it is time for the municipalities to absorb part of the cost.

There is nothing wrong with bringing us up to the twentieth-century and lets pass the bill without the amendment.
