Dear Mr. President:

The law establishing the Maine Judicial Compensation Commission required the Commission to make its biennial report "no later than December 1 of each odd-numbered year..." Because the Commission will not function until all appointments to the Commission are completed, a report for 1995 will not be forthcoming. In hindsight, it is clear that the time frame between the establishment of the Commission and the initial reporting deadline was overly ambitious. Given the inevitable difficulties of the appointment process, a different schedule will be required.

I would hope that at the special session in January, a simple amendment might be considered to establish a different reporting date. I will ask the Compensation Commission to consider such a revised schedule, and a proposed statutory change to reflect

it, as an early item of business when the Commission is finally formed.

This letter is to notify the Legislature that I have accepted and will implement the recommendations of the Productivity Realization Task Force relating Department of Economic & Community the Development, with the exception of recommendations that require legislative approval.

The recommendations I am accepting today include the elimination of 6 positions, the reclassification of 6 positions and combining 2 positions as recommended by the Task Force. All aspects of the Department's reorganization plan will be implemented except for the merger of the Offices of Tourism and Community Development, the shift of the Office of Energy Conservation into the Office of Business Development, and the shift of the Office of Economic Conversion to the newly created Office of Tourism and Community Development. Other parts of the proposal requiring legislative approval include the transfer of two employees out of the Department, implementation of FY '97 "All Other" savings, and the elimination of two positions.

Consolidation of the Department's personnel and computer systems functions in the Department of Administrative and Financial Services has already

received legislative approval.

The recommendations contained in the Department's reorganization plan will result in a savings to the General Fund of \$414,250 over the biennium. The Department of Economic & Community Development has met its goal of improving the delivery of services to the citizens of Maine while improving productivity. The enclosed letter from Commissioner McBrierty provides detailed information about the Productivity Realization Task Force recommendations for the Department. This letter is to notify the Legislature that I have accepted and will implement the recommendations of the Productivity Realization Task Force relating to the Department of Environmental Protection, with the exception of two actions that will require

legislative approval.

The recommendations affecting the Department of Environmental Protection that I am implementing today will result in a savings over the biennium of \$1,237,377 from all funds. This figure does not include general fund reductions of \$402,393 over the biennium, associated with DEP staff transferred to the previously approved Administrative Services Center. There is a likelihood that the Department may realize more than its estimated cost savings, through earlier implementation of Task Force recommendations and the potential for unemployment insurance and other separation costs to be lower than projected.

The Department of Environmental Protection has met its goal of improving the delivery of services to the citizens of Maine while improving its productivity. The enclosed letter from Commissioner Sullivan additional provides information about Productivity Realization Task Force recommendations for the Department of Environmental Protection. This letter is to notify the Legislature that I have accepted and will implement the recommendations of the Productivity Realization Task Force relating to the State Planning Office. No statutory changes are required.

The recommendations I am accepting today include the elimination of three positions. These are in addition to a fourth position which was previously given up as part of the creation of an administrative cluster at the Department of Administrative and Financial Services, in which the State Planning Office is participating.

The recommendations will result in an additional savings of \$311,708, including \$138,795 in FY 96 and \$172,913 in FY 97. This will bring to 15.1% the reduction in the State Planning Office's general fund

The State Planning Office has met its goal of maintaining a high level of services to the state and its decision-makers—in economic analysis forecasting, in strategic planning and performance-based budgeting, and in land, water, and energy policy—while improving productivity. It has done so, in part, by moving out of a traditional organizational hierarchy—which depends upon earmarked supervisory personnel—and into a team structure, in which project personnel coordinate self-directed teams. This system has enabled the Office to absorb two programs sent to it by the Legislature in the last session (the community planning division of DECD and the remnant of the Waste Management Agency), plus a major new duty in the coordination of the state's strategic the coordination of planning/performance budgeting, with

supervisory personnel.

In Memory of:

Clifton "Clif" Reynolds, a pioneer in Maine broadcast journalism and a television personality at WCSH-TV in Portland for 40 years. Mr. Reynolds anchored the morning news and hosted a variety of shows including the popular "People, Places and Things"; (HLS 764) by Representative LABRECQUE of Gorham. (Cosponsors: Representative REED of Falmouth, Senator ABROMSON of Cumberland)

Representative from Gorham, Representative Labrecque. Representative LABRECQUE: Mr. Speaker, Ladies and Gentlemen of the House: In a suburb of Tucson, Arizona on Wednesday, December 27, after a four month battle with cancer, Clifton E. Reynolds died.

Clif Reynolds, the well known radio and television personality who's life has touched many. Clif's 40-plus years in broadcasting had it's beginnings in the late 1940s when he auditioned for and was hired by radio station WGUI Bangor. Clif was not even aware that this broadcasting career was tailored just His work literally became his way of life for him. and he loved it.

When television had it's beginnings, Clif was watching that closely and in 1955, he moved to the greater Portland area having been hired to do live commercials for television station WCSH. He would spend the next 30 odd years with Channel 6. Little did this small struggling station, at that time, realize what a leader they had among them, nor the mark he would leave.

The first of many innovative ideas that Clif put into place was the logo, early morning news programs. How many of you remember starting your day with Clif and a cup of coffee, catching those first glimpses of local breaking news? I heard one of Clif's colleagues say that Clif had interviewed everybody in Maine. Well, perhaps he had, because everybody seems to know him. He didn't interview people as we have come to know interviewing today. He did not shove a camera or a microphone in your face nor ask offending questions. Rather, he talked with you, which put you immediately at ease and you were not aware that you were on television. From these interesting conversations we learned unique things about people, places and things. This program too was the first to get television out of the news room and on the road.

Clif was one of the last true original pioneers in Maine broadcast journalism. Seven years ago, retired wintering in Arizona and summering in Maine. We still heard his voice doing those commercials. have given you a very brief look at Clif's public life. He came into my life on a personal level when he married my sister. However, I never could detect the line between his public personality and his private one. It did not exist.

Clif was what we all got and what we all saw, honest, straight forward and especially witty. He was a caring and loving husband, father and friend and he will be dearly missed. Another colleague amply memorialized Clif by saying quote, "We will remember Clif with a smile." His passing has left a very large hole that will in time be filled with those many smiling memories. Thank you.
