Dear President Butland and Speaker Gwadosky:

In 1994, the Legislature enacted P & S Law 1993, Chapter 80 that established a study group on energy and the environment. The study group consisted of the Chair of the Public Utilities Commission, the Director of the State Planning Office and the Commissioner of Environmental Protection. Chapter 80 required this study group to provide, by January 1, 1995, an interim report to the joint standing committee having jurisdiction over utility matters outlining its progress in completing its study on energy and the environment. On behalf of the study group, I am sending to you a copy of our interim report because committee assignments have not been made to date. In addition, I have sent a copy of the interim

SENATE ORDERS

On motion by Senator **CAREY** of Kennebec, the following Senate Order: (S.O. 10)

ORDERED, that Senate Rule 25-A be enacted to read:

25-A. Unless by consent of 3/5 of those members present and voting, no item may be removed from the unassigned table without one legislative day's notice being given in the calendar.

Which was READ.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Carey.

Senator CAREY: Thank you Mr. President, Ladies and Gentlemen of the Senate. This is an effort to give people a notice, and I don't care whether they are Democrats, Republicans, or Independents, to give them a notice so they can prepare for something coming off the Table on the following day. I know that Leadership has always reserved for itself the privilege of tabling matters unassigned, but many times the message doesn't get back to those of in the trenches that it is, in fact, coming off the next day; and therefore, many times we will either not be prepared or will have been involved in an absence from the Senate. This will at least give us the notice that I believe we really all deserve. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Kieffer.

Senator **KIEFFER:** Thank you Mr. President, Ladies and Gentlemen of the Senate. I have had a little problem trying to understand the purpose of this Order in light of the cooperation that has existed here for the past two years. During that period of time

really saw no abuse of this privilege that has been granted to leadership and certainly there wasn't any abuse of it in the last two years and I would not anticipate that there would be any this year. I guess I don't see any real reason for this. I would like to pose a question through the Chair, is there something here that I am missing? I would pose that question to anyone who would care to answer it. Thank you.

THE PRESIDENT: The Senator from Aroostook, Senator Kieffer has posed a question through the Chair to any Senator who may care to respond. The Chair recognizes the Senator from Kennebec, Senator Carey.

Senator CAREY: Thank you Mr. President, Ladies and Gentlemen of the Senate. I can understand the hesitation that the Majority Leader has in possibly supporting this measure. However, there are some of us who are not as healthy as others are, number one. Secondly, there are some of us, myself included, who are not always prepared to present arguments for or against something if, in fact, it comes off the Table on a moment's notice, which it obviously can. Therefore, I would be much more comfortable and I know that the new members of the Legislature, the Senate in particular, would be a little more forewarned as to what is coming up. Therefore, I would sincerely ask that we pass this Order on the Senate Rules. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Hanley.

Senator HANLEY: Thank you Mr. President, Ladies and Gentlemen of the Senate. I would like to pose a question to my good friend from Kennebec, Senator Carey. I, too, am a firm believer in reforming rules and having them fit in where applicable. My question to the good Senator would be, why is this limited to just the Senate Rules? Wouldn't this also be appropriate to place into the Joint Rules? If so, why wasn't it? Thank you.

THE PRESIDENT: The Senator from Oxford, Senator Hanley, has posed a question through the Chair to any Senator who may care to respond. The Chair recognizes the Senator from Kennebec, Senator Carey.

Senator CAREY: Thank you Mr. President, Ladies and Gentlemen of the Senate. I have absolutely no objections. I am concerned with what may be happening in this body but if we could get support for this in the Joint Rules I would have absolutely no problem and would support such a move. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Hanley.

Senator **HANLEY:** Thank you Mr. President, Ladies and Gentlemen of the Senate. I would encourage my good friend from Kennebec, Senator Carey, to then pursue another avenue, as far as to the Joint Rules, rather than to the Senate Rules. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Carey.

Senator CAREY: Thank you Mr. President, Ladies and Gentlemen of the Senate. Sensing a feeling of support in this matter, I would ask to withdraw the

THE PRESIDENT: The Chair recognizes the Senator from York. Senator Lawrence.

Senator LAMRENCE: Thank you Mr. President, Ladies and Gentlemen of the Senate. I would simply point out that the purpose of the Joint Rules is to cover the flow of legislation between the two bodies. It is my understanding the Senate Rules apply strictly to the procedure and the control of legislation within this body. Thank you.
