THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Harriman.

Senator HARRIMAN: Thank you, Mr. President. Good afternoon, Ladies and Gentlemen of the Senate. It's good to see all of you here again. If you would, please allow me just a few moments to share with you my firsthand observations and thoughts about the crucial decision before us. As you know, confirmation of the Public Utilities Commissioner is the last step in the journey that puts a new Commissioner outside of the Legislative and Executive Branch decision-making process. In my opinion, this position is more powerful, in many respects, than a judge. I say this because the PUC Commissioner not only passes judgement on issues that come before it, it also writes the rules that guide their policies, procedures and philosophies. It is for these reasons that I offer the following comments for your consideration.

Let me begin by saying that, from my position as Senate Chair of the Business and Economic Development Committee, as a small business owner, and as a member of the Utilities and Energy Committee, utility rates are one of the major factors that continue to inhibit our economic resurgence. Past PUC actions has put Maine's economy, and our electric utilities, in

harm's way. Because I believe so deeply that fixing these mistakes is crucial to our future, I wrote to Governor King's Chief Operating Officer way back in June, expressing my hope that the nomination for PUC Commissioner would be someone from Maine. I hoped it would be someone who understood our economic and geographical diversity, and someone who could bring the experience of working in, and with, our economy. When Miss Hunt was introduced to the press, and before the Governor formally posted her name, Senator Carpenter and I offered a letter directed to Governor King, asking that he reconsider and to meet with us to discuss our concerns. That letter went our concerns. That letter went unanswered. However, before the confirmation hearing, I did spend a couple of hours with Miss Hunt. We discussed a wide range of things, including her background and her experience. I came away from that encounter genuinely liking Heather Hunt. Heather is poised, she is sincere, she is bright. Further, I had a chance to meet with Governor King; and, of course, he is confident that Heather is the best choice. As we talked, he, too, offered that he had some of the very same concerns about her experience that I had; but after talking with her at length, she was, in his view, going to be a star in the regulatory field. All he asked of me was that I keep an open mind and judge her on the responses she gave to the questions we asked. I have kept my promise to Governor King. In fact, I have approached this decision with a desire to find reasons to support her nomination, not to look for reasons to justify voting against her. During the day-long hearing we learned, in detail, about the process the Governor used in selecting Miss Hunt. As a foundation, Mr. Hewitt, from Governor King's office, asserted that the Governor believes that this is one of his most important appointments for his term. When asked, Mr. Hewitt stated that Miss Hunt's resume rose to the top, one of twelve out of one hundred and eighty five, or so, applications; because her resume was concise and that Chairman Welsh knew of her work in Connecticut, not because it possessed overwhelming skills and experience as compared to all others.

The selection criteria used by the search committee included a list of thirteen items. In no particular order they were: experience in electrical regulatory issues, oriented toward economic development; commitment to Maine; supporter of competitive markets; strong professional personality; knowledge of the benefit of old style regulations; not overly dependent on staff support; experience in the regulatory process; advanced degree preferred; a proven implementer; decisive; not trapped in precedent; and a concensus builder but comfortable in an adversarial situation. Yet the ad that appeared in publications did not mention anything about these special qualities that they were seeking. In fact, the ad read, "The State of Maine seeks applicants for the position of Commissioner of Maine's Public Utilities Commission, commencing as soon after March 31, 1995 as possible. The Commissioner position is a six-year appointment by the Governor of Maine under Section M.R.S.A." et cetera, et cetera, "The three-member Commission is responsible for policy development and regulation of all Maine public utilities. Submit a letter of interest and resume". No mention of the criteria. This is what I learned from the hearing. Miss Hunt was instrumental, and richly deserves credit, for developing a rating system for utility customer service, which was

distributed to the public in Connecticut. She assisted in the creation of a fully competitive telecommunications market. She believes that rate relief should be available to entities who have the option of leaving Maine, and those who do not have the option should pay the rates as a price for being here. As someone who believes that utility problems would be solved by economic development, I wholeheartedly agree with, she testified that she is a "purist" as it relates to the components that make up rates. She stated that removing hidden costs was within her philosophy, yet later testified that burying some cost was important, if for social or other reasons. She acknowledged her lack of private sector work experience, her lack of understanding of Maine people, our economy and our geography was something that she needed, and would spend time on.

While I think these weaknesses are reason for pause, they, at least to me, are not reasons to deny confirmation. But, when coupled with the fact that there was a not a well articulated position on such critical matters as stranded investments, retail wheeling, and externalities, to name but a few, it did cause me reason to pause. She volunteered that her technical ability is weak and has very little expertise in electric utility matters. She was not familiar with and had no opinion of the issues surrounding the non-utility generators, or the issues surrounding nuclear decommissioning costs, and, in fact, suggested that there may not be a nuclear decommissioning in Maine. Similar concerns, on my part at least, were raised around the issues regarding municipal electric districts and the regulation of ferry services and water districts. I stated at the beginning, I view this PUC position as one of the most important positions in determining our economic future. We are about to vote on someone who possesses integrity, maturity, and intelligence; and that is as it should be; but if we want to give someone like this nominee a chance to determine our future, then I stand before you today to speak up in support of a Maine woman who is in possession of these admirable characteristics, and also has the local knowledge of our citizens, our economy, and our geographical uniqueness.

Imagine, if you will, the reaction from the State of Connecticut to someone from Frenchville, or Farmington, or Freeport, coming before them to be put in the position of guiding them into the twenty-first century. I think they would have the same reaction that I have. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Carpenter.

Senator CARPENTER: Thank you, Mr. President, Women and Men of the Maine Senate. I hope you are all from the State of Maine. I'm not. This confirmation hearing, I want to put it in perspective a little bit, from some other confirmation hearings. For instance, in State and Local I worked very hard to extend that hearing to half an hour. This hearing I worked hard to keep it under eight hours, and I didn't, but it was close. It's an intense hearing. It was, obviously, a very long hearing. My good friend, Senator Harriman from Cumberland, and I agreed on many, many things leading up to the hearing. The process of the Governor and his staff, which we didn't feel was handled correctly. The process of telling me, and others, in advance, before announcing it in the newspaper, who would be his nomination. But I consider myself a semi-fair person

and I got over the hurt that I was ignored on that and asked for more information and more meetings. My meetings with the Governor started in February, talking to him about quite possibly the most important nomination he would have in his four-year cycle. He agreed and he did another thing that I know isn't done all of the time. He formed a committee to help him search the country, and the committee to help him search the country, and the State of Maine, for many qualified candidates. Other governors just appoint a person that is a good friend, somebody they have known for years, somebody they have served with. They appoint them as Commissioner of the PUC. They don't always get confirmed, as I know, spending eight years in the Utilities and Energy Committee. I think I did go into the hearing with a completely open mind. I agree that the resume wasn't overpowering, and I did find out that Tom Welsh picked resumes from anybody find out that Tom Welsh picked resumes from anybody that had service in other PUC's. That's where the interview came from. In speaking with members of this Committee about the interview process, I am very satisfied that they picked whoever they thought was certainly the best person for this job.

In the hearings we had, I believe it was six people who travelled from Connecticut. Their equivalent of the PUC came up to testify in her favor. A cable company came to testify in her favor, even though she had opposed a rate result; and the same for telecommunications, I think it is Southern New England Telephone. I was impressed with the people who came to support her. That's a very political position down there, much more so than it is here. When one governor is out, you are out. They came and supported her. We didn't get any negative testimony at all, not one bit. Not one person came and said she can't do it. I didn't get letters. I got letters that said we were right to do a complete questioning of her, in that it appeared that she was very young and very inexperienced. A lot of people dwelled on her inexperience in the electric utility rate setting cases. That bothered me, too. That was probably the number one thing, for a period of time, that bothered me. I was sitting in the Committee listening to people question her about her experience in electrical matters; and I just said to myself, for her to give an opinion on a lot of these items wouldn't really be correct. She is going to go on to a PUC Commission that will hear rates and give their qualified opinion in the rate setting procedure, not just without a Committee and on her

own. I think that was probably a wise move.

The other move that wasn't intentional, I know, on her part, she doesn't have any real experience in the electrical industry. At first I thought how horrible that was; but then I thought where we are right now, and who set the priorities. It was back in the 1980's when we did have a bunch of so-called electrical experts running the PUC, and it doesn't look too great right now. I really hope that you will vote to sustain the Committee's eleven to two vote. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Cleveland.

Senator CLEVELAND: Thank you, Mr. President, Men and Women of the Senate. If you would bear with me for a few minutes, as a member of the Utilities Committee, one of the longer serving members, I would like to share a few of my thoughts with you, as well; because this appointment is so critical; and because I think the Governor has nominated an outstanding individual who will serve this State very well. First of all, I would like to commend Senator Carpenter, and the House Chair, for running an excellent nomination process. It was very extensive. It went from 9 o'clock in the morning until after 6 o'clock in the evening. It was very thorough and in depth. To my knowledge, not one member of that Committee entered that room with a commitment pre-made that they were supporting that nominee, but with the intention of looking at the qualifications and asking the hard questions, and coming to those decisions that would indicate whether she deserved our confirmation.

Let me give you an example of that I think some of the characteristics are for us to look for, and what I believe the Committee looked at. One is the nominee ought to have judicial temperament. This is a quasi-judicial position, and they ought to have that ability to be fair. They need to be highly intelligent. They need some knowledge and background of regulatory issues. They need to appreciate the economic consequences of both business and consumers. They need to be a mature individual with sound judgement, and they need to be an independent thinker. They also need to understand the appropriate role of the Legislature to set policy. I think you will see, in a moment, that she met everyone of those tests. As we try to judge it, who best to talk about Heather Hunt than people who have worked with her for years and who know her intimately and who have worked with her under very grueling and difficult situations and can judge her actions in a crisis and in the heat of an event. Again, as Senator Carpenter has indicated, scores of individuals came forward to support her. Some of those included Mr. Fitzgerald of the Bath Iron Works, Mrs. Smith who is the Chairman of the Public Utilities Commission, Mr. Benedict who is a member of the Public Utilities Commission in Connecticut, Owen Wells who is a distinguished attorney and who was on the selection committee chosen by the Governor and who is a very careful and prudent individual, Michael Kenney who is a former Commissioner of the PUC. I might mention to you, to a person, those Commissioners came to us and said when she was appointed to the Connecticut PUC, we had grave concerns about her abilities. We have none now. She has exceeded all of our expectations. We have had representatives from the cable industry in Connecticut, including a southern Connecticut telephone company, and the Chief Legal Counsel for the Department of Public Utilities in Connecticut. Let me share with you just a few of the things they Let me share with you just a few of the things they said. These were reiterated speaker after speaker. She is extremely bright and a very quick study. "She is the hardest working clerk that I have ever had." That was from Thomas Fahey, a principal in Leary and Fahey, where she clerked. "Rarely have I met anyone with the aptitude and the skills exhibited for this Commission." "Her character and integrity are absolutely unimpeachable." "Her work ethic is nothing short of unbalievable." "You are lucky to be nothing short of unbelievable." "You are lucky to be getting her as a Commissioner. You have scored a real coup." Here is what one of the representatives of the New England Cable Television Association said about her. He was there to testify on her behalf. He did not appreciate her ruling, because it did not go the way they liked it, but she thought it was fair. Here is what he said about her. His organization brought up some highly paid Washington

D.C. lawyers, expecting to bowl her over because she was chairing the committee who was setting the regulations and rules. "Heather Hunt single-handedly kicked the daylights out of the entire bunch of D.C. lawyers." I think, as you can see from some of these quotes, that what you find is that she is an independent person, highly intelligent, an individual who is fair, who does not pre-judge an issue but looks at the facts of the case before they come there. She has a real appreciation for the impact of her decisions, is mature in her judgements and determined to go to the extra length to find out the facts and do her homework before she makes a decision and will stand up to anybody when she thinks she is right. She has done so when she was on the Commission there and that was testified to by the Commissioners who came up and who later said that she was right and they were wrong.

I think one of the best ways to judge individuals, though, is not to look at individual cases and individual circumstances, because they change and we don't know in the next six years what they all will be. You want to look at the meddle of an individual's character. How do they make judgements? I asked her about herself and asked her to describe to me her experience. I found it extremely moving when she said to us that as a young teenager, the youngest of four children in her family, her father died very unexpectedly, leaving a widow, who was primarily a homemaker, to raise and care and provide for those four daughters. It was not an easy time in that family's life. But, as a very young teenager, she knew that she had to stand up, she had to meet the test, be disciplined, work hard, be contributive, be mature, and make tough decisions. She did that. She worked unbelievably hard in high school and college, did an outstanding job in law school, and was an outstanding performer for the Governor's office in Connecticut. Those are the kinds of traits of individuals who had the test put to them at a young age, who know what it takes to make tough interventive decisions and are mature enough to stand up on their own with independence. That's the kind of people we need. I have no doubt that she will meet all of the qualifications; and in my opinion, not only do I think she will be a good Commissioner, I think she has the potential to be a star in the State of Maine. I think we are going to be proud of the job she does. I hope you will support her nomination. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Benoit.

Senator BENOIT: Thank you, Mr. President. May it please the Senate. The good Senator from Cumberland, Senator Harriman, made a correct assessment a moment ago when he said that this Commission position for the Public Utilities Commission is as important, if not more so, than the position of a judge. Those were hard words for me to listen to and accept, but he is right. As a judge for sixteen years, with mainly two parties before the court, and deciding for one side, I was 50% of the time right. On the PUC, the Commissioners must be right more than 50% of the time in the work that they do. I will not be able to vote to confirm the nomination for several reasons that trouble me. This is a hard thing for me to do, to stand here and talk about these things; but when I feel that the Governor is right, I support him. When I feel he is wrong, I feel it is our duty to say so. I am troubled by the

amount of experience that the nominee possesses. Twenty-one months in Connecticut on the Commission. You have to ask yourself, has she gotten her feet wet, really, in this kind of work? I understand that the cases that she has worked on mainly have been cable cases in Connecticut. That is a jurisdiction that I believe our Commission does not have. I am really troubled by her resume. I want to share this with you, a particular in her resume, where she indicates, as far as her past experience goes, that from September of 1991 to October of 1993 she held the position of Deputy Legal Counsel. I'm troubled by that because part of that time she was still a law student, as well as during part of that time she had yet to pass the Connecticut, or any other state, bar exam. She tells us she held the position of Deputy Legal Counsel, words of art, if you will.

In a letter to the Committee, written by Mr. Halloran, in the third paragraph of his letter, he writes something that bothers me. It's kind of self-serving. He writes, "You may be sure that Miss Hunt officially functioned as the Deputy Legal Counsel." Then, contrary to that, is another writing from the Connecticut Department of Administrative Services, the Bureau there in the Department of Employee Relations. They write, "Our records do not reflect any reference to a title of Deputy Legal Counsel." So, Mr. Halloran says she had an official function and position; but this bureau, charged with giving titles to positions, does not record such a title. Her real title is as follows, according to the Bureau, not Deputy Legal Counsel, but Executive Office Administrative Aide - Governor's Office. So, I am disturbed that she would give us a resume that seemingly carries a legal counsel title at a time when she was not entitled to carry that job description. Moreover, in Mr. Halloran's letter, in the last paragraph, and I think you have to read his letter with this flavor, he writes something that really bothers me. It begs the question. He says, "In other states, many states permit law students to appear in court and otherwise function as attorneys while under direct supervision of licensed practitioners." Then he writes that Connecticut doesn't recognize this particular principle. As if to say some states do recognize the principle, but here in Connecticut we don't. To me, that begs the question, why mention it? It's not applicable. It is, to me, a self-serving statement given in her behalf. So, on the basis of experience, and on the basis of these other things, her resume and some of these other things that I have been reading, I am wondering if we have the best person for the people of the State that we can get. You have to understand that I am not opposed to people from away coming to Maine and working in the Executive Branch. Joseph Lehman came here from Pennsylvania as Commissioner of Corrections, a leading authority in the country, a good man. He will do a good job. He is doing a good job. Commissioner Concannon came to us from Oregon. He had prior contacts in Maine but we brought him back home from Oregon to head up the Department of Human Services. We want the best people we can get, whether they are in Maine or whether they are from away. I'm just asking myself, what is it about this nominee that tells me this is the best person that we can get, given the whole picture of resume, statements in her behalf by Mr. Halloran and so forth. I would respectfully say to the Governor, by reason of my vote today, please go

back to the drawing board and see if you can't find a nominee that has the experience for our people, a person who will do the best job. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Lord.

Senator LORD: Thank you, Mr. President, my Learned Colleagues. When I first read in the paper about this nominee, I was a little bit disturbed. thought that she was kind of young, maybe she didn't have the experience. But, when I found out that out of a hundred and eighty odd, a select committee of technical people, business people in the State of Maine, picked her as one of the top three; and they must have given them all a gosh darn good going over to see what their qualifications were; and she came out as one of the top three. I met her a while back; and when I took her hand, she shook my hand like she meant business. I shook it again today and she meant business. When I shake a hand with somebody and it isn't like a dishrag or something, they mean business. I think this young lady means business and I am going to vote for her. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Cleveland.

Senator CLEVELAND: Thank you, Mr. President. I would like to take just a few moments to make it quite clear, because there have been some allegations raised in regards to her resume and whether it speaks correctly to her experiences and training. I want to assure you that I have no reservations that it does and that she has represented her experience exactly as what it has been. I think the question is two-fold. Number one, did she hold the position of Deputy Counsel that she said that she did, for the period that she did? Secondly, was she entitled to hold that position? In response to the first question, Mr. Halloran, which she worked for for the entire time, who was Counsel for the Governor, says in his letter, unequivocally, that he recommended her and that the Governor appointed her to that position and that was the title of the position, Deputy Counsel. In general categories on the personnel area, they have broad categories in which they put individuals, not each individual title. It is not unusual to expect that she may have been in a broader category, defined under the Executive Branch, as opposed to her specific title. There is no question about the fact that she held that. We also have a letter from Michael Blaney, who is a counsel lawyer in Connecticut, of which an opinion regarding this issue was asked of him, to once again make absolutely clear that there was no question about any violation of law, or the practice within, in Connecticut. Let me just briefly summarize his opinion. Number one, and this is referring to Heather Hunt, she did nothing that any third-year law student could not have done in any law firm, in participating as a Deputy Counsel. Two, her work was totally supervised by a member of the bar, her boss, Mr. Halloran. Three, the job title was given to you by the Governor and his counsel for the purpose of designating your function in the office, not for the purpose of deceiving anyone. She never did. She was straightforward to us about what her education was, where she was in her education process when she got the title, when she passed the bar, and what she did. There was no attempt, whatsoever, to deceive anyone. Fourth, she didn't practice law under any recognized definition of that term until after she passed the bar. Her resume was completely accurate Further, Mr. Halloran, who she worked for from September of 1991 until 1993 said of her, "She demonstrated the personal maturity and technical skills on a par with far more senior members of this staff. There was never any questions about her competence or ability." They were always very pleased about her work and her recommendations. So, on the first point, clearly she had that title. It was given to her by the Governor and recommended to her by the person that she worked for. Secondly, according to the laws of Connecticut and the opinions of the counsel there, it was appropriate for her to function in the role that she did and to assist in the way that she was asked to assist in those areas, and never represented herself as having completed law school or passed the bar until those activities had occurred. She never misrepresented that to this Committee and we asked her clearly about those points. Thank you.

THE PRESIDENT: The Chair recognizes the Senator

from Oxford, Senator Hanley.
Senator HANLEY: Thank you, Mr. President. One of the frailties of our legislative process is that we can't sit in the Committee room to hear every bill, to hear all of the input from the public, from the various State employees, members of the administration. Oftentimes we have to rely on the recommendations we have from our fellow colleagues. Usually the process works fairly well. Witness the last three hours, all of the confirmations this Senate has reviewed. But, there are times when not all members of a Committee agree, and that requires those of us who didn't have the opportunity to sit through the hearing to sit through the confirmation process, to pay a little bit more attention to what is at hand and to what is at stake. In this instance I relied on the comments from my good friends and colleagues, the Senator from York, the Senator from Androscoggin, and the Senator from Cumberland. Because they were not unified, it caused me to review this nominee with a, maybe, finer process than those who have preceded her this afternoon.

Let me first state, for the members of this Senate, that I have two biases. I think the biases counter themselves. My first bias is a personal bias that I think people of tender years, people in their twenties and early thirties, can have a significant impact, be policy makers, be put in a position where you can make important decisions. There may be members of this Legislature who have maybe criticized other members of the Legislature for being of tender years and maybe not up to this task. Having been on the receiving end of that myself, I can understand Miss Hunt's concerns as far as trying to break, not a glass ceiling, but an age ceiling. For that, I have a bias towards Miss Hunt; because I have lived it; and I have lived through members of the Legislature who, for one reason or another, think that if you don't have the age experience, maybe you can't do as competent a job. My second bias, which counters that, is that I agree with Governor King when he says the greatest export in our State is our youth. I have to be concerned, as I shared with my Caucus: We have very competent, young, female attorneys here in the State that graduated from the University of Maine School of Law, as I did, who, I think, share the same attributes as the nominee. I realize it is the Governor's perogative to appoint who he will to these

positions. I feel it does send an inappropriate message when you have a limited number of very important positions here in the State, and we seek out people, and we give those positions to people who aren't Maine residents, who haven't lived in Maine and who don't have the experience of what it is like to pay the rate structures in Maine, to live in such a rural community, in a rural state, which is so dependent on our electrical rates. So, those are my biases, and I think they counter one another. I went as far as how important is this position that I should defer to the Chief Executive of our State, as I have in the past, and say, "Governor, this is your choice. You need an opportunity to show your leadership, to leave your mark on our State." Well, I compared this position with the position I hold myself here in the Maine Senate. I guess I would argue that the position of a PUC Commissioner is right up there with that of a State Senator here in Maine. Every two years the people of western Maine have had the opportunity to decide whether or not they wanted to send Dana Hanley to the Maine Legislature. If they didn't like the job I was doing, then in two years they could keep me at home. In this instance it is a six-year appointment. She will go through another administration. She will go through three legislatures. If we do not make the proper decision today, we don't have any recourse for six years. That's a concern. When you start mounting it up with the fact that, in reviewing her resume, and once again I will share my concerns, and it's not going to be new to this Chamber, those who have not engaged in private sector experience do not fully realize the ramifications of some of their decisions. And some members of this Senate, I would argue, come from a different life experience, and don't see the importance of that role and see the importance of having lived on the private sector end, where you try and meet your budget. One of the highest elements, and one of the most deleterious aspects of doing business here in the State that I have run into with businesses, is the cost of electricity. I guess I would like to see someone in that position, as the Commissioner of the PUC, who has had some private sector experience, who realizes that every decision they have is going to have an impact on, not only the residential customers, but the business customers, as well, and those will translate directly to how many people can John Doe's Widget factory employ?

I have tried to balance off the role of a new Commissioner on the PUC with the attributes that Miss Hunt has, that I have heard extolled by members of this Legislature, that I have had the opportunity to review from those who had submitted written testimony at the hearing. I do, in fact, believe that Miss Hunt is a qualified candidate, but is she the best candidate for Maine at this point in time? I would have to say that no, I don't believe so, based on all of the information that has been presented. Because of that, I will be voting against the nomination this

afternoon. Thank you.

THE PRESIDENT: The pending question before the Senate is the nomination of Heather F. Hunt for appointment as a Commissioner of the Public Utilities Commission.

Is the Senate ready for the question? The Doorkeepers will secure the Chamber. The Secretary will call the Roll.
