The SPEAKER: The Chair recognizes the Representative from Wells, Representative Carleton.

Representative CARLETON: Madam Speaker, Ladies and Gentlemen of the House. Last year Bob Marshall, an ordinary citizen of this state, had a vision. His vision was that every citizen of this state should be able to know what goes on in their State Legislature, quickly and easily. He knew, as we all knew, that it is sometimes difficult for the average citizen to know what we do up here. Bob Marshall decided to do something about this. He didn't have grant money and he didn't have support, but he decided that he would do something anyway. He started gathering all the information he could about the Legislature, its rules, its people, its bills and he started posting them on a web page on the internet. He called it the "Unofficial Legislative Home Page." He started small. He experimented and worked with his local library, a couple of legislators and the Clerk of the House to put up this information. He did it is a volunteer, a public service for the people of this state.

At the end, it took him two full days of work every week to keep it up to date. People began to notice. As the months went by, more and more people visited his web site to find out about our Legislature. As more and more people noticed, more people talked with their legislators about what a wonderful thing it was. The number of visitors to his web site reached 1,000; 5, 000; 10,000 and finally 20,000 people at the end. People started taking notice that the internet was a wonderful way to keep people informed of the public's business.

Bob Marshall continued his service to the people of Maine as a volunteer member of the first Special Legislative Committee on Information and Technology. Bob Marshall is a modest man who has done an extraordinary and valuable thing for the people of this state. It is appropriate that we take this moment to thank him for it.

When we walk through the sentiment calendar everyday, frequently we find a place where people have contributed greatly to their communities who are honored after they passed away. We have an opportunity here today. I just wanted to mention it and highlight it because John is one of those truly unique individuals who has dedicated his life to helping others.

John is suffering from a crippling and soon to be fatal disease. I thought it was especially fitting that the Maine Potato Board honored him while he was still with us. I just wanted to point out that we have an opportunity as we vote unanimously, I suspect, to pass along this resolution to honor someone while they are still with us and while they are still contributing as John is winding up his days with Lou Gehrig's disease.

An Act to Authorize the Department of Transportation to Use Design-build Contracting for Development of a New Bath-Woolwich Bridge (S.P. 220) (L.D. 679) (C. "A" S-10)

The SPEAKER: The Chair recognizes the Representative from Old Orchard Beach, Representative Kerr.

Representative KERR: Madam Speaker, Men and Women of the House. I just feel compelled to discuss this issue for a little bit. My understanding is the total cost of this project is about \$70 million. Thirty-eight million dollars will be coming from the South Portland Bridge in monies that were not expended. We are left with about \$32 million where we have to come up with some extra money. Between \$8 million and \$15 million will be coming from pots of money within the Highway Fund. You will still be short about \$20 million. There will be a bond package and I am not sure that anyone has seen it as of yet, that will have some money that will be put toward that \$20 million. By no means am I trying to stop this bill from moving forward. I just wanted to be clear that everyone in this chamber understands that this project has a cost of somewhere around \$70 million. There will be \$38 million, again, coming from the South Portland Bridge. remainder is up in the air. If, in fact, the bond package that is being proposed does not pass, those revenues that were predicated on the passage of that bond issue, will not be there to fund this project. That is all I would like to say.

Was reported by the Committee on **Engrossed Bills** as truly and strictly engrossed. This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken. 119 voted in favor of the same and 6 against and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate. Ordered sent forthwith.
