The SPEAKER: The Chair recognizes the Representative from Limestone, Representative O'Neal.

Representative O'NEAL: Madam Speaker, Men and Women of the House. I rise to ask you to vote against the pending motion and to accept the Majority Report. Both reports are exactly the same with one slight difference. The Majority Report would not allow the news media to have the E-911 tapes and we feel that that could cause problems either with abuse or stalking. There will be other people to speak for this, but I would urge you to vote against the pending motion and help us support the Majority Report.

The SPEAKER: The Chair recognizes the Representative from Wilton, Representative LaVerdiere.

Representative LAVERDIERE: Madam Speaker, Men and Women of the House. I also rise with my colleague to urge that you defeat the pending motion and adopt the Majority Report. I do so because it is important that you understand that the sole difference between the two reports is the question of whether or not the actual 911 tapes are to be released to the media or not. In all of the respects, the committee basically agreed and the two bills are, in fact, the same. I want to explain to you why the majority felt that the E-911 tapes should not be released.

Basically, the bill provides for the fact that actual transcripts of the 911 calls are going to be available to anyone that asks for those transcripts. They will not contain the name. They will not contain the telephone number or the address of the person who calls, but the actual transcripts will be available to anyone that wants one. They can have one. The minority feels that in addition to that, the actual tapes themselves should be released. We heard testimony from individuals on the committee. We heard testimony from individuals who asked that the tapes be released, basically the broadcast media because they feel that there may be something on that tape that they want to make sure is heard. They may not be sure what the transcript may pick up. In order to guard against that, the committee agreed to insert in there a provision that said if the media has any suspicion whatsoever or any fear that there may have been something left out, they have the right to petition a court and ask for the release of the tapes. The court will release the tapes for them to review. They have an actual transcript. They have the right to go to court to seek the release of the tapes. What we object to is the actual release in every situation of the tape.

We feel that way because we don't want to discourage people from using the 911 system for fear that what they say will appear on the 6 o'clock news. If people know that what they say on the 911 system will wind up on the 6 o'clock news, they may not provide all of the information. Some may not even use the system. In fact, in some communities there are ways of getting in touch with authorities without the 911 system. We want to discourage that. We want to encourage people to use the new 911 system and to feel comfortable that what they say will not necessarily be released. Someone from the Maine Broadcasting Association said to us, well, if we play the tapes, no one is going to know who that voice is. I pointed out to them that that may be true in Portland, Lewiston or Augusta, but I can guarantee you, I will pick on my good colleague Representative Joy, that if they say that someone called from Crystal and they have the actual tape, everyone in Crystal will know exactly who that was that made that phone call. We feel very strongly that the actual tapes should not be released. That is the only difference between the two bills. We urge that you defeat the pending motion and adopt the Majority Report. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Gardiner, Representative Colwell.

Representative COLWELL: Madam Speaker, Men and Women of the House. I urge you to vote for the pending motion. I am on the Minority Report and I would like to speak to my motion. The good Representative from Wilton is correct. The committee was in 99 percent agreement on this, although I don't view freedom of the press as a minor issue, the disagreement is on the point of the audio tapes being public information. Currently, they are public information. This would be a vast departure from the law as we know it now. When this bill originally came to our committee in Utilities we worked very hard to produce unanimous reports. We like to do our debating within the committee. We just had a very distinct and legitimate difference of opinion on this.

The public Safety Department originally wanted to make all this information on E-911 confidential information. I would suggest that, were the case given the recent tragic events on the Maine Turnpike, that we would not be able to tell if the system was broken. We would not know if there were any sort of cover up. We would not be well served. The public interest would not be well served. I ask you, is it in our public interest to restrict the light of day on these matters? I think that it is not. If, in fact, in the second half of this session our Maine media uses these tapes in a sensational manner. I will personally sponsor the legislation to remove these tapes from public information. Let's give the media the right to prove us wrong before we vote to limit one of our most important constitutional rights. The right to free speech. I would urge you to vote for the current motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Buxton, Representative Vedral.

Representative VEDRAL: Madam Speaker, Men and Women of the House. I am on this report on the "Ought to Pass" as amended Minority Report that allows the release of the edited audio tapes from E-911 systems. I can assure you that with either of these two reports the identity and nature of the call is confidential in regards to an individual. Information that is released has been very well discussed in our committee. I would support either of these two reports and, I urge you, if you do vote not to accept this Minority Report that you do accept the Majority Report and make sure that we do preserve the privacy of all individuals who use the E-911 system.

The SPEAKER: The Chair recognizes the Representative from Belmont, Representative Berry.

Representative BERRY: Madam Speaker, May I pose a guestion through the Chair?

The SPEAKER: The Representative may pose his question.

Representative BERRY: Madam Speaker, Men and Women of the House. The question is, did the Judiciary Committee consider E-911 during this session? I address this to any member of that committee.

Either motion on the floor of the moment actually fits that exact bill to the T. The only thing that we didn't discuss in that legislation was the audio, I believe. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Waterhouse.

Representative WATERHOUSE: Madam Speaker, Ladies and Gentlemen of the House. The Judiciary Committee did look at that bill on confidentiality in enhanced 911. We felt as though it was not the proper way to go. The big difference between the E-911 and the 911 now, from my recollection, was that with the new possibility of when you call in, you automatically will be identified of who you are and where you live as opposed to the old 911. If someone wanted to call up to report something and they didn't want to be known who they were, they could do it on the present system, but I don't think they would be able to do it on the new enhanced 911. If my memory serves me right and some other members of the Judiciary Committee can correct me if I am wrong, we defeated that bill unanimous in committee. Thank you.

Representative CHICK: Madam Speaker, Ladies and Gentlemen of the House. I rise this morning to explain that I am not opposed to hunting rabbits with dogs. However, this is a bill that would allow this practice to place during the open season on white tail deer. The white tail deer is our most sought after wildlife in Maine and has the greatest value. I am familiar with hunting with dogs. I hold a current Maine Guide's License and have for a long time. I have many friends that hunt rabbits with dogs. Their greatest concern is that the dog will depart from the rabbit and pursue the deer. This being something that many people know about, they would frequent the area during the open season on deer where people are hunting rabbits with dogs knowing that many of them will stray from their prime target and take after the deer. I would urge you to defeat this motion and go with the "Ought Not to Pass." Thank you.

The SPEAKER: The Chair recognizes the Representative from Penobscot, Representative Perkins.

Representative PERKINS: Madam Speaker, Colleagues of the House. I think there is a little confusion, even in our committee, on this. Presently in 11 counties in Maine you can hunt rabbits with dogs in November. Eleven out of the 16 counties. This bill just brings the other five into compliance so that it is the same. Hancock County being one and Washington and there are three others. This came up at a department public meeting back in my district. People asked why they couldn't hunt in November with our dogs when the rest of the state can? The department people said that has just been on the books so long, most of them didn't even know why. It probably had to do with some of the laws down our way, hunting deer, with them decades ago. This is just to bring it into compliance. Some of the people on the "Ought Not to Pass" apparently believed that this is opening up something, but already it is in the books. This just would allow the five counties that you can't hunt presently, to be in compliance with the rest of the counties. Thank you.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Wheeler.

Representative WHEELER: Madam Speaker, May I pose a question through the Chair?

The SPEAKER: The Representative may pose his question.

Representative WHEELER: Madam Speaker, Men and Women of the House. To anyone who could answer, does

anybody know the five counties that you cannot hunt with dogs during November?

The SPEAKER: The Representative from Eliot, Representative Wheeler has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Sanford, Representative Paul.

Representative PAUL: Madam Speaker, Ladies and Gentlemen of the House. The counties that would be included if this bill passes, would be Hancock, Knox, Lincoln, Sagadahoc, Waldo and Washington Counties. I hope you will support the Majority "Ought to Pass" Report.

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Dunlap.

Representative DUNLAP: Madam Speaker, Men and Women of the House. I think a point of clarification may be in order here. The statute as it was written was enacted, I did a little bit of research on this, sometime in the 1920s basically because people who hunted with hounds hunted with hounds. There was not much distinction as to what they were hunting those hounds with. They were using blue ticks, black and tans and walkers to hunt rabbits, raccoons and bears with. At the time during the rabbit season, if a rabbit stopped someone from running dogs with deer, they said they were running rabbits. The law was passed on the books at the time to do away with dog hunting during the deer season to eliminate any kind of eye winking confusion of hunting rabbits when actually they were running deer, which as been illegal as long as there has been legal deer hunting in the State of Maine. In that interim period of time it has come through Inland Fish and Wildlife, that the laws have been allowed, structures such that you could have dog hunting on rabbits on November, but somehow the coastal counties have fallen through the cracks on this, and this, as Representative Perkins earlier stated, would simply bring those counties into compliance with the rest of the state. It is not a problem running deer with dogs during hunting season in the other counties where it is legal. We felt, in the majority, that that would not necessarily erupt in some immense number of violations in the coastal communities. We felt that it was a good bill. Thank you.

Representative RICHARD of Madison moved that the House accept the Majority "Ought Not to Pass" Report.

The SPEAKER: The Chair recognizes the Representative from St. George, Representative Skoglund.

Representative SKOGLUND: Madam Speaker, Ladies and Gentlemen of the House. I hope you will not accept the "Ought Not to Pass" Report on this. I do plan to ask for a roll call on it in case you are planning to wander off while I am talking. This is a matter that Representatives from rural areas, particularly, have wanted to vote on for a long time. I am giving you this opportunity to do so. It seems time consuming, but I think if I explain the circumstances that brought this to the floor, it will save time and give you a better understanding. As I understand the law now, before a school can be closed in a town, the town has to vote to permit this school to be closed. However, a school board, in a school administrative district, can take a school apart class by class until there is hardly any school left. In St. George, we are in the same district with Thomaston and Cushing, School Administrative District 50. A few years ago the school board had hearings in each town on building a middle school in Thomaston. The people at the hearing at St. George told them 100 percent, don't even think about it. We do not want our 7th and 8th grades taken out of town. The school board said that they have studied the matter and they know more about it than you do. We will proceed with our plans for a middle school.

The town meeting then voted and passed a resolve instructing the school board, do not proceed, we do not want to send our 7th and 8th grade children out of town. To which the school board replied, more or less, you can't stop us and proceeded with plans. Eventually, this created a great dissension within the district and turned one family against the other and you know how these things proceed when you have a school problem. I am sure this happens in other towns in the state and does not need to. If it is wise for a class to be taken out of town, if it is prudent to do so, then let that town vote on that matter. You don't need to be afraid of democracy. Often, a school board in a school administrative district does not perceive things exactly in the way members in each town do. We have seen local schools close town by town and we have seen much of rural Maine become an educational and cultural wasteland. We see the stores close in rural Maine. We see the post offices go. We see the churches close. We see the schools go. We close our communities down bit by bit. Then we come up with a program called Communities for Children. What can a community do for children when there is no community left?

What this bill would do, if passed, would permit the town to say that we want to maintain a school in this community. Madam Speaker, when the vote is taken, I ask for the yeas and nays.

Representative SKOGLUND of St. George requested a roll call on the motion to accept the Majority "Ought Not to Pass" Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Madison, Representative Richard.

Representative RICHARD: Madam Speaker, Men and Women of the House. The committee sympathized with Representative Skoglund's position and I think the committee sympathizes with any small town where the school is closed. There is one little glitch in this bill. Maybe it is a big glitch and that is if at the beginning of a school year it was discovered that one class was too large and they felt they had to move that class into another building, this could not be done until a town meeting had been called and a vote of the community had been taken. It was on this basis that most of us chose "Ought Not to Pass" on this bill. As Representative Skoglund has said, in a community where the school board decides to close the school by eliminating one class at a time without accepting the input of the townspeople, that is a sad situation and we agree with him 100 percent. It is the other half of the situation that caused us to vote "Ought Not to Pass."

The SPEAKER: The Chair recognizes the Representative from Unity, Representative McElroy.

Representative MCELROY: Madam Speaker, Ladies and Gentlemen of the House. Seldom do I rise in this body, primarily because most of the arguments that are being presented, we have all heard before. However, this to me is a fairly significant issue regarding schools and the operation of schools. - 1 sympathize with the good Representative from St. George on this occasion and on others I sometimes do not. Let's make the assumption that we belong to a multi-school unit, and remember this is not about cats and dogs or churches or stores or anything of that kind. It is about school units and school houses. I happen to come from an area where one SAD has 11 towns. Those 11 towns have only six schools. The flexibility is needed on placing of students. There is no intent on any issue of student placement of closing a school. That is a separate issue by itself. We do, however, need the flexibility of moving, as the good Representative Richard has already said. We need the flexibility of moving students from one school to another so that we don't end up with a school that has room enough for 100 having 200 students and the other school has room enough for 40 having only 20 students. We need to be able to move these students back and forth between these school units. This is usually done with agreement between the parents and the school administrators. When we have an issue such as the good Representative of St. George speaks of, then that becomes more of an internal political issue and not what is best for the students of that area. Thank you very much.

The SPEAKER: A roll call has been ordered. The pending question before the House is acceptance of the Majority "Ought Not to Pass" Report. All those in favor will vote yes, those opposed will vote no.
