Representative TRIPP of Topsham moved that the House ACCEPT the Majority Ought Not to Pass Report.

The SPEAKER: The Chair recognizes the Representative from Topsham, Representative Tripp.

Representative TRIPP: Madam Speaker, Ladies and Gentlemen of the House. As you note, I am on the Minority Report. I feel that this bill should get any discussion possible on the House floor. The cost of this bill is about \$3,000 a year. It would exempt from the sales tax any goods purchased in connection with the operation of high-stakes Beano. We now have 77 separate exceptions to the sales tax code. This would make 78. I would say to vote your conscience and thank you.

The SPEAKER: The Chair recognizes the Representative from Nobleboro, Representative Spear.

Representative SPEAR: Madam Speaker, Ladies and Gentlemen of the House. You notice I am on the Minority Report. This is a bill that has been thoroughly discussed. In fact it was held over from last session. For the past 10 years, the Indians have been able to hold these Beano or Bingo games and have not had any sales tax put on the prizes that they have purchased. They have been treated as a municipality. The Maine Revenue Services has decided to treat this as a business venture, therefore, are going to put a sales tax on these goods. This is something that has not been done in the past. This is a new venture. Once again, I feel that it should be treated like a municipality. Still, where they have done this for the past 10 years without it, this is something new. It only has a fiscal note of a little over \$2,000. I think it is just taking money away from running their government. I think it is a fairness issue. I would urge you to vote against the Majority Report Ought Not to Pass. Thank you.

The SPEAKER: The Chair recognizes the Representative from Penobscot Nation, Representative Loring.

Madam Speaker, Ladies and Representative LORING: Gentlemen of the House. As a lot of you know, I came in in midstream in this. The bill was submitted, originally, by Representative Bisulca. I get fairly leery of bills that I have to do a lot of research on and especially with the Bingo taxation issue and how heavily that has been debated here in the past, the gambling issue. For the Penobscot people and the Penobscot Nation, we are not trying to do anything underhanded, reference sovereignty issues or jurisdiction issues. This bill specifically was for the purpose of not allowing the state to double tax us. We already pay the state in lieu of taxes on gambling. I think it is very unfair if we are made to pay another tax and the services that this small Bingo game provides helps with emergency services and general fund for the tribe. We are not making \$14 million a day. Basically that is my feeling. Vote your conscience.

The SPEAKER: The Chair recognizes the Representative from Waterville, Representative Gagnon.

Representative GAGNON: Madam Speaker, Men and Women of the House. This is a fairness issue. This is basically a government providing municipal services to their constituents.

They don't have the power of taxation. This is how they raise money. If it was a church, in the State of Maine, that wanted to buy Beano equipment, they are tax exempt. They are not paying taxes on that equipment because of their category. The Maine State Lottery Commission when they purchased those green things that sit on every mom-and-pop grocery store in the State of Maine, they are not paying taxes on that equipment for gambling. This truly is a fairness issue. In terms of the number of exemptions and number of exclusions for the tax code, there are quite a few, \$2,000. People keep focusing on a number of exemptions. Let's focus on the total dollars of the exemptions and what the fairness is. I would encourage you to defeat the pending motion so we can move on to the Minority Report. Thank you.

Representative TUTTLE of Sanford **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative TUTTLE: Madam Speaker, Men and Women of the House. As you have heard from the debate so far, Representative Spear, Representative Gagnon and myself, had worked with former Representative Bisulca on this issue and, therefore, the issue was held over for this time. As many of you are aware, the tribes consider Bingo revenue to be similar to non-Indian municipality property tax because almost all tribal lands are federally owned. They are non-taxable property. Bingo revenue, in effect, is their property tax. Imagine your municipality without any property tax to fund government operations. I think the impact would be the same if tribal Bingo revenue was cut off. If Bingo operations is not considered to be a governmental means to fund tribal government operations and what means do they have? I have spoken on this issue over and over the years as Chair of Legal and Veterans Affairs and as a member of the Taxation Committee. In my opinion, this bill simply clarifies that a federally recognized Indian tribe operating high-stakes Beano is operating in a governmental capacity and is not subject to taxation. Essentially all the amendment does is it replaces the exemption in the proper section of the Maine State Statute. As is mentioned here, the fiscal impact is very slight. It is \$2,800 for fiscal year 1998-99 and \$3,593 for 1999-2000. It is for that reason that I would ask you to support the Minority Report and vote against the pending motion.

The SPEAKER: A roll call has been ordered. The pending question before the House is acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.

Since I have been here, I have found out that Yogi Bear is saying, It is not over until it is over, is very true in the House of Representatives. I am presenting House Amendment "B" clarify an issue that was brought up yesterday concerning the director and deleting that name and replacing it with the person issuing the permit. Before I sit down, I just want to remind you that this is all about local control. Yesterday it was mentioned that this is local control, but is controlled by one individual and my amendment would allow the whole town or community to decide whether they want to accept this criteria as part of this issuing of burning permits. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Rowe.

Representative ROWE: Madam Speaker, Men and Women of the House. This proposed amendment does indeed correct a technical error in the bill that was raised yesterday. However, that was not the reason the amendment was opposed by, myself, and other members of the committee who spoke. The proposed amendment that is before you today significantly undermines the Committee Amendment "A," the unanimous report of the committee. Therefore, I strongly oppose it. I stand to encourage you to oppose it. With all due respect to the Representative from Bridgewater, I would move to Indefinitely Postpone House "B" to Committee Amendment "A."

Representative ROWE of Portland moved that House Amendment "B" (H-816) to Committee Amendment "A" (H-797) be INDEFINITELY POSTPONED.

Representative WATERHOUSE of Bridgton moved that the Bill and all accompanying papers be **INDEFINITELY POSTPONED**.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Waterhouse.

Representative WATERHOUSE: Madam Speaker, Men and Women of the House. The amendment that the good Representative Wheeler put on improves the bill quite a bit. I still have the same problem. I was on the phone talking with my town manager this morning about this bill. It puts additional burdens on rural small towns and it also does what the state has done in the past and really irk rural communities and, I imagine, all communities using the carrot stick approach to public policy. It does hurt rural communities who can't afford municipal trash pickup by giving preference and financial aid on their recycling efforts and waste reduction efforts to towns and municipalities that do have municipal trash pickup. To all you people who are from rural towns that don't have that availability, you might want to check with your small towns. This is not good for them. I wish you would vote on this motion. Thank you.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Rowe.

Representative ROWE: Madam Speaker, Men and Women of the House. I would request that you vote against this motion. The statement that was just made, I would ask you to look at the actual Committee Amendment. I think the Representative is speaking to the Technical and Financial Assistance Program portion of the amendment which deals with some additional language that was added. Currently it talks about, and this is the program that encourages recycling, it is grants that are given to various communities. The current language is a program of technical and financial assistance for waste reduction and recycling. It is established in the office, that is the State Planning Office to assist municipalities with managing solid waste. The director shall administer the programs in accordance with the waste management hierarchy in another section of the statute. It

then goes on to say that preference and allocating resources under this section must be given to municipalities that take advantage of regional economies of scale.

This amendment proposes to add a sentence which says, "Preference may also be given to municipalities that provided municipal trash collection service where they prohibit residential out of door burning of highly combustible trash." Again, it was the unanimous decision of the committee and the feeling after having heard the testimony that the funds that are available to encourage recycling efforts ought to be also available to provide incentives to those municipalities that convert to municipal trash collection service or that prohibit out of door burning. The idea here is to use this money to improve the environment of the State of Maine, to improve the air. It seems to me that if a community is taking a step to try to convert from burn barrels to a recycling effort to trash pickup, there ought to be some financial assistance that is provided, both in terms of technical assistance and additional monies to help move that effort forward. I don't know the argument against rural communities. This is not a rural vs. non-rural. This is basically using that money to assist those communities and providing incentives to those communities to basically reduce the air pollution in the communities. I certainly hope you vote against this current pending motion.

We have put the amendment on there, House Amendment "B," which some of you with the local control issue understand that. I surely do not understand this motion. I would strongly encourage you to vote against it. Thank you.

The SPEAKER: The Chair recognizes the Representative from Norridgewock, Representative Meres.

Representative MERES: Madam Speaker, Ladies and Gentlemen of the House. One thing I would like you to remember before you get carried away with somebody claiming that this is a problem with rural areas is to remember that, first of all, the Natural Resources Committee, has been extremely meticulous and willing to listen to the Maine Municipal Association. They have been a participant in this since its conception. They were an active participant in the session that we had this summer. They spoke during that study session on incentives themselves. They were present at the work sessions. They had a few minor concerns which we took care of in the amendment. They supported this. I think you have to realize too, that one of the debating issues that we had for fairness during the course of this whole procedure was the fact that you have many, many people who need assistance in ridding themselves of their trash. There is a lot of people who are elderly or who live away or recycling facilities are not anywhere near them. They are having a difficult time. Most of these people who need assistance live in rural areas.

It was one of the thoughts that we had during the debate was what can we do to help bring assistance to people in rural areas so that they can, especially the elderly or the low-income elderly, can get some help getting their trash and their recycling where it needs to go. I don't want you to do anything but vote your conscience. I really wanted to emphasize the fact that this wasn't a fly by night attempt to mandate something to communities. There is no mandate in this or to punish anybody, which I think is a ridiculous statement. Basically it was a well thought out attempt to do some of the things that needed to be done. To just give incentives and encouragement and an opportunity for dialog on ways to improve the system, especially for the elderly. Maine Municipal was a part of it and they did not bring this issue up once. Thank you.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Waterhouse.

Representative WATERHOUSE: Madam Speaker, Men and Women of the House. I appreciate the hard conscientious workers in the Natural Resources Committee. They are hardworking people. They have very technical bills to deal with. I cannot speak for your rural towns. I don't know if you have been speaking to your rural towns on this issue. I have been speaking to mine. As I said this morning, I talked to one of them this very morning and they said that this is not a good bill for them. That is what I am trying to tell you. I am not speaking for everybody's rural town, just mine. Madam Speaker, I ask for the yeas and nays.

Bill "An Act to Increase the Cap on the Total Acreage of Aquaculture Leases That May Be Held by One Person"

(H.P. 1434) (L.D. 1998) (C. "A" H-802)

Was reported by the Committee on Bills in the Second Reading and READ the second time.

On motion of Representative GOODWIN of Pembroke, was **SET ASIDE**.

The same Representative PRESENTED House Amendment "A" (H-808), which was READ by the Clerk.

The SPEAKER: The Chair recognizes the Representative from Pembroke, Representative Goodwin.

Representative GOODWIN: Madam Speaker, Men and Women of the House. The bill increases from 150 acres to 250 acres lease sites that would be put out by the Department of Marine Resources. All this amendment does is put a cap on the total number of acres to be leased in Cobscook Bay and to increase that number by more than double, to 1,000 acres. There is already a moratorium on all lease sites in Canada, New Brunswick that has been in place for two years because of the overcrowding of the bays in New Brunswick They have moved fish into our bay, in Cobscook Bay. They have already killed from 100,000 to 200,000 fish with disease in New Brunswick. There are no studies ongoing. No one knows what the optimum capacity of Cobscook Bay is. There are no studies. environmental assessments. We also have traditional fisheries in the bay. Lobstermen, urchinmen, scallopers, divers, recreational fishermen as well as the lease sites available to Aquaculture, there is also a perimeter of 250 feet from each and every site where no one is allowed to enter, which also increases the size.

The 1,000 acres that I proposed in here, if you add a strip of boardwalk at 204 feet wide, it would be nine and two-thirds miles long. That would be the 1,000 acres to be sufficient until we get some studies and if we find that we can optimally add in additional fisheries in that bay in years to come, we could make the change. I represent all 10 towns surrounding Cobscook Bay. We need this additional help. I thank you for your time.

The SPEAKER: The Chair recognizes the Representative from Harpswell, Representative Etnier.

Representative ETNIER: Madam Speaker, Ladies and Gentlemen of the House. I respectfully ask you to oppose this House Amendment "A" to the bill. This idea was brought back to the committee by the Representative from Pembroke, Representative Goodwin and he asked us to consider it within the committee. There was no interest within the committee. There was no interest within the committee. There was no interest in the committee in amending the bill to put this in there. In my humble opinion, I view this 1,000 acre cap, which he has referred to as being totally arbitrary and having no basis in science, let alone any basis coming from public input or the parties that would be affected by this cap.

I do believe that there probably is a case to be made for having studies in a number of the bays up and down the coast regarding their total carrying capacity for Aquaculture, but I believe those studies should be done before you put arbitrary caps on. I have a gut feeling and members of the Aquaculture industry that I have spoken to feel that 1,000 acres is probably way too high for Cobscook Bay. Probably 600 or 700 acres is more likely the amount of acreage they can sustain within Cobscook Bay. There is no desire on the part of the Aquaculture industry to make the water quality within Cobscook Bay unhealthy and a bad place to raise fish by having too many acres given to their industry. It would be detrimental to the health of their industry. I would therefore urge you to oppose this. I don't wish to debate the bill at this point. I am only going to be debating the House Amendment. I would ask you to oppose the House Amendment. Thank you.

The SPEAKER: The Chair recognizes the Representative from Boothbay, Representative Honey.

Representative HONEY: Madam Speaker, Colleagues of the House. First of all, I would like to address some of the good Representative from Pembroke's assertions he made. The State of Maine, in concert with the federal government, has the most

rigorous biological monitoring of Aquaculture sites in the United States. This is done through a penny tax placed on salmon processing in this state. This attempt to amendment the original bill will have far reaching implications, not only in Cobscook Bay, but could slow down an already fragile emerging Aquaculture industry. Currently in Cobscook Bay, the area that is around the good Representative's district, there are 678 acres currently leased. The chances for increasing this total are extremely remote because of the IF & W Essential Habitat Regulations, i.e. the Eagle nest restrictions. You cannot place any Aquaculture facilities within the quarter mile boundary of any existing Eagle nest. Believe me, the Eagle nests are increasing every year down in that area.

Also, the DEP's water classification act does not allow Aquaculture in Class SA waters. I am sure people understand what Class SA water means. The Aquaculture industry has created 1,200 new well paying jobs in the State of Maine. Of these 900 new jobs, they are located in Washington County. The lion's share are in the good Representative from Pembroke's district and the good Representative from Machias, Representative Bagley's districts. You only have to go back at least 10 years to see how devastated Lubec and Eastport was. Aquaculture has done a lot for economics in that area. I also urge you to defeat this amendment.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Rowe.

Representative ROWE: Madam Speaker, Men and Women of the House. I know I speak for all of you when I say it was an honor to serve in this body with Representative Paul Bisulca. I served with Paul in the 117th and in the first session of the 118th. As a legislator, Paul was committed to serving the Penobscot Nation and the people of the State of Maine and the State of Maine itself. He did a superb job. The sentiment language speaks of Paul's strong and unwavering commitment to Maine's natural resource environment as well as his concern that it be preserved for future generations. I know those of us that serve on the Committee on Natural Resources saw this first hand on a daily basis. I know Paul Bisulca to be a person of great intellect and integrity. He used his words sparingly, but when he spoke, people listened. Although he did not have a vote in this chamber, he made a difference. He moved people. He had substantial influence.

As I said, I served with Paul on the Natural Resources Committee last session. My only regret was that I did not get to know Paul well earlier. I wish I had. Once I got to know him, I found him to be a tremendous person. As an aside, we share the same alma mater and we had a lot to talk about in that regard, too. Again, I know that others will speak after me about Paul. I just wanted to say, on behalf of the body, that Paul, we appreciate you service, your dedication and we wish you well in all your future endeavors. Thank you.

The SPEAKER: The Chair recognizes the Representative from Wayne, Representative McKee.

Representative MCKEE: Madam Speaker, Men and Women of the House. I, too, wish to rise and express my appreciation also for Representative Bisulca's service to this chamber and to the Natural Resources Committee. Paul was an invaluable and faithful member of our committee whose intelligence, analysis and keen observations and questions made our work a whole lot easier. I am especially grateful for his courageous effort last year to define especially and to articulate the dioxin issues. As the Penobscot's representative to the Legislature, he spent a lot of time educating us about the conditions of the Penobscot River, native fishing rights and the reproductive cycles of Eagles and the tragedy that has occurred to those birds. impressed by his wide knowledge of the environment by his eloquence, by his unflagging good humor, his humility and his great humanity. Representative Bull, who could not be here today, unfortunately, he and I had some long and wonderful conversations with Paul because we were on the same side of the issue. I am convinced today that we wouldn't be where we are with dioxin had it not been for the discussions to eliminate the use of chlorine in the way we make paper. I think that we can thank Representative Bisulca for bringing this issue to the forefront and doing it so eloquently. We have had Tribal Representatives here in this body since 1823. Until the 1980s we were the only body to seek Tribal Representatives. There was a brief hiatus in which these Representatives were only Representatives at the Legislature, but that was only for a short time. I am extremely proud to know that we have seated these Representatives so long. I do understand that there are two other states that now seat those Representatives and if I am not mistaken, I think they actually have the right to vote.

Representative Bisulca was the first Native American graduate of West Point in 1970. The first one since 1823, when a young Cree Indian graduated from West Point. You can see he is a very distinguished person in the state. We are extremely proud of him. We are delighted to have him in our midst today. I hope that you will join us in welcoming him back today. Thank you.

The SPEAKER: The Chair recognizes the Representative from Penobscot Nation, Representative Loring.

Representative LORING: Madam Speaker, Ladies and Gentlemen of the House. I am proud to recognize Paul. On behalf of the Penobscot Nation, Paul has put many hard years in as Tribal Representative. It is not easy dealing with tribal government, state government and federal government. Those things have to be juggled with and you have to be a real diplomat to be able to do that. Paul has put in some long hard hours doing that. The Penobscot Nation wishes to thank him for all of his hard work.

The SPEAKER: The Chair recognizes the Representative from Bowdoinham, Representative Shiah.

Representative SHIAH: Madam Speaker, Ladies and Gentlemen of the House. I, too, had the privilege to serve with Representative Bisulca for the last three years on the Natural Resources Committee. I just want to echo the comments of the three previous speakers. Paul not only served the Penobscot Nation most ably, but he served the people of the State of Maine. He was a tireless advocate for many difficult issues that came before the committee. I, too, was impressed by the amount of homework he did on bills, his background knowledge and I just want to say, Thank you, Paul. I wish you the best in your future plans. Thank you.

The SPEAKER: The Chair recognizes the Representative from Holden, Representative Campbell.

Representative CAMPBELL: Madam Speaker, Men and Women of the House. I was fortunate enough to have served with Representative Bisulca also. Paul has been mentioned before as very, very hardworking and always on top of all the issues. We could always count on Paul to help us with the issues of the Penobscot Valley and on behalf of the Penobscot Valley, Paul, we certainly will miss you.

The SPEAKER: The Chair recognizes the Representative from Norridgewock, Representative Meres.

Representative MERES: Madam Speaker, Ladies and Gentlemen of the House. I, too, rise to talk about the wonderful person I learned to know down here, Representative Bisulca. He came before the Natural Resource Committee before he actually took the position of Representative as an advocate. I was totally impressed by his passion and his wisdom and his knowledge. He impressed me then and my feelings about him have nothing but increased since that point. He is a kind man. He is a good family person. He is intelligent. He is probably the best that can ever be. He is the type of person we can all use as a role model and we should honor him. We are going to miss him here, but I am sure that his future is always going to be one that is going to bless us because of his caring knowledge and his good nature. Thank you.
