WHEREAS, the Family Violence Project is an independent, nonprofit organization dedicated to serving the special needs of all women, children and men who are experiencing domestic abuse; and

WHEREAS, the Family Violence Project was incorporated in 1978 and serves the communities of Kennebec and Somerset Counties, with offices located in Augusta, Winslow and Skowhegan, and is funded by local, state and federal funds, private grants, special fundraising events and donations; and

WHEREAS, The Family Violence Project provides valuable social services for advocacy and referrals privately and in the

court system, and it provides a children's program, a schoolbased program, community education, support groups, batterer's intervention, a confidential hotline and emergency shelters; and

WHEREAS, in Maine, 50% of homicides are domestic abuse related and 60,000 people are victims of domestic assault annually; 95% of all domestic abuse victims are women, and one out of 4 American women will be physically assaulted at some time in their lives. Re: Recodification of the Constitution

Dear Senate President Daggett and Speaker of the House Colwell:

It is my honor to present the 2003 recodification of the Maine Constitution.

Pursuant to the requirements of Article X, section 6 of the Maine Constitution, it is the responsibility of the Chief Justice of the Supreme Judicial Court to "arrange the Constitution, as amended, under appropriate titles and in proper articles, parts and sections,

omitting all sections, clauses and words not in force and making no other changes in the provisions or language thereof." Section 6 requires the Chief Justice to submit the recodification to the Legislature "in 1973 and every 10 years thereafter."

Along with the recodified Constitution, I have developed and enclosed notes indicating the history of changes to the Constitution and the few minor changes that have been made in this decade's recodification. Also incorporated in the notes is a listing of each article amending the Constitution along with the constitutional resolution that created it, its placement in this recodification, and its effective date.

CHANGES, 2003

Headings

Three heading changes have been made in this recodification. The first supplements the heading in Article IV, part I, section 4, to describe the contents of the entire section.

The second addresses the arrangement of Article IX, section 1, regarding oaths and subscriptions. The arrangement of sentences has been reorganized to make more sense with regard to the availability of an affirmation in place of an oath. None of the substantive language of the section has changed.

The third heading change occurs at Article IX, section 23, where a heading has been added that was not contained in the original certified amendment. The heading simply alerts the reader that the primary focus of section 23 is "State park land."

Minor Grammatical and Typographical Corrections

Eight minor grammatical corrections, and two corrections of typographical errors have been made in order to correct obvious grammatical and typographical errors, and to make the current version of the Constitution consistent with the grammatical uses of the actual language of amendments, or to correct minor oversights in the 1993 recodification. They are listed and described in the attached notes.

CHANGES CONSIDERED BUT NOT MADE, 2003

Additional consideration was given to Article II, section 1. The specific provision at issue grants the right to vote in elections for governor and state legislators to all U.S. citizens age eighteen or over who are residents in the State, "excepting persons under guardianship for reasons of mental illness." In 1997 and again in 2000, the Maine Legislature proposed a repeal of this constitutional provision. On both occasions the proposed repeal was rejected by the Maine voters in ballot questions. Maine is currently among many states that have some constitutional provision disenfranchising individuals with mental illness. The question presented regarding this recodification is whether the mental illness disenfranchisement provision is still "in force."

The provision prohibiting voting by persons under quardianship for reasons of mental illness was challenged in an action brought in Federal District Court in October 2000. Ultimately, Judge Singal of the Federal District Court held that the challenged prohibition violates the due process and equal protection clauses

(both facially and as applied), the Americans with Disabilities Act (ADA), and the Rehabilitation Act. Doe v. Rowe, 156 F. Supp. 2d 35 (D. Me. 2001). That judgment was not appealed.

Despite the federal trial court's determination that certain restrictions on voting related to people with mental illness may not be enforced, a comprehensive constitutional approach has not yet been developed. The United States Supreme Court has not addressed the constitutionality of such provisions pursuant to the United States Constitution nor has it addressed whether these provisions are consistent with the ADA. Similarly, the Supreme Judicial Court of the State of Maine has not addressed the issue in its role as the Law Court.

At this point, I have concluded that I do not have the authority to delete that provision from the Constitution. It is incumbent upon me to be cautious in eliminating components of the Maine Constitution before there is final clarity that the provision may not be enforced under any circumstances against any party. Therefore, I have concluded that the provision will remain a part of the Constitution at the point of this recodification.

NEXT STEPS

Upon receipt by the Legislature of the recodification, the Constitution requires that "the draft and arrangement, when approved by the Legislature, shall be enrolled on parchment and deposited in the office of the Secretary of State; and printed copies thereof shall be prefixed to the books containing the Revised Statutes of the State."

As always, "the Constitution, with the amendments made thereto, in accordance with the provisions thereof, shall be the supreme law of the State."

I have enclosed both the written version and an electronic version of the 2003 arrangement. It has been my honor to provide this recodification.

Senator BRYANT of Oxford moved the Senate ACCEPT the Majority OUGHT TO PASS AS AMENDED BY COMMITTEE AMENDMENT "A" (H-75) Report, in concurrence.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Hall.

Senator **HALL**: Thank you, Madame President, and members of the Senate. I rise, with some reluctance, to speak in opposition to the Majority Report today. My reluctance is twofold.

First, I absolutely respect the work that the committee has done in trying to work this issue to some kind of compromise.

My second grounds for reluctance is that, all too often, contentious issues around hunting become divisive urban versus rural divides. My sympathies are greatly with the hunting and outdoor recreation community, whose defensiveness is entirely understandable given the erosion of their rights and of hunting, fishing, and trapping in the State of Maine in recent years.

But I must speak in opposition to the Majority Ought to Pass motion and urge instead acceptance of the Minority Ought to Pass report for all of the reasons that you have already heard and read in the papers that have been circulated to you, in the editorials you've read in the state's newspapers, but chiefly and primarily for this reason, the program does not work. It does not work because the natural ecosystem of Maine is, in economic terms, a free market. We interfere in it at our peril. It does not work because when a small number of coyotes are killed under this control program, the survivors simply increase their breeding rate. There is no evidence, whatsoever, that this program has the material impact on the levels of coyotes or the levels of our deer herds. It seems to me, stripping away all the emotion behind this issue, that when a program does not work, we should peacefully bury it. For that reason, Madame President, I ask you to vote against the Majority Ought to Pass report and hope that later we will move to the Minority Ought to Pass. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland. Senator Edmonds.

Senator **EDMONDS**: Thank you, Madame President, men and women of the Senate. I first want to praise the work of the committee for bringing a better solution than what presently exists in law, regarding this issue. But I am still going to urge you to vote for the Minority Report, mostly because I'm concerned about non-target species being killed in these snares. I just think that is not the way for us to go. I appreciate the challenge of keeping the deer herd healthy. But I don't want us to continue with this particular method. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President, ladies and gentlemen of the Senate. I, too, am rising and asking that you oppose the motion on the floor and reject the Majority Ought to Pass report on this matter. I can't stand before you and say that I am a hunter or a trapper. I do very much respect those who do this, either for professional reasons or for recreation purposes. I am not opposed, in fact, to the use of snaring. But I do believe this is a program that has not worked.

While I applaud the committee, they have tried very hard to restrict this program and be responsive to much of the testimony

that they have heard. I believe it's a program that has failed. When I listen to biologists and professions, on both sides of this issue, it is clear to me that there is lots of divisiveness, albeit respectful divisiveness, around the matter of coyotes and our ability to control them, and what effect that could possibly have on our deer yards. It's my opinion, and obviously only my opinion, that these programs do not work, have not worked in other places, and will continue not to work.

I think people refer to the coyote as wile, and probably wile for very good reasons. They are a predator, and a smart one. I'm not saying they cannot be caught in snares, I'm sure that they can be. I do believe, however, that this program has failed and will continue to fail in whatever form we choose to keep it. So I would ask that you join me and other Senators in the chamber in voting against the Majority Ought to Pass report. Thank you.

The Chair ordered a Division. 19 Senators having voted in the affirmative and 12 Senators having voted in the negative, the motion by Senator BRYANT of Oxford to ACCEPT the Majority OUGHT TO PASS AS AMENDED BY COMMITTEE AMENDMENT "A" (H-75) Report, in concurrence, PREVAILED.
