**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Shorey.

Senator **SHOREY**: Thank you, Madame President, men and women of the Senate. I rise here today to speak on this bill. This is one I submitted to the committee.

First of all, I am not against land conservation. The setting aside of land for future generations is a very valuable asset to the tourism industry, the economy, and to the heritage of Maine. However, this is a case where sometimes too much of a good thing can be detrimental, with unintended consequences. The State of Maine currently has no policy on the amount of land the state should own. As a matter of fact, the State of Maine has no idea at all how much land it owns. There are vague ideas about it and percentages, but we really don't know how much land we own.

This bill, with the committee amendment, sets parameters on the amount of land the state can own and takes it off the tax rolls which will have a direct impact upon local property taxes. This is something we've heard about a lot, in my campaigning anyways, property taxes. People in my district ask me, 'why are we buying all this land in Washington County and taking it off the tax rolls, driving my taxes up higher?' I couldn't answer the question. Thus, I brought forward this bill.

Much of the land the state is looking to purchase is in the poorest counties of the state. The residents of these counties can least afford to pay the higher taxes due to the loss of taxable land. I, as well as a majority of people in the State of Maine, supported the \$50 million bond for Lands For Maine's Future to purchase land under these programs. But nowhere in that bond did it say how much land the State of Maine should purchase. I would suggest to you that \$50 million would not purchase 1/5 of the State of Maine.

What I am asking you to do is to reject this motion so we can move onto Committee Amendment "A" (S-30), where we will look

at the bill. It says that no more than 1/3 of any county can be owned by the state, nor can more than 1/5 of the entire state can be owned by the state. What it also does is take out municipal ownership as a percentage.

So what I would ask is that you vote against the pending motion so we can move on and pass Committee Amendment "A" (S-30), so we can tell the people in the State of Maine and our taxpayers that the State of Maine is not going to be the majority landowner in the state. Madame President, I request a roll call.

On motion by Senator **SHOREY** of Washington, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Bryant.

Senator **BRYANT:** Thank you, Madame President, men and women of the Senate. I would encourage you to stay with the motion that is before us, Ought Not to Pass. This bill has such arbitrary limits. The land that we are talking about has willing sellers, willing buyers. Towns have the option to participate or not to participate. I think the people of the State of Maine will let us know when they feel that they don't want any more land bought. They won't be passing any bonds. I would also state that during the public hearings there were really no people from the public to testify for this bill. I would urge you to pass the committee's recommendation of Ought Not to Pass.

**THE PRESIDENT:** The Chair recognizes the Senator from Arostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President, and members of the Senate. I approach this from an entirely different approach. I'm one of those who, a number of years ago, when industry started to sell off the state from one end to the other, and was basically losing control of some of the land used for forest production and tree protection for our mills and sources of raw materials, encouraged the previous Governor to actually buy the land. As a matter of fact, it would probably have been about 1 million acres. That, to me, would have guaranteed that this land stayed in production.

That is happening again, right now. As you may know, Yale University has just put their land up for sale. It could go to anyone. It could go to someone who decides that they have enough money to take it off the market so that it will not be used for forest production of trees for our mills.

Frankly, I'd be concerned to have this Maine law as our policy. I think that we really ought to be looking at it from the opposite direction. I agree with the concern about some, in terms of taking land out of the tax basis, but I will point out, for those communities that are affected, that if the land is taken off the tax roll the county tax goes down, the amount of money that comes in to the municipality for revenue sharing goes up, and the amount of money that comes in from school subsidies goes up. The overall tax impact is very substantially reduced. I do think that it could set a very bad policy. That is a separate issue. I think that, if a county or an area doesn't want the state to purchase, I suppose that is fine. But I'm coming at it from a totally different direction. At some point, we're going to be impacted by someone with a lot of money who decides that they are going to buy a

million acres and it will be simply locked up and will be unusable for our mills in this state.
