Prayer by Reverend Edward Hatch, Palermo Christian Church.

**REVEREND HATCH:** Before I pray this morning, I just have a couple of remarks. First of all, I want to let you know that on Thursday, the National Day of Prayer, this past week, our church was praying for you, as a group. For those who represent the people who are part of our congregation, we prayed for you by name. We prayed not only for the decisions you make, but we also understand that, as public servants, you also have other pressures in your life. It was our prayer that you folks would be able to work through all the busyness of the things you have to, in order to do the job that you need to do here as well.

This past Sunday a lady came to me and she said, 'I heard that your old man passed away.' I looked at her strangely because my father and step-father both had died quite a number of years ago, and was wondering what she was talking about. She said, 'yes, he fell off the mountain.' It occurred to me that I used to live in New Hampshire, went to school there, and we used to sometimes go by the Old Man of the Mountain in New Hampshire. So I was rather amused by what she had to say. It is very interesting, that landmark, a 40' long landmark, just came sliding down in the clouds. No one saw it fall. I guess you can buy pieces of it today on E-Bay.

A State Park Official said, 'we always thought it was the hand of God holding him up and that He let go.' Daniel Webster once said of the Old Man of the Mountain that, in the mountains of New Hampshire, God Almighty has hung out a sign to show that He makes men. I thought those were interesting comments. Several of the local people felt that the Old Man would fall some time, but they said, 'not during our lifetime.' They had used cables and epoxy to keep it up. They thought it would be around forever, as far as they were concerned, but down he came.

One of the reasons is that the Old Man of the Mountain had no foundation. It was just an outcropping of rock that was coming out from the side. There was nothing underneath him to hold him up. So he fell. The very design of the Old Man caused his demise. Our state, and our nation as well, was built on a foundation. We are endowed by our Creator with certain inalienable rights of life, liberty, and the pursuit of happiness. We are a nation of laws, which this body of people makes. If we move from our foundation, the state, as we know it, could fall because its weight would have moral support. The citizens of this state have entrusted you with great responsibility. Your decisions impact every one of us.

I was in the post office this morning. I'm not normally dressed up like I am. One of the ladies there said, 'where are you going?' I said, 'to pray for the Senate.' She said, 'make sure that you tell them to look out for the small people.' So I said to her,

'everybody under 5'5"?' She said, 'no, for all the people who don't make much money.' I said, 'well I guess I won't have them pray for the postal workers than, but maybe for the ministers and pastors.' Remember the small people. Your decisions really do impact them.

Our nation was founded on Christian principles. It is my belief that they are good, that they work, that they stand the test of time. I recommend them to you as a firm and strong foundation. Let us pray.

God, I thank You this morning for each one of the men and women who devote their time to serve the citizens of this state. Lord, the responsibilities that they have are great. The number of people who are demanding their time and attention are many. None of the decisions that they make in here will be accepted by all of the people. It is my prayer, God, that You would help them as they debate the various bills, as they talk with one another in the halls, and as they meditate on the tasks that are before them. Help them to make the decisions that will stand the test of time. We ask for Your help and bless them for their efforts. In Jesus' name. Amen.

**JOINT RESOLUTION IN MEMORY OF  
MARY "MAME" OLSSON**

WHEREAS, Mary "Mame" Olsson, of Waterville, passed away on March 23, 2003 after a short illness and will be remembered as a "heck of a dancer" and an accomplished speaker and master of ceremonies. She dedicated her life's work to veterans and veterans' causes and was always there to help the less fortunate with a helping hand; and

WHEREAS, Mame was born in East Millinocket in 1916, the daughter of Richard and Nina Canavan, and graduated from Calais Academy, where she was an outstanding basketball player. She attended Crabbe Business School in 1935. In 1935, she also married her high school sweetheart, Orville "Swede" Olsson. They were married for 53 years, until his death in 1988; and

WHEREAS, Mame was a 58-year member of Bourque-Lanigan Post 5 American Legion Auxiliary and held all the offices in that organization, as well as being the American Legion's Auxiliary Department state president in 1974-1975 and a member of numerous other veterans organizations. She was a recipient of the Elks Mother of the Year and, like her mother Nina, was honored as Waterville's Citizen of the Year; and

WHEREAS, Mame was a VAVS volunteer at Togus, with thousands of dedicated hours of volunteer work for the veterans, marching in 53 consecutive Veterans' Day and Memorial Day parades until illness forced her to ride in the last 5 parades for each organization. She was the Democratic Party city chairwoman for Waterville during the 1950s and worked and volunteered for numerous community charities; and

WHEREAS, while she personified the ideal of volunteerism, Mame also worked for years in such positions as waitress in area restaurants, surgical technician at Thayer Hospital for many years, and concession stand manager for Reid State Park with her husband. She also owned Mame Olsson Luncheonette with her son from 1991-1997; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-first Legislature now assembled in the First Regular Session, on behalf of the people of the State of Maine, take this opportunity to recognize and honor the life of a Maine woman

who exemplified the best of the Maine spirit of volunteerism and who cheerfully dedicated her energies to raise a family and to assist and help others, most notably the veterans of the State of Maine who served this land; and be it further
