**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President. I rise on this bill, as I did on the previous one which was similar, because I believe the voters of Maine will be given an opportunity in November to decide whether or not they want to gamble further.

I think many of us in this body have forgotten that there was a public referendum on this issue a number of years ago in this state. We would be reversing the voters' decision without going back to referendum. I think this would be a mistake.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON:** Thank you, Madame President and members of the Senate. I would encourage you not to support the current motion to indefinitely postpone. As you can see on the report, the committee was fairly lopsided in supporting the arguments that were presented by the non-profit organizations.

I'm going to highlight some of the points of this bill. The non-profit organizations use the proceeds of these machines as one of the basic elements of their charitable giving. Most of them give much of the money that they generate for other events or items within their municipalities. The use of machines would be strictly controlled by the Bureau of Alcoholic Beverages and Lottery Operations; licensed by the State Police; and there would be a limit of only five machines per organization. The machines would have to pay out 80% of the wages to the players. The remaining income from each terminal is split between the host municipality, which would be whatever municipality they were located in; a program for compulsive gambling rehabilitation, and the licensee. The bill requires local approval. If the municipality is interested in having this operation within their municipality, they would have an opportunity to either say yes or no and share in whatever wealth there might be from that operation.

It seemed to be fairly straight forward, and something that was probably the best product that the committee could come up with, understanding that there were those people who have a real aversion to gambling. The committee is trying to look at these things without any jading in any way on the issue, one way or the other. They simply wanted to come up with the best product possible. I applaud the committee for doing that. I hope that you will support the bill at this time.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President and members of the Senate. Let me just remind you of the history, and the time when we had this in Maine. We had serious problems. We had indictments. We had money that was being laundered. We had violations throughout the state. We had the same number of personnel that we now have in the Department of Public Safety who were trying to do the job of controlling these. Nothing has changed. I'd remind you, also, that we would be violating, in my opinion, the public's trust. The voters of Maine, in overwhelming numbers, rejected these machines by referendum.

Senator **PENDLETON**: Thank you, Madame President, men and women of the Senate. Yesterday there was a special sentiment that came through on a supplement and I missed it. There was something I just wanted to share with you about this person.

Her name was Private First Class Lori Ann Piestewa. She was one of the first Native American women to be killed in our most recent military action. I just wanted to share this with you.

She was honored during a memorial service at the Women in Military Service at Arlington Cemetery this past Memorial Day. Pentagon officials, for the first time, publicly stated that she fought back. 'She drew her weapon and she fought. It was with courage and honor,' stated Shirley Martinez, Deputy Secretary of the Air Force. A Congressman from Arizona said, 'She fought tooth and nail along side a Sergeant to give other soldiers time to climb out. Her last stand was fighting with all her might, defending her own people. She fought with courage and valor.'

She was the first Hopi woman and Native American woman to die in combat in defense of the United States. She was a daughter. She was a sister, a mother, and a friend. She had a mountain and a highway named after her in area and was honored by 21 tribes who paid homage to her.

After the ceremonies, the songs, the poems, and the gifts, there is an empty space that will always be felt by her family, and especially by her children. Lori's son, Brandon, turned five years old on Memorial Day. Rose petals were ceremoniously placed in the reflection pool by the Woman's Memorial by her father, Terry, while her mother, Priscilla, stood by with her brothers, Adam and Wayland, and her three year old daughter, Carla.

Freedom is not free. The price is paid not only by the dead, but by those who must live without their loved ones. The empty space may never be filled.

According to Hopi legend, if a person had a good heart, when he or she died, their spirit would return to the earth in the form of moisture. Perhaps this is because it is so treasured in that dry and arid climate in which she lived. Lori was known to have a good heart and to love life, people, and above all, her family and friends. On the day the Piestewa family was notified of her death,

an unusual event occurred in her hometown of Tuba City. Moisture fell back to the earth in the pure white form of snow. Thank you.
