**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Kennebec, Senator Treat.

Senator TREAT: Thank you, Madame President, men and women of the Senate. It is a great honor and a privilege to be able to present this Joint Order for your consideration this morning. Jackie Calcagni is my constituent and it has been a pleasure for me to be her Senator here in the Maine Legislature. I just need to add my words as well to Jackie and for Jackie because, obviously, during my 20 years as a presiding officer in the other body, she was the person that I dealt with the most over all kinds of issues. # JOINT RESOLUTION MEMORIALIZING THE CONGRESS OF THE UNITED STATES TO SUPPORT THE FARM-TO-CAFETERIA PROJECTS ACT

WE, your Memorialists, the Members of the One Hundred and Twenty-first Legislature of the State of Maine now assembled in the Second Special Session, most respectfully present and petition the Congress of the United States as follows:

WHEREAS, in the past 30 years childhood obesity rates in the United States have doubled in our children and tripled in our adolescents due to poor eating habits, and obesity can contribute to increased likelihood of developing diabetes, high blood pressure, high blood cholesterol and clogging of the arteries; and

WHEREAS, school cafeterias serve millions of children breakfast, snacks and lunch every day and struggle to maintain services in light of diminished budgets at the local, state and federal levels; and

WHEREAS, in May of 2003, the Economic Research Service of the United States Department of Agriculture released an evaluation of the Fruit and Vegetable Pilot Program, which, according to the report, worked to change immediately children's fruit and vegetable consumption, improve children's health, create a healthier school environment and supply a positive model for children's diets; and

WHEREAS, agriculture sustains rural communities, protects open space, creates scenic vistas and protects water recharge areas; and

WHEREAS, the northeastern states have a traditional system of small and midsized producers of agricultural products located close to the towns, villages and urban centers where the majority of the 58 million consumers reside; and

WHEREAS, programs that link local farms to school cafeterias are reconnecting urban America with local agriculture in every state where they operate and providing a unique opportunity to make local agriculture relevant to the majority of the American population that now resides in urban and suburban areas; and

WHEREAS, the United States Congress is currently considering the Farm-to-Cafeteria Projects Act; and

WHEREAS, passage of the Farm-to-Cafeteria Projects Act would provide \$10,000,000 annually for grants of up to \$100,000 to school districts and nonprofit organizations to create farm-to-

cafeteria projects and overcome the initial challenges schools face in purchasing locally grown food; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge passage of the Farm-to-Cafeteria Projects Act and any other legislation that will accomplish these goals: to assist schools in purchasing locally grown food, to provide more healthy and fresh foods for schoolchildren, to educate children and their families about the foods that are grown in their own communities and to expand market opportunities for local farms, ensuring that regional agriculture continues to be viable and available to provide a safe, secure food supply to all consumers; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the President of the United States Senate, the Speaker of the United States House of Representatives, the Secretary of the United States Department Agriculture and the Northeast States Association for Agricultural Stewardship and to each Member of the Maine Congressional Delegation.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Waldo, Senator Weston.

Senator WESTON: Thank you, Madame President, men and women of the Senate. I'm going to ask you to connect the dots with me. I'm going to try to do that myself, and if you would follow along, perhaps we can make this trip together.

Let me tell you what this bill requires. It requires that drug manufacturers doing business in this state report and certify to the Department of Human Services what the actual average wholesale price, wholesale acquisition cost, average manufacturer price, and the best price as defined by federal law for each of their drugs. That is what it requires. Let me tell you what is already being done. All of the information I've just read is already required and received by the federal government from those companies and is already available to the State of Maine under some confidentiality requirements.

What will this bill require from the State of Maine? It's going to require a health planner position at the cost of \$69,437. This is where the bill gets to be really creative. We don't have that money. We should really stop and weigh this. How important is this? Is this a priority? Let me tell you that the Department of Human Services testified neither for nor against this. In fact, what they said was that this will cost money and may not be helpful. This bill proceeds through this process anyways. Let me ask you this, if we don't have the money, how creative can we be getting it? This is what the bill does in that manner. I'm going to quote from someone from the Attorney General's Office who spoke before our committee. They said, 'If an opportunity presents itself, we will sue a pharmaceutical company, and if we get an award, we will take that award and we will fund this planner, who will then mandate that all of these companies now send this information not only to the federal government but also to the State of Maine.' Remember this information is already available to us. We're going to ask for another stream to be directed directly to the State of Maine.

We have an Attorney General whose eagle eye is looking for someone to sue in order to fund a position in Maine for \$69,000. Once we get that information, the department says it may not be useful. That's because of confidentiality requirements. You cannot take the information about the cost of a drug from one company and use it to negotiate with another.

Why are we doing this? That's where my dots end. I don't have an answer. This information is available. This bill is unnecessary. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Sagadahoc, Senator Mayo.

Senator MAYO: Thank you, Madame President, ladies and gentlemen of the Senate. As a co-sponsor of this particular piece of legislation, I feel it necessary to speak on it. I'd like to compliment the good Senator from Waldo, Senator Weston, on her remarks, which I find quite interesting. I would correct one item that she mentioned. In the original bill, she was 100% correct. In the amended version, which is Committee Amendment "A" (S-496), it restricts application of the bill to manufacturers of prescription drugs dispensed in the state under a health program directed or administered by the state. It is not a blanket in regard to dealing with the drug companies.

I feel a little awkward listening to the fact that our Attorney General is going to immediately jump to sue some drug company so this bill can be implemented. My dealings with the current Attorney General, both in his current position and in his former position in the other body, would lead me to believe that this situation is not necessarily going to happen. We have recently, within the year, received a settlement of \$2.5 million from a drug company for acts that were found illegal. They settled for that amount. I think is the type of thing that is going to happen. I don't think somebody is going to go looking for something under the bed of a drug company and immediately file a lawsuit.

The last thing I would like to say is that, as this bill has been approaching us, the word went out that one of the drug store companies in the state was not supportive of L.D. 1890. Today

the lobbyist for that particular company indicated that this was not the case and the Rite Aide was supportive of L.D. 1890. With that, I would strongly urge acceptance of the majority Ought to Pass report. Thank you.

**THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Cumberland, Senator Brennan.

Senator **BRENNAN**: Thank you, Madame President, men and women of the Senate. I'd also like to connect the dots. I would like to connect the dots in a way to give a complete and full picture, and hopefully a much more positive picture, than the last attempt to complete the dots.

First, drug manufacturers are required under MaineCare in order to participate in MaineCare to provide the lowest price to the state. The lowest price. Unfortunately, what we have found in the last several years, is this has not been the case. The manufacturers and pharmaceutical companies have, in fact, not done that. As a result of that, the state has claimed between \$2.5 and \$3 million back from these companies through the Attorney General's Office through suits. Even though there is a federal requirement of providing information and the best price, we haven't always received that and have had to use legal means in order to get that money to the state.

What this bill does is simply say that the information that will be provided to the state will be certified and will be accurate from that company. They will put their stamp of approval and say what they give us is accurate. I don't think that is overly burdensome. I don't think that is going to be too terribly difficult for them to achieve that particular measure. In fact, it will give the state information that it does not currently receive. That information will allow us to negotiate a better, and or, best price.

Clearly, during the public hearing and during the work session, issues were raised about confidentiality and proprietary rights. We wanted to make sure that there wasn't an opportunity for people to share this information in a way that would create an unfair advantage to competitors. What we did in the bill, in the amended version, was put in a confidentiality section that mirrors federal law so that we would protect that information. While that issue was raised, the committee was very cognizance of that issue and acted very directly to address this issue.

The good Senator from Waldo, Senator Weston, is absolutely right. This bill doesn't have a fiscal note. The reason it doesn't have a fiscal note is because the committee felt strongly about this bill. We were afraid that if it went to the Appropriations Table it may not get funded because there are a number of other worthy things that are on the table. We then saw there was an opportunity to fund the position within the Department of Human Services through the proceeds or through the revenues from the settlements that we from the suits that we have with pharmaceutical companies. What the bill simply says is the position in the Department of Human Service that will be necessary to go through all of this information and make some meaningful sense out of it will be funded out of proceeds or revenues from the settlements that the Attorney General gains in suits that we have already had up to this particular point. It in no way implies, directs, or indicates that the Attorney General is now going to go out and sue somebody in an attempt to get revenues to fund this position. That is just simply not true.

Lastly, and maybe even the most important point of all, in answer to the question of why we are doing this. The reason we are doing this is because we had the overwhelming majority of information and testimony on this bill that indicated that it would save money for the state. This will be an opportunity for us to save money and to reduce the cost of prescription drugs. So while we might want to talk about how it is going to be funded, we might want to talk about confidentiality, we might want to talk about 'burdens it will place on pharmaceutical companies', the bottom line is that by enacting this bill and allowing it to go forward the state will save money and citizens in the State of Maine will be paying less for their prescription drugs. That is the reason, and the most compelling reason, why people should vote for enactment. Thank you.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Waldo, Senator Weston.

Senator WESTON: Thank you, Madame President, men and women of the Senate. Two more dots to connect. Under federal law, any manufacturer who provides false or inaccurate information to any state is going to be fined, is going to be held in contempt of the law already. This is a quote from a representative from our Attorney General's Office in our committee hearing. When asked about these law suits and when asked about settlements and awards, he said, 'If an opportunity presents itself we will proceed and sue and hopefully get an award.' With that award we're not just simply funding a position, an entire regulatory process is being put in law, on hold, until we get a settlement. I don't know if we've ever, at least in the years I've been here, passed any bill with kind of financial process. All of these companies are waiting in the wings for a settlement to be made, funding to be had, and then they are going to be required to proceed and give this information within the last guarter of that calendar year. I don't think that is how Maine intends to do business. Again, this information is available to us. If there is savings to be made, there should be a positive fiscal note and there is none. Thank you.
